SECTION 2. Arkansas Code § 27-15-2503 is amended to read as follows: 27-15-2503. Prerequisites to issuance. (a) An applicant shall be issued a Pearl Harbor survivor license plate free of charge for his or her private motor vehicle, used for personal conveyance and not for commercial purposes, upon submitting proof of eligibility and complying with the state motor vehicle laws relating to registration and licensing of motor vehicles, and payment of the regular license fee for license plates as prescribed by law plus, for the initial issuance, an additional fee of fifteen dollars (\$15.00). (b) All applications for Pearl Harbor survivor license plates must be verified by the Arkansas State Chairman of the Pearl Harbor Survivors Association of Arkansas.
