## For An Act To Be Entitled

10 AN ACT TO IMPLEMENT AMENDMENT 74 TO THE ARKANSAS  
11 CONSTITUTION; TO AMEND CERTAIN SECTIONS OF THE  
12 ARKANSAS CODE TO COMPLY WITH AMENDMENT 74; TO  
13 DECLARE AN EMERGENCY; AND FOR OTHER PURPOSES.

## Subtitle

15 AN ACT TO IMPLEMENT AMENDMENT 74 TO THE  
16 ARKANSAS CONSTITUTION; TO AMEND CERTAIN  
17 SECTIONS OF THE ARKANSAS CODE TO COMPLY  
18 WITH AMENDMENT 74; TO DECLARE AN  
19 EMERGENCY.

23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
24

25 *SECTION 1. Arkansas Code Title 26, Chapter 80 is amended to add a new*  
26 *subchapter:*

27 *26-80-301. Title.*

28 *This subchapter shall be known and may be cited as "The Amendment No.*  
29 *74 Enabling Act of 2003."*  
30

31 *26-80-302. Definitions.*

32 *As used in this Subchapter and Subchapter 1 of Chapter 80 of Title 26*  
33 *of the Arkansas Code:*

34 *(1) "Additional maintenance and operation millage" means millage levied*  
35 *by the electors of a local school district for maintenance and operation in*  
36 *excess of those required by the uniform rate of tax;*



1           (2) "Dedicated maintenance and operation millage" means millage levied  
2 by the electors of a local school district and used for those purposes  
3 explicated in § 26-80-110;

4           (3) "Debt service millage" means the total number of mills voted by the  
5 electors of a school district to be pledged as security for the retirement of  
6 bonded indebtedness;

7           (4) "Millage rate" means the millage rate listed in the most recent tax  
8 ordinance approved by the county quorum court under the authority of § 14-14-  
9 904;

10           (5) "Maintenance and operation millage" means millage levied by the  
11 electors of a local school district for the maintenance and operation of the  
12 school district;

13           (6) "Net revenues" means actual revenues from taxes due and owing after  
14 January 1, 1997, rounded to the nearest hundredth minus any commission fees  
15 authorized by law to be collected or withheld for later distribution by the  
16 county offices. No additional fees shall be charged for transmittal or  
17 redistribution of funds by any county or state office in carrying out the  
18 procedures established to comply with the requirements of Arkansas  
19 Constitution, Amendment 74; and,

20           (7) "Uniform rate of tax" means a uniform rate of ad valorem property  
21 tax of twenty-five (25) mills to be levied on the assessed value of all  
22 taxable real, personal, and utility property in the state to be used solely  
23 for maintenance and operation of the schools. In calculating compliance with  
24 the uniform rate of tax imposed by Arkansas Constitution, Article 14, § 3, as  
25 amended by Arkansas Constitution, Amendments 11, 40, and 74, only those mills  
26 voted for maintenance and operation shall be used.

27  
28           26-80-303. Establishment of compliance.

29           Compliance with the uniform rate of tax shall be established by the  
30 Department of Education in coordination with the Assessment Coordination  
31 Department.

32  
33           26-80-304. Calculation of Compliance with the Uniform Rate of Tax.

34           (a)(1) Within thirty (30) days of the effective date of this act, the  
35 Director of the Department of Education shall certify to each school district  
36 whether or not that school district is currently in compliance with the

1 uniform rate of tax.

2 (2) Compliance shall be determined by analyzing the millage rate  
3 levied for maintenance and operation millage from the most recent school  
4 election in which the ad valorem tax rate was voted upon. If the millage  
5 rate is equal to or greater than twenty-five (25) mills, then the school  
6 district shall be deemed to be in compliance with Amendment No. 74 to the  
7 Arkansas Constitution.

8 (b)(1) On or before November 1, 2003, the Director of the Department of  
9 Education shall certify to each quorum court whether or not the school  
10 districts in its jurisdiction are in compliance with the uniform rate of tax.

11 (2) The calculation of compliance under this subsection shall be  
12 the same as the calculation explicated in subsection (a)(2) of this section.

13 (c) On or before November 1, 2004, and each year thereafter, the  
14 Department of Education, in conjunction with the Assessment Coordination  
15 Department, shall monitor compliance with the uniform rate of tax.

16  
17 26-80-305. Interrelationship between Amendments No. 59 and No. 74.

18 Pursuant to the application of Arkansas Constitution, Amendment 74 to  
19 the rollback provisions of Arkansas Constitution, Amendment 59 for millage  
20 rates levied by the various school districts within the county, if it is  
21 determined that the adjustment or rollback of millages as provided in  
22 Arkansas Constitution, Amendment 59, will result in a tax rate for  
23 maintenance and operation of less than the uniform rate of tax, then the  
24 millage shall be rolled back only to the uniform rate of tax plus the debt  
25 service millage adjusted under Amendment 59 and no further.

26  
27 26-80-306. Penalties.

28 (a) All duties imposed by this subchapter and subchapter 1 of this  
29 chapter on all state, county, and school district officers are declared to be  
30 mandatory, and any officer who neglects, fails, or refuses to perform any  
31 such duty shall be subject to removal from office and liable on his official  
32 bond for such neglect, failure, or refusal.

33 (b)(1) Upon the refusal or failure of any state officer to perform any  
34 duty imposed upon him under the provisions of this subchapter, subchapter 1  
35 of this chapter, and Amendment 74 of the Arkansas Constitution, any citizen  
36 of the state may, and the Attorney General of the State of Arkansas shall,

1 institute in the proper court mandamus proceedings to compel the state  
 2 officer to perform his duties.

3 (2) Upon the refusal or failure of any county or school district  
 4 officer to perform any duty imposed upon him under the provisions of this  
 5 subchapter, subchapter 1 of this chapter, and Amendment 74 of the Arkansas  
 6 Constitution, any citizen of the county may, and the prosecuting attorney of  
 7 the district including such county shall, institute in the proper court  
 8 mandamus proceedings to compel the county officer to perform his duties.

9  
 10 SECTION 2. Arkansas Code § 6-14-114 is amended to read as follows:  
 11 6-14-114. Counting of votes.

12 When the polls of each election are closed, the election officials  
 13 shall immediately proceed to count the results, and make returns thereof to  
 14 the county clerk showing:

15 (1) The number of votes cast for each person for school district  
 16 director;

17 (2) The number of votes cast for the school tax;

18 (3) The number of votes cast against the school tax;

19 (4) The number of mills for:

20 (A) The additional mills for maintenance and operation ~~of~~

22 (B) The additional mills for maintenance and operation that have been  
 23 designated dedicated maintenance and operation mills ~~of the school district;~~

 25 ~~required and excess debt service millage in the school district; and~~

26 (D) The total millage rate levied for all purposes in the school  
 27 district in excess of the uniform rate of tax; and

28 (5) The number of votes cast for and against any other question  
 29 submitted at the election.

 31 SECTION 3. Arkansas Code § 6-20-1205 is amended to read as follows:  
 32 6-20-1205. Submission of statement prior to issuing bonds - Approval.

33 (a) When any school district board of directors desires to issue bonds  
 34 for the purposes described in § 6-20-1201, it:

35 (1) Shall furnish to the Director of the Department of Education  
 36 a statement of the amount proposed to be borrowed, the maturity of the

1 indebtedness, a financial statement of the affairs of the district, and a  
2 certificate from the county clerk showing the then-assessed valuation of the  
3 real, personal, and utility property in the district; and

4 (2) Shall not ~~advertise for the sale of~~ sell bonds until the  
5 issue is approved by the State Board of Education or by the director to be  
6 evidenced by a writing signed by the board or the director, and bearing the  
7 seal of the board.

8 (b) In addition to other reasons for disapproval of a bond issue  
9 provided under law or by regulation, neither the board nor the director shall  
10 approve the sale of bonds for the purposes described in § 6-20-1201 if that  
11 sale+

22 ~~district must reapply for approval prior to the issuance of the bonds.~~

23 ~~(d) (c)~~ The department shall not provide a local school district that  
24 issues second-lien bonds more additional base funding for which it would  
25 otherwise qualify excluding the issuance of the second-lien bonds except as  
26 authorized under § 6-20-1229.

27 ~~(e) (d)~~ The department is authorized to adopt procedural rules and  
28 regulations to enforce the provisions of this section.

~~26-26-410. Assessment Coordination Division — Form revision.~~

~~The Assessment Coordination Division of the Public Service Commission shall revise the forms found in § 26-26-401 et seq. pertaining to rollback of millage rates under Arkansas Constitution, Amendment 59, to provide for changes required to effectuate Amendment 74 to the Arkansas Constitution. The revised forms produced by the Assessment Coordination Division shall be submitted to the Arkansas Legislative Council, or any subcommittee designated by that body, for review and comment on or before August 1, 1997. Upon review~~

1 ~~by the Arkansas Legislative Council, the Arkansas Code Revision Commission~~  
2 ~~shall incorporate such revised forms into § 26-26-401 et seq.~~

11 ~~shall determine which local school districts have a local revenue per student~~

SECTION 7. Arkansas Code § 26-80-110 is amended to read as follows:

26-80-110. Dedicated maintenance and operation millage.

(a)(1) ~~In addition to other maintenance and operation millages, the~~ The board of directors of each local school district is authorized, upon approval of a majority of the qualified voters in the school district, voting in the annual school election to levy and collect a tax upon real, personal, and utility property for dedicated maintenance and operation millage for the local school district to designate some of the school district's additional maintenance and operation millage as dedicated maintenance and operation millage.

(2) The approved tax shall be assessed, levied, and collected as provided by law for other school taxes.

(3) The approved tax may be considered part of the school district's uniform rate of tax as calculated by the State Department of Education under Arkansas Constitution, Amendment 74.

(b) Any funds received from the collection of a dedicated maintenance and operations tax shall only be used for ~~the following~~ maintenance and operation purposes; approved by the majority of the qualified voters of the school district voting in the school election, and for no other purpose than those that were explicated on the ballot.

~~(1) Purchase of school buses;~~

~~(2) Purchase of furniture or equipment to support the instructional program;~~

~~(3) Purchase of computer software;~~

~~(4) Renovation or repair of existing facilities; or~~

~~(5) Repaying revolving loans for any of the purposes previously listed.~~

(c)(1) ~~Local school districts which have levied a capital outlay tax or current expenditures tax prior to the amendment of this section are authorized to continue such levies for the terms and purposes approved by the majority of voters at the time of their adoption.~~

~~(2) If a school district, at the time of the adoption of the~~



1 ~~amendment of this section, levied a capital outlay tax or current expenditure~~  
 2 ~~tax less than or equal to its additional mills for maintenance and operation,~~  
 3 ~~then that millage levied as a capital outlay tax or current expenditures tax~~  
 4 ~~shall be considered as a dedicated maintenance and operation millage.~~

5 ~~(3) If a school district, at the time of the adoption of the~~  
 6 ~~amendment of this section, levied a capital outlay tax or current expenditure~~

 3 ~~millage rate is approved by the electors of the district~~ electors of the  
 4 district approve the proposed millage rate, it shall be the rate for the  
 5 district, provided such rate complies with the uniform rate of tax.

 25 ~~each county shall transmit to the Department of Education the abstract of~~

21 ~~base of equal local effort for Arkansas public schools by establishment of a~~  
22 ~~uniform rate of ad valorem property tax of twenty-five (25) mills to be~~  
23 ~~levied on the assessed value of all taxable real, personal, and utility~~

11 SECTION 10. EMERGENCY CLAUSE. It is found and determined by the  
12 General Assembly of the State of Arkansas that the Arkansas Supreme Court has  
13 declared that the current method that the state uses to determine compliance  
14 with Amendment 74 to be unconstitutional and has instructed the General  
15 Assembly to take action before the termination of the court's stay of its  
16 mandate. It is also found that the people must be informed as early as  
17 possible the impact of the Court's ruling on the property taxes that they pay  
18 for education. Therefore, an emergency is declared to exist and this act  
19 being immediately necessary for the preservation of the public peace, health,  
20 and safety shall become effective on:

21 (1) The date of its approval by the Governor;

22 (2) If the bill is neither approved nor vetoed by the Governor,  
23 the expiration of the period of time during which the Governor may veto the  
24 bill; or

25 (3) If the bill is vetoed by the Governor and the veto is
