## For An Act To Be Entitled

9 AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL  
10 SERVICES AND OPERATING EXPENSES FOR THE ARKANSAS  
11 HOUSE OF REPRESENTATIVES WHICH SHALL BE  
12 SUPPLEMENTAL AND IN ADDITION TO THOSE FUNDS  
13 APPROPRIATED BY ACT 1 OF 2003, ACT 1025 OF 2003,  
14 AND ACT 1 OF THE SECOND EXTRAORDINARY SESSION OF  
15 2003; AND FOR OTHER PURPOSES.

## Subtitle

18 AN ACT FOR THE ARKANSAS HOUSE OF  
19 REPRESENTATIVES SUPPLEMENTAL  
20 APPROPRIATION.

24 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
25

26 SECTION 1. APPROPRIATION - SUPPLEMENTAL. There is hereby appropriated, to  
27 the Arkansas House of Representatives, to be payable from the Constitutional  
28 Officers Fund, for personal services and operating expenses of the Arkansas  
29 House of Representatives which shall be supplemental and in addition to those  
30 funds appropriated in Section 1 of Act 1 of 2003, Section 11 of Act 1025 of  
31 2003, and in Section 1 of Act 1 of the Second Extraordinary Session of 2003,  
32 for the remainder of the biennial period ending June 30, 2005, the sum of ...  
33 .....\$150,000.

35 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized  
36 by this act shall be limited to the appropriation for such agency and funds



1 made available by law for the support of such appropriations; and the  
 2 restrictions of the State Purchasing Law, the General Accounting and  
 3 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
 4 Procedures and Restrictions Act, or their successors, and other fiscal  
 5 control laws of this State, where applicable, and regulations promulgated by  
 6 the Department of Finance and Administration, as authorized by law, shall be  
 7 strictly complied with in disbursement of said funds.

8  
 9 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General Assembly  
 10 that any funds disbursed under the authority of the appropriations contained  
 11 in this act shall be in compliance with the stated reasons for which this act  
 12 was adopted, as evidenced by the Agency Requests, Executive Recommendations  
 13 and Legislative Recommendations contained in the budget manuals prepared by  
 14 the Department of Finance and Administration, letters, or summarized oral  
 15 testimony in the official minutes of the Arkansas Legislative Council or  
 16 Joint Budget Committee which relate to its passage and adoption.

 18 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General  
 19 Assembly, meeting in extraordinary session, that funds provided by the  
 20 General Assembly for the operations of the Arkansas House of Representatives  
 21 are, due to the call of the governor for a convening of an extraordinary  
 22 session, insufficient for the Arkansas House of Representatives to continue  
 23 to provide essential governmental services; that the provisions of this act  
 24 will provide the necessary monies for the Arkansas House of Representatives  
 25 to continue such services; and that a delay in the effective date of this Act  
 26 could work irreparable harm upon the proper administration and provision of  
 27 essential governmental programs. Therefore, an emergency is hereby declared  
 28 to exist and this Act being necessary for the immediate preservation of the  
 29 public peace, health and safety shall be in full force and effect from and  
 30 after the date of its passage and approval. If the bill is neither approved  
 31 nor vetoed by the Governor, it shall become effective on the expiration of  
 32 the period of time during which the Governor may veto the bill. If the bill  
 33 is vetoed by the Governor and the veto is overridden, it shall become  
 34 effective on the date the last house overrides the veto.
