7	Provided however, the Speaker of the House of Representatives and the
8	President Pro Tempore of the Senate may by joint proclamation issued at any
9	time prior to March 4, declare that it is not necessary for the Senate and
10	House of Representatives to reconvene and may adjourn the Second
11	Extraordinary Session of the Eighty-Fourth General Assembly sine die.
