## For An Act To Be Entitled

9 AN ACT TO REORGANIZE THE EXISTING PUBLIC  
10 EDUCATION SYSTEM; TO ESTABLISH THE POWERS AND  
11 DUTIES OF THE OFFICERS OF THE PUBLIC EDUCATION  
12 SYSTEM; AND FOR OTHER PURPOSES.  
13

## Subtitle

14 THE COMPREHENSIVE PUBLIC EDUCATION  
15 REORGANIZATION ACT.  
16  
17  
18

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
20

21 WHEREAS, The Arkansas Supreme Court, in the decision of Lake View  
22 School District No. 25 v. Huckabee, 351 Ark. 31 (2002) declared the now  
23 extant system of public education to be unconstitutional because it is both  
24 inequitable and inadequate; and  
25

26 WHEREAS, The Arkansas Supreme Court set forth the test for a  
27 constitutional system to be one in which the state has an "absolute duty" to  
28 provide an "equal opportunity to an adequate education"; and  
29

30 WHEREAS, The Arkansas Supreme Court defined an "equal opportunity" to  
31 include the "basic components [of] substantially equal curricula,  
32 substantially equal facilities, and substantially equal equipment for  
33 obtaining an adequate education"; and  
34

35 WHEREAS, The Arkansas Supreme Court pointed to discrepancies in teacher  
36 salaries finding that "[w]ell paid and well motivated teachers are what make



1 the education engine run”; and

2  
3 WHEREAS, The Arkansas Supreme Court recognized that the Arkansas  
4 General Assembly had “addressed what an adequate education in Arkansas would  
5 entail” through the passage of § 3 of Act 1108 of 1997 and § 1 of Act 1307 of  
6 1997; and

7  
8 WHEREAS, The General Assembly acknowledges the Acts 1108 and 1307 set  
9 forth what Arkansas’ children should be able to know and do, which is the  
10 definition of an adequate education; and,

11  
12 WHEREAS, The Arkansas Supreme Court has only given until January 1,  
13 2004, to implement a constitutional education system; and

14  
15 WHEREAS, The State of Arkansas recognizes that it has been the position  
16 of the state that any school district, regardless of size, whose students  
17 consistently exhibited exceptional performances on state, regional, or  
18 national examinations or on other related indicators of academic success  
19 would not be adversely affected by any structure of public education; and

20  
21 WHEREAS, It is the desire of the State of Arkansas to maintain as many  
22 community schools and as much community involvement in public education as  
23 possible; and

24  
25 WHEREAS, The state recognizes that there is no greater indicator of  
26 success in education than the involvement of the parents of students and the  
27 members of the community; and

28  
29 WHEREAS, Multiple studies of education and education efficiency have  
30 determined that there are better ways of delivering an education system than  
31 the one that currently exists in Arkansas; and

32  
33 WHEREAS, The state is acutely aware of financial and monetary  
34 restraints that have been placed on it by both the current state of the  
35 economy and the Constitution of the State of Arkansas; and

36

1           WHEREAS, The state has to find an efficient method to use its limited  
2 resources to create a system of public education as defined by Article 14, as  
3 amended, of the Arkansas Constitution,  
4

5 NOW THEREFORE, BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF  
6 ARKANSAS:  
7

8           SECTION 1. Legislative purpose

9           The General Assembly declares that this act is necessary to ensure the  
10 delivery of a constitutionally compliant equal opportunity for adequate  
11 educational services to the people of Arkansas in an efficient and effective  
12 manner; to provide education accountability at all levels of public school  
13 education including but not limited to student performance, teacher  
14 performance, administrative performance and overall school performance; to  
15 develop a teacher compensation structure which enables the state of Arkansas  
16 to compete both regionally and nationally in initial hiring and retention of  
17 top quality teachers; and to ensure the provision of substantially equal and  
18 adequate facilities and educational equipment and technology for all public  
19 school students.  
20

21           SECTION 2. Creation of the Office of Public School Accountability under  
22 the State Board of Education.

23           (a) In order to enhance the public's access to public school  
24 performance indicators and to better measure the dividends paid on the  
25 increasing public investment in Arkansas' schools, the General Assembly finds  
26 that an Office of Public School Accountability should be established under  
27 the direct operational control of the State Board of Education. The foremost  
28 obligation of this section shall be to administer all monitoring and  
29 compliance activities dealing with academic and fiscal accountability for  
30 each school or school district and report academic progress.

31           (b) Upon the effective date of this act, there is created an Office of  
32 Public School Accountability.

33           (c) The Office of Public School Accountability shall report directly to  
34 the State Board of Education.

35           (d) The Chairman of the State Board of Education shall name a three  
36 member Public School Accountability Oversight Panel consisting of the

1 following individuals:

2 (1) Chairman of the State Board of Education

3 (2) Two (2) members of the State Board of Education

4 (e) The Public School Accountability Oversight Panel shall select an  
5 individual to serve as the Public School Accountability Officer.

6 (1) The Public School Accountability Officer shall be classified  
7 as exempt from the provisions of the Uniform Classification and Compensation  
8 Act, Arkansas Code § 21-5-201 et seq.

9 (2) The Public School Accountability Officer, with guidance and  
10 approval from the Public School Accountability Oversight Panel, shall be  
11 responsible for hiring all employees of the Office of Public School  
12 Accountability.

13 (f) The Office of Public School Accountability shall have the following  
14 responsibilities:

15 (1) Monitor schools for compliance with state and federal  
16 regulations;

17 (2) Monitor schools for compliance with legislative acts and  
18 court ordered mandates;

19 (3) Monitor schools for compliance with all standards of learning  
20 and accreditation as established by the State Board of Education;

21 (4) Monitor schools for compliance with all rules and regulations  
22 as established by the State Board of Education;

23 (5) Coordinate the analysis, dissemination, and reporting of all  
24 criterion and norm-referenced testing information;

25 (6) Coordinate the implementation and administration of  
26 longitudinal tracking and trend data collection as established by the  
27 Arkansas State Board of General Education for the purposes of improving  
28 student and school performance, ensuring mastery of the curriculum and  
29 providing comparison between students within Arkansas and with students in  
30 other states;

31 (7) Coordinate the implementation and administration of value-  
32 added assessments as established by the State Board of Education;

33 (8) Coordinate the implementation and administration of the  
34 annual school performance reports as established by the State Board of  
35 Education;

36 (9) Administer all monitoring and compliance activities dealing

1 with academic and fiscal accountability as established by the State Board of  
2 Education;

3 (10) Administer all monitoring and compliance activities dealing  
4 with desegregation and equity issues;

5 (11) Serve as the Dispute Resolution Office for the Arkansas  
6 public school system, and

7 (12) Work with program approval and certification sections of the  
8 Arkansas Department of Education, the Arkansas Department of Higher  
9 Education, the Arkansas Department of Workforce Education and the individual  
10 colleges to provide information that will contribute to reasonable,  
11 equitable, and excellent preparation of certified personnel in the  
12 institutions, both public and private, of higher education.

13 (g) The Office of Public School Accountability, through the State Board  
14 of Education, shall make available to the Joint Interim Oversight  
15 Subcommittee on Educational Reform, the House and Senate Interim Committees  
16 on Education annual reports of school performance or compliance.

17 (h) Upon the effective date of this act, there is created the Arkansas  
18 Public Schools Accountability Advisory Council.

19 (1) The membership of the Arkansas Public Schools Accountability  
20 Advisory Council shall include:

21 (A) One (1) person designated as chairman, to be selected  
22 by the Governor, who shall be a representative of Arkansas businesses;

23 (B) One (1) person selected by the Governor, who shall be a  
24 representative of a educator's union in the state of Arkansas;

25 (C) One (1) person selected by the Governor, who shall be a  
26 parent of at least one (1) student currently enrolled in kindergarten through  
27 grade 12 (K-12) in a public school in the state of Arkansas;

28 (D) One (1) person selected by the Speaker of the Arkansas  
29 House of Representatives who shall be a representative of Higher Education;

30 (E) One (1) person appointed by the President Pro Tempore  
31 of the Arkansas Senate who shall be a representative of Arkansas businesses;

32 (F) One (1) person appointed by the Senate Committee on  
33 Education who is currently employed as a teacher in the kindergarten through  
34 grade twelve (K-12) public school system in the state of Arkansas;

35 (G) One (1) person appointed by the House Committee on  
36 Education who shall be a representative of the administration of a public

1 school in the state of Arkansas.

2 (2) The Arkansas Public Schools Accountability Advisory Council  
3 shall provide advice and consultation services for the Public Schools  
4 Accountability Officer.

5 (3) The Arkansas Public Schools Accountability Advisory Council  
6 may be convened by the Chair of the Advisory Council, by the Chair of the  
7 State Board of Education, or by the Public Schools Accountability Officer.

8 (4) Members shall not receive compensation for service on the  
9 Arkansas Public Schools Accountability Advisory Council but may receive  
10 expense reimbursement as provided in Arkansas Code 25-16-902.

11  
12 SECTION 3. Creation of the Office of Public Schools Academic Facilities  
13 under the State Board of Education.

14 (a) In order to ensure that substantially equal access to adequate  
15 educational facilities and educational equipment is provided for all public  
16 school students in Arkansas, the General Assembly finds that an Office of  
17 Public School Academic Facilities should be established under the direct  
18 operational control of the State Board of Education.

19 (b) Upon the effective date of this act, there is created an Office of  
20 Public School Academic Facilities.

21 (c) The Office of Public School Academic Facilities shall report  
22 directly to the State Board of Education.

23 (d) The Chairman of the State Board of Education shall name a three  
24 member Public School Academic Facilities Oversight Panel consisting of the  
25 following individuals:

26 (1) Chairman of the State Board of Education

27 (2) Two (2) members of the State Board of Education

28 (e)(1)The Public School Academic Facilities Oversight Panel shall  
29 select an individual to serve as the Public School Academic Facilities  
30 Officer.

31 (2) The Public School Academic Facilities Officer shall an  
32 architect, licensed by the State of Arkansas.

33 (3) The Public School Academic Facilities Officer shall be  
34 classified as exempt from the provisions of the Uniform Classification and  
35 Compensation Act, Arkansas Code § 21-5-201 et seq.

36 (4) The Public School Academic Facilities Officer, with guidance

1 and approval from the Public School Academic Facilities Oversight Panel,  
2 shall be responsible for hiring all employees of the Office of Public School  
3 Academic Facilities.

4 (f) The Arkansas Executive Chief Information Officer shall assign one  
5 individual from the staff of the Office of Information Technology to serve as  
6 a technology liaison to the Public Schools Academic Facilities Office.

7 (g) The Director of the Arkansas Building Authority shall assign one  
8 individual from the staff of the Arkansas Building Authority to serve as a  
9 physical plant liaison to the Public Schools Academic Facilities Officer.

10 (h) The Office of Public Schools Academic Facilities shall conduct an  
11 educational facilities needs assessment to be completed and presented to the  
12 no later than June 30, 2005.

13 (l) This assessment shall be a comprehensive review, district by  
14 district, of all existing facilities, including technology in each district.

15 (i) The Public Schools Academic Facilities Officer shall present a  
16 report on the educational facilities needs assessment to the State Board of  
17 Education no later than August 1, 2005.

18 (j) The Public Schools Academic Facilities Officer shall prepare a  
19 report, under the direction of the Arkansas State Board of General Education,  
20 for presentation to the Governor and the House and Senate Education  
21 Committees no later than September 1, 2005. This report shall include  
22 recommendations on the most critical facilities and technology needs and  
23 provide priorities for each category.

24 (k)(1) Effective January 1, 2006, the Office of Public Schools Academic  
25 Facilities shall on a quarterly basis receive a list of any repair in excess  
26 of five thousand dollars (\$5,000), new construction in excess of twenty-five  
27 thousand dollars (\$25,000), or technology needs in excess of ten thousand  
28 dollars (\$10,000) from each school district in the state.

29 (2) The Public School Academic Facilities Officer shall have the  
30 responsibility for creating a standardized reporting format and selecting the  
31 medium to be utilized by school districts in the preparation and submission  
32 of the report to the Office of Public Schools Academic Facilities.

33 (3) The data gathered from the reports generated by the school  
34 districts shall be presented to the State Board of Education for compilation  
35 into an annual report to the Governor and the House and Senate Education  
36 Committees on the facilities needs in the state.

1           (4) The Office of Public Schools Academic Facilities shall  
2 conduct any reviews, site visits, and other research during the year to  
3 assist in preparation of the annual report.

4           (1) The Public Schools Academic Facilities Officer shall present to the  
5 Governor and the House and Senate Education Committees an annual report on  
6 the public facilities status including the facilities and technologies needs  
7 and priorities for each category.

8           (m) No later than September 30 of each even numbered year of the  
9 biennium, the Public Schools Academic Facilities Officer shall present to the  
10 Governor and the House and Senate Education Committees the list of public  
11 school facilities and technology improvements proposed for the next biennium.

12  
13           Section 4. Creation of the Office of Education Renewal Zones under the  
14 State Board of Education.

15           (a) Upon the effective date of this act, there is created an Office of  
16 Public School Education Renewal Zones.

17           (c) The Office of Public School Education Renewal Zones shall report  
18 directly to the State Board of Education.

19           (d) The Chairman of the State Board of Education shall name a three  
20 member Public School Education Renewal Zones Oversight Panel consisting of  
21 the following individuals:

22                   (1) Chairman of the State Board of Education

23                   (2) Two (2) members of the State Board of Education

24           (e)(1)The Public School Education Renewal Zones Oversight Panel shall  
25 select an individual to serve as the Public School Education Renewal Zones  
26 Officer.

27                   (2) The Public School Education Renewal Zones Officer shall be  
28 classified as exempt from the provisions of the Uniform Classification and  
29 Compensation Act, Arkansas Code § 21-5-201 et seq.

30                   (3) The Public School Education Renewal Zones Officer, with  
31 guidance and approval from the Public School Education Renewal Zones  
32 Oversight Panel, shall be responsible for hiring all employees of the Office  
33 of Public School Education Renewal Zones.

34                   (4) The Director of the Arkansas Department of Higher Education  
35 shall assign one individual from the staff of the Department of Higher  
36 Education to serve as a liaison to the Office of Public Schools Education

1 Renewal Zones.

2 (f) The Office of Education Renewal Zones shall be responsible for  
3 developing guidelines for the approval of Education Renewal Zone strategic  
4 plans and guidelines for the evaluation and reporting of Education Renewal  
5 Zone activities.

6 (g) The Office of Education Renewal Zones shall approve any Education  
7 Renewal Zone strategic plan prior to the disbursement or annual renewal of funds  
8 to participating institutions of higher education.

9 (h) Effective July 1, 2004, any public school, education service center  
10 and institution of higher education is authorized to enter into one or more  
11 inter-local agreement through which they collaborate to improve public school  
12 performance and academic achievement.

13 (1) Each inter-local agreement shall establish an Education  
14 Renewal Zone.

15 (2) The purpose of an Education Renewal Zone shall be:

16 (A) To identify and implement education and management  
17 strategies designed specifically to improve public school performance and  
18 student academic achievement throughout the state of Arkansas, with special  
19 focus on the state's most academically distressed public schools.

20 (B) To provide for collaboration among the state's smaller  
21 schools and districts in order to achieve some of the advantages of economies  
22 of scale in providing educational and related activities.

23 (C) To maximize benefits and outcomes of public schooling  
24 by concentrating and coordinating the resources of Arkansas's higher  
25 education institutions, the expertise of the regional education service  
26 centers, and the technical assistance of other service providers to improve  
27 public school performance and student academic achievement.

28 (D) To enable small, rural and low-wealth schools to make  
29 the best use of the latest cost-effective distance learning technology to  
30 enhance curricula and professional development through two-way interactive  
31 learning environments.

32 (i) Each Education Renewal Zone shall consist of the following:

33 (1) Higher Education Partner (HEP)

34 (A) The Office of Education Renewal Zones shall develop,  
35 publish and disseminate guidelines for establishing an Education Renewal  
36 Zone, including a process for selecting a qualified Education Renewal Zone

1 Higher Education Partner (HEP) in each of the fifteen (15) educational  
2 service centers areas in the state and in Pulaski County.

3 (B) A qualified higher education institution shall meet the  
4 following minimum requirements:

5 (i) A school or department of education, or

6 (ii) A comprehensive four-year teacher preparation  
7 program, and

8 (iii) Be capable of demonstrating a willingness and  
9 flexibility to restructure its programs and services to meet the needs of the  
10 participating K-12 schools and school districts.

11 (iv) The Office of Education Renewal Zones shall give  
12 preference to qualified four-year higher education institutions located  
13 within the educational service center area.

14 (C) In the event that there is no qualified four-year  
15 higher education institution located within the education service center  
16 area, the Office of Education Renewal Zones may select:

17 (i) A two-year higher education institution that, in  
18 collaboration with a qualified four-year educational institution located in  
19 another education service center area, provides a comprehensive four-year  
20 teacher preparation program, or

21 (ii) A qualified higher education institution located  
22 in another educational service center area.

23 (iii) An institution of higher education may serve as  
24 the HEP for more than one educational service center area.

25 (2) Educational Service Center (ESC)

26 (A) The Educational Service Center shall be a full partner  
27 in planning, implementing and evaluating the Education Renewal Zone in its  
28 respective service area and shall provide direct services as called for in  
29 the Education Renewal Zone Plan.

30 (3) Public Schools

31 (A) Public schools may participate in an Education Renewal  
32 Zone upon successful application by the public school district of which the  
33 school is a part.

34 (B) The application for admission to the Education Renewal  
35 Zone shall be submitted to the Office of Education Renewal Zones at a time  
36 and in a manner as prescribed via rule or standard by the Office of Education

1 Renewal Zones.

2 (i) Acceptance or rejection of the application by a  
3 school for admittance to an Education Renewal Zone shall be the  
4 responsibility of the Office of Education Renewal Zones, with consultation  
5 from the Higher Education Partner.

6 (ii) The Office of Education Renewal Zones may  
7 include within an Education Renewal Zone any school within the Education  
8 Service Center area provided that no more than ten (10) schools may  
9 participate in any single Education Renewal Zone.

10 (iii) The Office of Education Renewal Zones may  
11 designate up to a maximum of three (3) Education Renewal Zones within any  
12 single Education Service Center area.

13 (C) In designating Education Renewal Zones and selecting  
14 schools for participation in a particular zone, the Office of Education  
15 Renewal Zones shall give priority to schools that meet one or more of the  
16 following criteria:

17 (i) The school is classified as "School Improvement  
18 Schools" or "Alert Status for School Improvement" under the Arkansas state  
19 compliance plan under the federal Elementary and Secondary Education Act of  
20 2002, the No Child Left Behind Act.

21 (ii) The school lies within a school district  
22 classified as in "Academic Distress" or "Financial Distress" under the  
23 Arkansas Comprehensive Testing, Assessment, and Accountability Program.

24 (iii) The school demonstrates an inability to hire  
25 and retain highly qualified teachers as defined by the state plan for  
26 compliance with the No Child Left Behind Act.

27 (iv) The school demonstrates an inability to provide  
28 the minimum number of course offerings as determined by the state through the  
29 conventional hiring of qualified teachers.

30 (v) The school is within a school district with an  
31 average daily membership of fewer than one thousand five hundred (1,500)  
32 students.

33 (vi) The school serves a student population that  
34 exceeds the average rate of participation in free or reduced price lunch  
35 programs.

36 (4) Local Advisory Group

1                   (A) Each Education Renewal Zone shall form a local advisory  
 2 group comprised of a representative of the following groups:

3                   (i) The Higher Education Institution Partner

4                   (ii) The Education Service Center which includes the  
 5 area in which the Education Renewal Zone is located

6                   (iii) The public school or school district  
 7 participating in the Education Renewal Zone.

8                   (iv) Each community in which there is a school  
 9 participating in the Education Renewal Zone.

10                   (B) The Office of Education Renewal Zones may designate up  
 11 to a maximum of three (3) Education Renewal Zones within any single Education  
 12 Service Center area.

13                   (5) Technical Assistance Provider (TAP)

14                   (A) Any two-year community or technical college, technical  
 15 support organization, or other entity may participate in the Education  
 16 Renewal Zone at the discretion of the Office of Education Renewal Zones and  
 17 in collaboration with a designated Higher Education Institution Partner and a  
 18 designated Education Service Center.

19                   (j) The Office of Education Renewal Zones, the State Board of Education  
 20 and the local school districts shall exercise due diligence to assure that  
 21 all schools classified as "School Improvement Schools" under the No Child  
 22 Left Behind Act are included in a designated Education Renewal Zone.

23                   (k) The Office of Education Renewal Zones may, at its discretion,  
 24 include any school regardless of its eligibility under the foregoing  
 25 criteria, if it determines that on the basis of location, characteristics of  
 26 its faculty or leadership, needs of the students, or other factors, in the  
 27 judgment of the Office of Education Renewal Zones, that the inclusion of such  
 28 school significantly strengthens the prospect of the Education Renewal Zone  
 29 in meeting its school improvement goals.

30                   (l) The Office of Education Renewal Zones may, at its discretion,  
 31 change participating schools within each Education Renewal Zone.

32                   (m) Each school participating in an Education Renewal Zone shall  
 33 develop and implement a school improvement plan.

34                   (1) Each school improvement plan shall at a minimum include the  
 35 following:

36                   (A) Goals for improving student achievement

1                   (B) Measurable benchmarks for achieving student improvement  
2 goals.

3                   (C) A timeline for reaching goals in improving student  
4 achievement.

5                   (D) Requirements for services to be provided by the  
6 Education Renewal Zone Partners.

7           (n) The partners within a specific Education Renewal Zone shall develop  
8 a strategic plan that is responsive to the needs of the individual school  
9 improvement plans.

10           (o) The Education Renewal Zone Strategic Plan shall at a minimum  
11 provide for the following:

12                   (A) Collaboration between and among the higher education  
13 institution partners, education service centers, schools and communities  
14 participating in the Education Renewal Zone, including within the academic  
15 departments within the higher education institution partners

16                   (B) A comprehensive program of professional development to  
17 assure the practical knowledge base of pre-service and in-service teachers  
18 with respect to pedagogical practice, content knowledge, and competent use of  
19 distance learning technology.

20                   (C) Enhancement and expansion of local school curricula  
21 offerings through the use of two-way interactive television to include  
22 advanced placement, dual-credit and advanced high school courses,

23                   (D) The sharing of faculty for core course offerings when  
24 schools are unable to hire highly qualified teachers in core subject areas  
25 required for college entrance or teachers necessary to meet state  
26 accreditation standards,

27                   (E) A strategy to recruit and retain highly qualified  
28 teachers with particular focus on hard-to-staff schools,

29                   (F) A system for mentoring teachers with three (3) or fewer  
30 years of professional service,

31                   (G) Active participation of the community in the work of  
32 the school,

33                   (H) Active involvement of parents in the academic work of  
34 the student, and

35                   (I) A means of collecting the data necessary to evaluate  
36 the progress of each participating public school and the Education Renewal

1 Zone in its entirety.

2 (p) Each Education Renewal Zone, using guidelines and indicators set by  
3 the Office of Education Renewal Zones, shall prepare an annual report to the  
4 Office of Education Renewal Zones describing the progress toward  
5 accomplishing the goals of the Education Renewal Zone.

6 (q) The Office of Education Renewal Zones, under guidance and direction  
7 of the Office of Education Renewal Zones Oversight panel of the State Board  
8 of Education, shall prepare an annual report to the Governor, the General  
9 Assembly, and the Arkansas State Board of Education describing the progress  
10 toward accomplishing the goals of the individual Education Renewal Zones and  
11 the overall Education Renewal Zone program.

12 (r) The Office of Education Renewal Zones shall establish a website,  
13 accessible by the public, to provide for broad dissemination of both the  
14 Education Renewal Zone plans and strategies and the results of the annual  
15 reports on progress toward accomplishing the goals of the individual  
16 Education Renewal Zones and the overall Education Renewal Zone program.

17  
18 SECTION 5. Restructuring of the Arkansas Department of Education

19 (a) Upon the effective date of this act, the Academic Standards and  
20 Assessment Unit of the Accountability Section of the Arkansas Department of  
21 Education and its personnel positions, powers, authorities, duties, and  
22 functions shall be eliminated.

23 (b) Upon the effective date of this act, the Educational Accountability  
24 Unit of the Accountability Section of the Arkansas Department of Education  
25 and its personnel positions, powers, authorities, duties, and functions shall

26 teachers have a keen understanding of what is expected of them and the

5 (B) disruptive behavior

2 (ii) Screening should be conducted to diagnose learning difficulties and

4 (3) Eligible students with disabilities defined by the Individuals with  
5 Disabilities Education Act (IDEA), Public Law 94-142, as amended, may be  
6 placed in an ALE.

7 ALEs shall provide access to appropriate education services consistent with

9 (4) Each ALE shall have a plan to involve parents, guardians, or other  
10 parties responsible for the student.

11 (5) The district or districts operating the ALE shall not discriminate  
12 against any student or group of students on the basis of race, gender,  
13 handicap, or religious belief in the criteria for admission or in operating  
14 the ALE.

15 (c) ~~(a)~~ Every school district shall establish an alternative learning  
16 environment which shall afford students an environment conducive to learning.

17 (d)(1) ~~(b)~~ The alternative learning environment required by this  
18 section may be established by more than one (1) school district ~~or may be~~  
19 ~~operated by a public school educational cooperative established under § 6-13-~~  
20 ~~901 et seq~~ or an education service center.

21 (2) The alternative learning environment must meet the following criteria:

22 (A) Have students supervised by a currently licensed teacher;

23 (B)(i) Have a student to teacher ratio in the alternative learning  
24 environment of no more than fifteen (15) to one (1).

25 (ii) Have a student-to-teacher ratio of no more than twenty (20) to one (1)  
26 if an aide is employed in addition to a licensed supervisor.

29 (C) Provide each alternative learning student access to the services of a  
30 school counselor or a mental health professional and a social worker and  
31 other district resources including but not limited to transportation, health

34 language arts correlated with the regular classroom instruction or with the

 10 Lake View School District No. 25 v. Huckabee, 351 Ark. 31 (2002) declared the  
 11 now existing system of education to be unconstitutional because it is both  
 12 inequitable and inadequate; and the Arkansas Supreme Court set forth the test  
 13 for a constitutional system to be one in which the State has an “absolute  
 14 duty” to provide an “equal opportunity to an adequate education”; and the  
 15 Arkansas Supreme Court instructed the General Assembly to define and provide  
 16 what is necessary to provide an adequate and equitable education for the  
 17 children of Arkansas. Therefore, an emergency is declared to exist and this  
 18 act being immediately necessary for the preservation of the public peace,  
 19 health, and safety shall become effective on:

20           (1) The date of its approval by the Governor;

21           (2) If the bill is neither approved nor vetoed by the Governor,  
 22 the expiration of the period of time during which the Governor may veto the  
 23 bill; or

24           (3) If the bill is vetoed by the Governor and the veto is  
 25 overridden, the date the last house overrides the veto.
