1 In addition to powers conferred upon the Arkansas Commission on Law 2 Enforcement Standards and Training elsewhere in this subchapter, the commission shall have power to: 3

- 4 (1) Promulgate rules and regulations for the administration of 5 this subchapter. The rules and regulations promulgated by the commission 6 shall not go into full force and effect until the commission seeks the advice 7 of the Legislative Council and the House Interim Committee on Public Health, 8 Welfare, and Labor and the Senate Interim Committee on Public Health,
