SECTION 4. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
PROVISIONS. Any unexpended balance of any appropriation provided in this Act
which remains at the close of the fiscal year ending June 30, 2004 2006,
shall be transferred forward and made available for the same purpose for the
fiscal year ending June 30, 2005 2007. The provisions of this section shall
be in effect only from July 1, 2003 2005 through June 30, 2005 2007.

10 SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 11 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. REFUND TO EXPENDITURES. Proceeds generated from the rental of the Arkansas Governor's 12 Mansion-Grand Hall shall be deposited into the State Treasury as a "Refund to 13 Expenditures" to be used by the Arkansas Governor's Mansion Commission solely 14 15 for the expenses of operating the Arkansas Governor's Mansion-Grand Hall. 16 The provisions of this section shall be in effect only from July 1, 2003 2005 17 through June 30, <del>2005</del> 2007.

SECTION 6. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR 19 20 PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER 21 PROVISION. After receiving approval from the Chief Fiscal Officer of the 22 State, and prior review by the Arkansas Legislative Council, the Agency is 23 authorized to transfer appropriation from line items (01) and (03) authorized 24 in Section 3 Appropriation - Operations of this Act to the Mansion Expense line item authorized in Section 3. The provisions of this section shall be 25 in effect only from July 1, 2005 through June 30, 2007. 26

28 SECTION 7. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by 29 this act shall be limited to the appropriation for such agency and funds made 30 available by law for the support of such appropriations; and the restrictions of the State Procurement Law, the General Accounting and Budgetary Procedures 31 32 Law, the Revenue Stabilization Law, the Regular Salary Procedures and 33 Restrictions Act, or their successors, and other fiscal control laws of this 34 State, where applicable, and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied 35 36 with in disbursement of said funds.

2	SECTION 8. LEGISLATIVE INTENT. It is the intent of the General Assembly				
3	that any funds disbursed under the authority of the appropriations contained				
4	in this act shall be in compliance with the stated reasons for which this act				
5	was adopted, as evidenced by the Agency Requests, Executive Recommendations				
6	and Legislative Recommendations contained in the budget manuals prepared by				
7	the Department of Finance and Administration, letters, or summarized oral				
8	testimony in the official minutes of the Arkansas Legislative Council or				
9	Joint Budget Committee which relate to its passage and adoption.

11	SECTION 9. EMERGENCY CLAUSE. It is found and determined by the General				
12	Assembly, that the Constitution of the State of Arkansas prohibits the				
13	appropriation of funds for more than a two (2) year period; that the				
14	effectiveness of this Act on July 1, 2005 is essential to the operation of				
15	the agency for which the appropriations in this Act are provided, and that in				
16	the event of an extension of the Regular Session, the delay in the effective				
17	date of this Act beyond July 1, 2005 could work irreparable harm upon the				
18	proper administration and provision of essential governmental programs.				
19	Therefore, an emergency is hereby declared to exist and this Act being				
20	necessary for the immediate preservation of the public peace, health and				
21	safety shall be in full force and effect from and after July 1, 2005.
