- 5 Department of Workforce Education Public School Fund Account shall be used
- 6 for grants and aids for the programs administered by the Department of
- 7 Workforce Education consisting of, but not limited to:

8	proper administration and provision of essential governmental programs.
9	Therefore, an emergency is hereby declared to exist and this Act being
10	necessary for the immediate preservation of the public peace, health and
11	safety shall be in full force and effect from and after July 1, 2005.
