33	associate clinical psychotherapists or licensed clinical psychotherapists, or
34	their services to be psychological services; or
35	(5) Students of psychology, psychological interns, psychological
36	residents, and others persons preparing for the profession of psychology and

1	clinical psychotherapy from performing as a part of their training the
2	functions of clinical psychotherapists as defined in this chapter and the
3	rules of the Arkansas Board of Clinical Psychotherapy.
4	
5	17-107-105. Existing laws and rules regarding licensed psychological
6	examiners.
7	All state laws and state agency rules that authorize practice by
8	licensed psychological examiners shall be deemed to authorize practice by
9	licensed associate clinical psychotherapists and licensed clinical
10	psychotherapists.
11	
12	17-107-106. Privileged communications.
13	(a) For purposes of this chapter, the confidential relations and
14	communications between a licensed clinical psychotherapist or licensed
15	associate clinical psychotherapist and a client shall be the same as those
16	provided by law between an attorney and a client.
17	(b) Nothing in this chapter may be construed to require any
18	communication privileged under this section to be disclosed.
19	
20	Subchapter 2 - Arkansas Board of Clinical Psychotherapy.
21	17-107-201 Creation - Members.
22	(a)(1)(A) There is created the Arkansas Board of Clinical
23	Psychotherapy which shall consist of six (6) members who shall be appointed
24	by the Governor for terms of five (5) years.
25	(B) Appointments shall be for staggered terms so that no
26	more than one (1) position will expire in a given year.
27	(2) The Governor shall appoint:

5	on or participate in the administration or grading of examinations of
6	applicants for licensure;
7	(b) Have resided in Arkansas for at least five
8	(5) years immediately preceding appointment;
9	(c) Never have been a psychologist, licensed
10	psychological examiner, licensed clinical psychotherapist, licensed
11	professional counselor, or licensed clinical social worker; and
12	(d) Not otherwise have conflicts with his or
13	her duties as a board member.
14	(b)(1) The Governor shall ensure that the professional members
15	appointed under this section reflect a diversity of practice specialties,
16	including but not limited to, clinical, psychology, health, and school
17	psychology.
18	(2) All positions shall be appointed from a list of nominees
19	provided by the Arkansas Association of Masters in Psychology, any other
20	interested organizations, and or from a list with at least twenty (20)
21	signatures of licensees by the Arkansas Board of Clinical Psychotherapy.
22	(c)(1) Each member appointed to the board under subdivisions $(a)(2)(A)$
23	and (B) of this section shall:
24	(A) Reside within the State of Arkansas;
25	(B) Hold a current valid license to practice clinical
26	psychotherapy; and
27	(C) Have been licensed by the Arkansas Psychology Board,
28	the Arkansas Board of Clinical Psychotherapy, or both to practice for at
29	least five (5) years immediately preceding his or her appointment to the
30	board.
31	(2) At the time of the appointment, each member appointed to the
32	board under subdivisions (a)(2)(A) and (B) of this section shall be free of
33	any conflict of interest and the appearance of any conflict with his or her
34	duties as a member of the board.
35	(3) A board member shall immediately submit a letter of
36	resignation to the Governor if the board member:

1	(A) Fails to maintain or no longer meets the
2	qualifications as outlined in this statute for board membership; or
3	(B) Pleads guilt or nolo contendere to, or is found guilty
4	of a felony or other unlawful act involving moral turpitude by a court of
5	competent jurisdiction.
6	(c)(1) At least thirty (30) days before the expiration of the term of
7	any board member, the Governor shall appoint a person to replace that board
8	member.
9	(2) If the Arkansas Association of Masters in Psychology, other
10	interested organizations, or licensed clinical psychotherapists choose to
11	submit nominees to the Governor, they shall do so no later than (40) days
12	before the expiration of a board member's term.
13	(d) The Governor shall fill all vacancies on the board within thirty
14	(30) days after the vacancy occurs.
15	(e) The Governor shall remove any member from the board if he or she:
16	(i) Ceases to be qualified;
17	(ii) Fails to attend three (3) successive board
18	meetings without just cause as determined by the board;
19	(iii) Is found to be in violation of this chapter;
20	(iv) Pleads guilty or nolo contendere to, or is
21	found guilty of a felony or other unlawful act involving moral turpitude by a
22	court of competent jurisdiction; or
23	(v) Pleads guilty or nolo contendere to, or is found
24	guilty of malfeasance, misfeasance, or nonfeasance in relation to his or her
25	board duties by a court of competent jurisdiction.
26	(f) All vacancies occurring on the board by reason of resignation or
27	otherwise shall be filled by the Governor for the unexpired term, the
28	professional members from the list of qualified persons, within thirty (30)
29	days after the vacancy occurs.
30	(g)(1) Terms of each member shall expire on December 31 of the year in
31	which the term expires.
32	(h)(1) Immediately and before entering upon the duties of office, the
33	members of the board shall
34	(A) Take and subscribe to the constitutional oath of
35	office; and
36	(B) File the oath in the office of the Governor.

1	(2) Upon receiving the oath, the Governor shall issue to each
2	member a certificate of appointment.
3	(i) Members shall be eligible to receive reimbursement for mileage and
4	reimbursement for expenses in accordance with § 25-16-902.
5	(2) However, the reimbursements shall not exceed the fees
6	collected by the board.
7	(j) The Governor shall call the first meeting of the board within
8	sixty (60) days of the appoint of the members of the board.
9	
10	17-107-202 Organization and proceedings.
11	(a) The Arkansas Board of Clinical Psychotherapy shall elect a chair,
12	a secretary, and a treasurer.
13	(b)(1) The board shall hold at least one (1) regular meeting each
14	year.
15	(2) Special meetings may be held at the discretion of the chair
16	or at the written request of any two (2) members of the board.
17	(c) A majority of the members of the board shall constitute a quorum.
18	(d)(1) The board shall adopt a seal.
19	(2) The seal shall be affixed to all certificates issued by the
20	board.
21	(e) There is established within the board the Joint Administrative
22	Oversight and Budget Committee.
23	(1)(A) Membership of the Joint Administrative Oversight and
24	Budget Committee shall be:
25	(i) The chair and treasurer of the Arkansas Psychology
26	Board; and
27	(ii) The chair and treasurer of the Arkansas Board of
28	Clinical Psychotherapy.
29	(2) Ad hoc members without voting privileges shall be the
30	administrative staff members employed by the Arkansas Board of Psychology and
31	the Arkansas Board of Clinical Psychotherapy.
32	(3) The Joint Administrative Oversight and Budget Committee
33	shall:
34	(A) Provide advice and recommendations to the Arkansas
35	Psychology Board and the Arkansas Board of Clinical Psychotherapy on matters
36	of administration and finance that relate to the generation of income,

1	general operations, and expenditures of monies by the two (2) boards; and
2	(B) Make decisions concerning personnel matters and
3	utilization of monies.
4	
5	17-107-203. Powers and duties.
6	(a) The Arkansas Board of Clinical Psychotherapy may:
7	(1) Hire assistance as necessary to carry on its activities
8	within the limits of funds available to the board as directed by the Joint
9	Administrative Oversight and Budget Committee; and
10	(2) Accept grants from foundations or institutions; the monies
11	to be managed by the Joint Oversight and Budget Committee.

1	(2) Fees and penalties shall be added to the amount collected by

5	Subchapter 3. Licensing
6	17-107-301. Legislative intent.
7	The General Assembly intends that all licensed associate clinical

21	- Qualifications.
22	(a) No person may practice as or hold himself or herself out as a
23	licensed associate clinical psychotherapist unless that person possesses a
24	valid license issued by the Arkansas Board of Clinical Psychotherapy.
25	(b)(1) A person who seeks to be licensed to practice as a licensed
26	associate clinical psychotherapist who has not previously been licensed to do
27	so shall apply to the board for licensure.
28	(2) The application shall be:
29	(A) Addressed to the chair of the board; and
30	(B) On a form and in the manner adopted by the board.
31	(c)(1) A candidate for licensure shall furnish the board with
32	satisfactory evidence that he or she:
33	(A) Is of good moral character;
34	(B) Has received a master's degree in psychology or
35	related field from a regionally accredited educational institution recognized
36	by the board as maintaining satisfactory standards;

1	(C) Has passed written or oral examinations, or both as
2	the board requires to show competence to practice as a licensed associate
3	clinical psychotherapist;
4	(D) Has not violated ethical rules promulgated by the
5	board;
6	(E) Has applied to the Identification Bureau of the
7	Department of Arkansas State Police for a state and national criminal
8	background check to be conducted by the Federal Bureau of Investigation;
9	(F) Has not been found guilty of or pleaded guilty or nolo
10	contendere to any of the offenses listed in §17-97-313; and
11	(G) Has not failed an examination given by the board within
12	the preceding six (6) months.
13	(d) The board shall promulgate rules regarding the qualifications,
14	restrictions, and reporting requirements of supervisors to implement the
15	intent of this chapter to avoid restricting the professional integrity of
16	licensed associate clinical psychotherapists.
17	
18	17-107-304. Licensed clinical psychotherapist Application
19	Qualifications.
20	(a) No person may practice as or hold himself or herself out as a
21	licensed clinical psychotherapist unless that person possesses a valid
22	license issued by the Arkansas Board of Clinical Psychotherapy.
23	(b)(1) A person who has been licensed for three (3) years or practiced

8	(c)(l) After a review of all submitted documentation, the Arkansas
9	Board of Clinical Psychotherapy may issue a license to practice as a licensed
10	clinical psychotherapist.
11	(2)(A) However, the Arkansas Board of Clinical Psychotherapy may
12	decline to issue a license to practice as a licensed clinical psychotherapist
13	if the Arkansas Board of Clinical Psychotherapy finds that the applicant has
14	shown insufficient proficiency.
15	(B) If the Arkansas Board of Clinical Psychotherapy
16	declines to issue a license to practice as a licensed clinical

36	contendere to, or is found guilty of contendere to or been found guilty of a

2	(7) Does not use drugs or alcohol to an extent that affects the
