17	(a) Nothing in this chapter prevents:
18	(1) The teaching of psychology, or the conduct of psychological
19	research by a licensed associate clinical psychotherapist, a licensed
20	<u>clinical</u> psychotherapist or other licensed or unlicensed professionals under
21	the laws of Arkansas, if the teaching or research without regard to the
22	source or extent of payment for services rendered does not involve the
23	$\underline{\text{delivery or supervision of direct services to individuals who are themselves,}$
24	rather than a third party, the intended beneficiaries of the services;
25	(2) The provision of expert testimony by licensed clinical
26	psychotherapists who are exempted by this chapter;
27	(3) Members of other professions licensed under the laws of
28	Arkansas from rendering services within the scope of practice as set out in
29	the laws regulating their professional practices, if they do not represent
30	themselves to be licensed associate clinical psychotherapists or licensed
31	clinical psychotherapists;
32	(4) Recognized members of the clergy from functioning in their
33	ministerial capacities, if they do not represent themselves to be licensed
34	associate clinical psychotherapists or licensed clinical psychotherapists, or
35	their services to be psychological services; or
36	(5) Students of psychology, psychological interns, psychological

1	residents, and others persons preparing for the profession of psychology and
2	clinical psychotherapy from performing as a part of their training the
3	functions of clinical psychotherapists as defined in this chapter and the
4	rules of the Arkansas Board of Clinical Psychotherapy.
5	
6	17-107-105. Existing laws and rules regarding licensed psychological
7	examiners.
8	All state laws and state agency rules that authorize practice by
9	licensed psychological examiners shall be deemed to authorize practice by
10	licensed associate clinical psychotherapists and licensed clinical
11	psychotherapists.
12	
13	17-107-106. Privileged communications.
14	(a) For purposes of this chapter, the confidential relations and
15	communications between a licensed clinical psychotherapist or licensed
16	associate clinical psychotherapist and a client shall be the same as those
17	provided by law between an attorney and a client.
18	(b) Nothing in this chapter may be construed to require any
19	communication privileged under this section to be disclosed.
20	
21	Subchapter 2 - Arkansas Board of Clinical Psychotherapy.
22	17-107-201 Creation - Members.
23	(a)(1)(A) There is created the Arkansas Board of Clinical
24	Psychotherapy which shall consist of six (6) members who shall be appointed
25	by the Governor for terms of five (5) years.
26	(B) Appointments shall be for staggered terms so that no
27	more than two (2) positions will expire in a given year.
28	(2) The Governor shall appoint:
29	(A) One (1) academic member engaged in full-time teaching
30	of psychology at an institution of higher learning approved by the Arkansas
31	Board of Clinical Psychotherapy.
32	(B) Four (4) practicing licensed clinical psychotherapist
33	members engaged in full-time practice with:
34	(i) At least one (1) member being engaged in full-
35	time, private practice; and
36	(ii) One (1) member employed full-time by a state-

1	<u>funded agency or private non-profit mental health provider;</u>
2	(C)(i) One (1) member to represent consumers appointed
3	from the state at large and subject to confirmation by the Senate.
4	(ii) The consumer representative shall:
5	(a) Be a full voting member but shall not vote
6	on or participate in the administration or grading of examinations of
7	applicants for licensure;
8	(b) Have resided in Arkansas for at least five
9	(5) years immediately preceding appointment;
10	(c) Never have been a psychologist, licensed
11	psychological examiner, licensed clinical psychotherapist, licensed
12	professional counselor, or licensed clinical social worker; and
13	(d) Not otherwise have conflicts with his or
14	her duties as a board member.
15	(b)(1) The Governor shall ensure that the professional members
16	appointed under this section reflect a diversity of practice specialties,
17	including but not limited to, clinical, psychology, health, and school
18	psychology.
19	(2) All positions shall be appointed from a list of nominees
20	provided by the Arkansas Association of Masters in Psychology, any other
21	interested organizations, and or from a list with at least twenty (20)
22	signatures of licensees by the Arkansas Board of Clinical Psychotherapy.
23	(c)(1) Each member appointed to the board under subdivisions (a)(2)(A)
24	and (B) of this section shall:
25	(A) Reside within the State of Arkansas;
26	(B) Hold a current valid license to practice clinical
27	psychotherapy; and
28	(C) Have been licensed by the Arkansas Psychology Board,
29	the Arkansas Board of Clinical Psychotherapy, or both to practice for at
30	least five (5) years immediately preceding his or her appointment to the
31	board.
32	(2) At the time of the appointment, each member appointed to the
33	board under subdivisions (a)(2)(A) and (B) of this section shall be free of
34	any conflict of interest and the appearance of any conflict with his or her
35	duties as a member of the board.
36	(3) A board member shall immediately submit a letter of

1	resignation to the Governor if the board member:
2	(A) Fails to maintain or no longer meets the
3	qualifications as outlined in this statute for board membership; or
4	(B) Pleads guilty or nolo contendere to, or is found
5	guilty of a felony or other unlawful act involving moral turpitude by a court
6	of competent jurisdiction.
7	(c)(1) At least thirty (30) days before the expiration of the term of
8	any board member, the Governor shall appoint a person to replace that board
9	member.
10	(2) If the Arkansas Association of Masters in Psychology, other
11	interested organizations, or licensed clinical psychotherapists choose to
12	submit nominees to the Governor, they shall do so no later than (40) days
13	before the expiration of a board member's term.
14	(d) The Governor shall fill all vacancies on the board within thirty
15	(30) days after the vacancy occurs.
16	(e) The Governor shall remove any member from the board if he or she:
17	(i) Ceases to be qualified;
18	(ii) Fails to attend three (3) successive board
19	meetings without just cause as determined by the board;
20	(iii) Is found to be in violation of this chapter;
21	(iv) Pleads guilty or nolo contendere to, or is
22	found guilty of a felony or other unlawful act involving moral turpitude by a
23	court of competent jurisdiction; or
24	(v) Pleads guilty or nolo contendere to, or is found
25	guilty of malfeasance, misfeasance, or nonfeasance in relation to his or her
26	board duties by a court of competent jurisdiction.
27	(f) All vacancies occurring on the board by reason of resignation or
28	otherwise shall be filled by the Governor for the unexpired term, the
29	professional members from the list of qualified persons, within thirty (30)
30	days after the vacancy occurs.
31	(g)(1) Terms of each member shall expire on December 31 of the year in
32	which the term expires.
33	(h)(1) Immediately and before entering upon the duties of office, the
34	members of the board shall
35	(A) Take and subscribe to the constitutional oath of
36	office; and

1	(B) File the oath in the office of the Governor.
2	(2) Upon receiving the oath, the Governor shall issue to each
3	member a certificate of appointment.
4	(i) Members shall be eligible to receive reimbursement for mileage and
5	reimbursement for expenses in accordance with § 25-16-902.
6	(2) However, the reimbursements shall not exceed the fees
7	collected by the board.
8	(j) The Governor shall call the first meeting of the board within
9	sixty (60) days of the appointment of the members of the board.
10	
11	17-107-202 Organization and proceedings.
12	(a) The Arkansas Board of Clinical Psychotherapy shall elect a chair,
13	a secretary, and a treasurer.
14	(b)(1) The board shall hold at least one (1) regular meeting each
15	year.
16	(2) Special meetings may be held at the discretion of the chair
17	or at the written request of any two (2) members of the board.
18	(c) A majority of the members of the board shall constitute a quorum.
19	(d)(1) The board shall adopt a seal.
20	(2) The seal shall be affixed to all certificates issued by the
21	board.
22	(e) There is established within the board the Joint Administrative
23	Oversight and Budget Committee.
24	(1)(A) Membership of the Joint Administrative Oversight and
25	Budget Committee shall be:
26	(i) The chair and treasurer of the Arkansas Psychology
27	Board; and
28	(ii) The chair and treasurer of the Arkansas Board of
29	Clinical Psychotherapy.
30	(2) Ad hoc members without voting privileges shall be the
31	administrative staff members employed by the Arkansas Board of Psychology and
32	the Arkansas Board of Clinical Psychotherapy.
33	(3) The Joint Administrative Oversight and Budget Committee
34	shall:
35	(A) Provide advice and recommendations to the Arkansas
36	Psychology Board and the Arkansas Board of Clinical Psychotherapy on matters

1	of administration and finance that relate to the generation of income,
2	general operations, and expenditures of monies by the two (2) boards; and
3	(B) Make decisions concerning personnel matters and
4	utilization of monies.
5	
6	17-107-203. Powers and duties.
7	(a) The Arkansas Board of Clinical Psychotherapy may:
8	(1) Hire assistance as necessary to carry on its activities
9	within the limits of funds available to the board as directed by the Joint
10	Administrative Oversight and Budget Committee; and
11	(2) Accept grants from foundations or institutions; the monies
12	to be managed by the Joint Oversight and Budget Committee.
13	(b) The board shall:
14	(1) Examine and pass upon the qualifications of applicants for
15	the practice of clinical psychotherapy; and
16	(2)(A) Adopt a code of conduct consistent with national
17	standards set forth by the North American Association of Masters in
18	Psychology as they existed on January 1, 2005 to govern appropriate practices
19	and behavior for the practice of clinical psychotherapy.
20	(B) The board shall file the code with the Secretary of
21	State not less than thirty (30) days before the effective date of the code of
22	conduct.
23	
24	17-107-204. Collection and disposition of fees.
25	(a) The Arkansas Board of Clinical Psychotherapy may establish and
26	collect fees and penalties for administrative services, including, but not
27	<pre>limited to:</pre>
28	(1) The issuance of temporary permits and other printed
29	materials;
30	(2) Handling returned checks;
31	(3) Costs incurred in processing delinquent payments; and
32	(4) Other reasonable services as the board may determine.
33	(b) The fees, along with other cash funds made available to the board,
34	shall be used to supplement the board with adequate income to provide for the
35	efficient and necessary operations of the board.
36	(c)(l) The hoard shall set fees and penalties in accordance with

1	recommendations from the Joint Oversight and Budget Committee.
2	(2) Fees and penalties shall be added to the amount collected by
3	the Arkansas Psychology Board for the joint operation of the two (2)
4	respective boards.
5	
6	Subchapter 3. Licensing
7	17-107-301. Legislative intent.
8	The General Assembly intends that all licensed associate clinical
9	psychotherapists and licensed clinical psychotherapists conform to the
10	licensing requirements of this subchapter in order to protect the public
11	health and welfare by insuring competence in the delivery of services.
12	
13	17-107-302. Penalties.
14	If any person practices as or hold himself or herself out to the public
15	as being licensed to engage in the practice of clinical psychotherapy, but
16	does not then possess a valid license to practice as a licensed associate
17	clinical psychotherapist or licensed clinical psychotherapist, he or she
18	shall be guilty of a misdemeanor punishable by a fine of not less than one
19	hundred dollars (\$100) nor more than five hundred dollars (\$500).
20	
21	17-107-303. Licensed associate clinical psychotherapistApplication
22	- Qualifications.
23	(a) No person may practice as or hold himself or herself out as a
24	licensed associate clinical psychotherapist unless that person possesses a
25	valid license issued by the Arkansas Board of Clinical Psychotherapy.
26	(b)(1) A person who seeks to be licensed to practice as a licensed
27	associate clinical psychotherapist who has not previously been licensed to do
28	so shall apply to the board for licensure.
29	(2) The application shall be:
30	(A) Addressed to the chair of the board; and
31	(B) On a form and in the manner adopted by the board.
32	(c)(1) A candidate for licensure shall furnish the board with
33	satisfactory evidence that he or she:
34	(A) Is of good moral character;
35	(B) Has received a master's degree in psychology or
36	related field from a regionally accredited educational institution recognized

1	by the board as maintaining satisfactory standards;
2	(C) Has passed written or oral examinations, or both as
3	the board requires to show competence to practice as a licensed associate
4	clinical psychotherapist;
5	(D) Has not violated ethical rules promulgated by the
6	board;
7	(E) Has applied to the Identification Bureau of the
8	Department of Arkansas State Police for a state and national criminal
9	background check to be conducted by the Federal Bureau of Investigation;
10	(F) Has not been found guilty of or pleaded guilty or nolo
11	contendere to any of the offenses listed in §17-107-313; and
12	(G) Has not failed an examination given by the board within
13	the preceding six (6) months.
14	(d) The board shall promulgate rules regarding the qualifications,
15	restrictions, and reporting requirements of supervisors to implement the
16	intent of this chapter to avoid restricting the professional integrity of
17	licensed associate clinical psychotherapists.
18	
19	17-107-304. Licensed clinical psychotherapist Application
20	Qualifications.
21	(a) No person may practice as or hold himself or herself out as a
22	licensed clinical psychotherapist unless that person possesses a valid
23	license issued by the Arkansas Board of Clinical Psychotherapy.
24	(b)(1) A person who has been licensed for three (3) years or practiced
25	clinical psychotherapy for the full-time equivalent of three (3) years as a
26	licensed associate clinical psychotherapist may petition the Arkansas Board
27	of Clinical Psychotherapy to be licensed as a licensed clinical
28	psychotherapist with independent practice privileges.
29	(2)(A) The Arkansas Board of Clinical Psychotherapy shall
30	promulgate rules for granting petitions for licensure under subdivision
31	(b)(1) of this section.
32	(B) The rules shall be based upon experience, training,
33	and adherence to the rules of the Arkansas Board of Clinical Psychotherapy.
34	(3) Applications shall be accompanied by:
35	(A) Three (3) letters of reference as follows:
36	(i) One (1) letter shall be from the applicant's

1	current or most recent clinical supervisor;
2	(ii) One (1) letter shall attest to the applicant's
3	clinical competence; and
4	(iii) One (1) letter shall be a non-academic
5	character reference;
6	(B) A revised statement of intent to practice; and
7	(C) Other materials required by the Arkansas Board of
8	Clinical Psychotherapy.
9	(c)(1) After a review of all submitted documentation, the Arkansas
10	Board of Clinical Psychotherapy may issue a license to practice as a licensed
11	clinical psychotherapist.
12	(2)(A) However, the Arkansas Board of Clinical Psychotherapy may
13	decline to issue a license to practice as a licensed clinical psychotherapist
14	if the Arkansas Board of Clinical Psychotherapy finds that the applicant has
15	shown insufficient proficiency.
16	(B) If the Arkansas Board of Clinical Psychotherapy
17	declines to issue a license to practice as a licensed clinical
18	psychotherapist, the applicant shall continue to practice under a supervisor
19	approved by the Arkansas Board of Clinical Psychotherapy until the
20	deficiencies are corrected.
21	(d)(1) Upon request from the Arkansas Board of Clinical Psychotherapy,
22	the applicant shall furnish evidence that he or she:
23	(A) Is of good moral character;
24	(B) Has received a master's degree in psychology or a
25	related degree from a regionally accredited educational institution
26	recognized by the Arkansas Board of Clinical Psychotherapy as maintaining
27	satisfactory standards;
28	(C) Has passed such examinations written or oral or both
29	as required by the Arkansas Board of Clinical Psychotherapy to show competent
30	to practice as a licensed clinical psychotherapist;
31	(D) Has not violated ethical rules promulgated by the
32	Arkansas Board of Clinical Psychotherapy;
33	(E) Has applied to the Identification Bureau of the
34	Department of Arkansas State Police for a state and national criminal
35	background check to be conducted by the Federal Bureau of Investigation; and
36	(E) Has not been found guilty of or pleaded guilty or nolo

1	contendere to any of the offenses listed in §17-107-313; and
2	(F) Has not failed an examination given by the Arkansas
3	Board of Clinical Psychotherapy within the preceding six (6) months.
4	(e)(1) A person who has been licensed as a psychological examiner for
5	at least three (3) years is immediately eligible to apply for licensure as a
6	licensed clinical psychotherapist with independent practice privileges.
7	(2) The Arkansas Board of Clinical Psychotherapy may grant the
8	applicant independent practice privileges after consideration and evaluation
9	of the applicant's previous statement of intent, experience, training, and
10	adherence to rules of the Arkansas Board of Clinical Psychotherapy.
11	(3)(A) A persons who was granted independent practice privileges
12	by the Arkansas Psychology Board as indicated by statement of dated before
13	December 31, 2005, shall be deemed a licensed clinical psychotherapist with
14	independent practice privileges by the Arkansas Board of Clinical
15	Psychotherapy.
16	(B) Individuals granted practice privileges for
17	neuropsychology and projective personality assessment as indicated by the
18	statement of intent and approved by the Arkansas Psychology Board before
19	October 1, 2004, shall be authorized by the Arkansas Board of Clinical
20	Psychotherapy to continue those practice privileges under the supervision
21	indicated by the statement of intent as licensed clinical psychotherapists or
22	licensed associate clinical psychotherapists approved by the Arkansas
23	Psychology Board before October 2004.
24	(C) No other privileges under this chapter may be granted
25	to persons granted privileges under subdivisions (e)(3)(A) or (e)(3)(B) of
26	this section.
27	
28	17-107-305. Examinations.
29	(a)(1)(A) The Arkansas Board of Clinical Psychotherapy shall
30	promulgate rules for examinations for licensure to practice as a licensed
31	associate clinical psychotherapist.
32	(B) The examination shall include, but not be limited to:
33	(i) Subject matter in the filed of clinical
34	psychotherapy;
35	(ii) Methods of practice of clinical psychotherapy;
36	(iii) Basic psychological sciences; and

1	(iv) Ethics in the practice of clinical
2	psychotherapy.
3	(2) The examinations shall be offered at least one (1) time each
4	year.
5	(3)(A) The examinations may be written, oral, or both.
6	(B) In any written examination, the applicant shall be
7	designated by a number rather than by his or her name so that his or her
8	identity will not be available to the members of the board until the
9	examination has been scored.
10	(4) The board shall:
11	(A) Grade the written examinations returned by the
12	candidate; and (B) Retain the written examinations for a
13	least one (1) year.
14	(b) A candidate shall have passed the examination upon the affirmative
15	vote of three (3) or more members of the board.
16	(c) Upon written request to the board, any unsuccessful candidate may
17	see the candidate's own graded examination.
18	
19	17-107-306. Issuance.
20	(a)(1) The Arkansas Board of Clinical Psychotherapy shall be the sole
21	agency empowered to:
22	(A) Examine candidates concerning competence as a licensed
23	clinical psychotherapist or licensed associate clinical psychotherapist; and
24	(B) Grant licenses for the practice of clinical
25	psychotherapy at the appropriate level.
26	(2)(A) The license shall be signed by the Chair of the Arkansas
27	Board of Clinical Psychotherapy and attested by the Secretary of the Arkansas
28	Board of Clinical Psychotherapy under the seal of the board.
29	(B) After the license is signed and attested to and the
30	seal attached as required in subdivision (a)(2)(B) of this section, the
31	secretary shall issue the license.
32	(b)(1) The board shall issue a provisional license to an applicant who
33	has:
34	(A) Passed the examinations prescribed by the board for
35	provisional licensure;
36	(B) Satisfied the preliminary requirements of §§ 17-107-

1	303 and 17-107-304; and
2	(C) Paid the fee for a provisional license.
3	(2) A provisional license holder is entitled to practice as a
4	licensed associate clinical psychotherapist under the supervision of a
5	qualified supervisor approved by the board.
6	(3) The board shall adopt rules concerning provisional license
7	holders that identify:
8	(A) The activities that provisional license holders may
9	engage in; and
10	(B) Services that may be provided by provisional license
11	holders.
12	(4) The board may refuse to renew the provisional license of a
13	person who does not meet the requirements prescribed by law and rules
14	promulgated by the board.
15	(c)(l) An applicant for examination for a provisional license shall:
16	(A) Apply on forms prescribed by the board; and
17	(B) Submit the required fees with the application.
18	(2) The board may require that the applicant verify the
19	application.
20	(d) An applicant may take an examination for a provisional license if
21	the applicant:
22	(1)(A) Has received a master's degree in psychology or a related
23	field from a regionally accredited educational institution.
24	(B) In determining whether a degree is substantially
25	equivalent to the requirements for licensure, the board shall consider
26	whether at the time the degree was conferred the graduate program met the
27	prevailing standards for training in the area of psychology;
28	(2) Has attained the age of majority;
29	(3) Has good moral character;
30	(4) Is physically and mentally competent to provide
31	psychological services with reasonable skill and safety, as determined by the
32	board;
33	(5) Is not afflicted with a mental or physical disease or
34	condition that would impair the applicant's competence to provide
35	psychological services;
36	(6) Has not pleaded guilty or nolo contendere to, or been found

1	guilty of a crime involving moral turpitude or a felony;
2	(7) Does not use drugs or alcohol to an extent that affects the
3	applicant's professional competence;
4	(8) Has not engaged in fraud or deceit in making the
5	application; and
6	(9) Has not:
7	(A) Aided or abetted the practice of clinical
8	psychotherapy by a person not licensed under this chapter in representing
9	that the person is licensed under this chapter;
10	(B) Represented that the applicant is licensed under this
11	chapter to practice clinical psychotherapy when the applicant is not
12	<u>licensed; or</u>
13	(C) Practiced clinical psychotherapy in this state without
14	a license under this chapter or without being exempt under this chapter.
15	
16	17-107-307. Reciprocity.
17	At its discretion, the Arkansas Board of Clinical Psychotherapy may
18	grant a certificate without an assembled examination to any person residing
19	or employed in the state who:
20	(1)(A) At the time of application is licensed or certified by a
21	similar board of another state whose standards in the opinion of the board
22	are not lower than those required by this chapter; or
23	(B) Has been practicing psychology or related clinical
24	services in another state that has qualifications the board has determined to
25	be not lower than those required by this chapter; and
26	(2) Satisfies the board that to grant him or her a license
27	would:
28	(A) Be in the public interest; and
29	(B) Meet the requirements of the rules promulgated by the
30	board.
31	
32	17-107-308. Professional titles.
33	(a) Except as otherwise provided in this section, no individual or
34	organization, other than those licensed under this chapter, may present
35	himself, herself, or itself to the public or allow himself, herself, or
36	itself to be presented to the public by any title incorporating the name

1	"Licensed Associate Clinical Psychotherapist" or "Licensed Clinical
2	Psychotherapist".
3	(b)(l)(A) Any psychological scientist employed by a research
4	laboratory, college, or university recognized by the Arkansas Board of
5	Clinical Psychotherapy may represent himself or herself by the academic or
6	research title conferred upon him or her by the administration of the
7	laboratory, college, or university.
8	(B) This section does not permit a psychological scientist
9	employed by a research laboratory, college, or university recognized by the
10	board to offer services to any other persons or organizations as consultants
11	or to accept remuneration for any licensed clinical psychotherapy services
12	other than his or her institutional salaries unless he or she has been
13	licensed under this chapter.
14	(2) A visiting lecturer from a laboratory, college, or
15	university recognized by the board is exempt from the provisions of this
16	section and may represent himself or herself by the academic or research
17	title conferred upon him or her by the administration of the laboratory,
18	college, or university when presenting lectures to similar institutions or
19	organizations.
20	(3) Students of psychology, psychological interns, and other
21	persons preparing for the profession of psychologist or licensed associate
22	clinical psychotherapist under qualified supervision in recognized training
23	institutions or facilities may use such titles as "psychological intern,"
24	"psychological trainee," or other titles approved by the board that clearly
25	indicate such a training status.
26	(4)(A) A person who has been certified as a school psychology
27	specialist by the Department of Education may use the title "School
28	Psychology Specialist."
29	(B) A person who uses the title "School Psychology
30	Specialist" may only practice within settings under the purview of the State
31	Board of Education.
32	(c) Nothing in this chapter precludes the practice of psychotherapy by
33	licensed social workers, licensed professional counselors, licensed marriage
34	and family therapists, or other advanced licensed practitioners.
35	

1<u>7-107-309. Annual registration - Failure to reregister.</u>

1	(a)(1) The Arkansas Board of Clinical Psychotherapy may adopt and
2	enforce rules requiring each person licensed by the board to pay an annual
3	registration fee.
4	(2) The board shall set the fee as recommended by the Joint
5	Oversight and Budget Committee.
6	(b) The board shall set the due date for the fee as recommended by the
7	Joint Oversight and Budget Committee.
8	(c)(1) The board shall suspend the right of any person licensed by the
9	board if the person fails to timely pay the annual registration fee.
10	(2) The suspension shall continue until the person pays the fee
11	and any penalty the board may by rule adopt.
12	(d)(1) If any licensee fails for three (3) consecutive years to pay
13	the fee, the board shall, without hearing or notice, cancel his or her
14	license subject to reinstatement.
15	(2) If application for reinstatement is made, the board shall
16	$\underline{\text{consider the moral character and professional qualifications of the applicant}}$

3	and Budget Committee shall be paid as deemed necessary to defray the cost of
4	acquiring and administering the examination test and related expenses in

7	shall be paid to the Chair of the Arkansas Board of Clinical Psychotherapy
8	when the initial license is issued.
9	(c)(1) No part of any fee shall be returnable under any circumstances

11	announced.
12	(2) If the board fails to hold examinations at the time

16	17-107-311. Denial, suspension, revocation, fine, letter of reprimand,
17	or additional education - Grounds - Reinstatement.
18	(a) The Arkansas Board of Clinical Psychotherapy may:

21	(2) Impose a fine of up to five thousand dollars (\$5,000);

7	(c) The board shall refuse to issue a license to or shall revoke the
8	license of any person who has been found guilty of or pleaded guilty or nolo
9	contendere to any of the offenses listed in § 17-107-313(f) unless the person
10	requests and the board grants a waiver pursuant to § 17-107-313(h).
11	(d)(1) If the board receives satisfactory proof that any applicant or
12	licensee has been found guilty of or pleaded guilty or nolo contendere to any
13	of the offenses listed in <i>subsection</i> (b) of this section, the board may
14	refuse to grant a certificate to the applicant or may revoke a license of the
15	licensee upon a vote of three (3) or more members of the board.
16	(2) An application for reinstatement may be made to the board
17	and the board may upon favorable vote by three (3) of its members reinstate
18	the applicant.

20	17-107-312. Denial, suspension, revocation, other penalty -
21	Proceedings.
22	(a)(1)(A) The Arkansas Board of Clinical Psychotherapy may investigate
23	or cause to be investigated any allegation or evidence that appears to show

30	(b) The check shall conform to the applicable federal standards and
31	shall include the taking of fingerprints.
32	(c) The applicant shall sign a release of information to the board and
33	shall be responsible to the Department of Arkansas State Police for the
34	payment of any fee associated with the criminal background check.
35	(d) Upon completion of the criminal background check, the
36	Identification Bureau of the Department of Arkansas State Police shall

(g)(1) The board may issue a six-month nonrenewable letter of 31 32 provisional eligibility for <u>licensure to a first-time applicant pending the</u> 33 results of the criminal background check. 34 (2) Upon receipt of information from the Identification Bureau 35 of the Department of Arkansas State Police that the person holding a letter 36 of provisional licensure has pleaded guilty or nolo contendere to, or been

1	found guilty of, any offense listed in subsection (f) of this section, the
