13	AN ACT TO ESTABLISH THE ARKANSAS RX PROGRAM; AND
14	FOR OTHER PURPOSES.

16	Subtitle
17	AN ACT TO ESTABLISH THE ARKANSAS RX
18	PROGRAM.
19	
20	
21	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22	
23	SECTION 1. Arkansas Code Title 20, Chapter 76 is amended to add an
24	additional subchapter to read as follows:
25	20-76-501. Findings.
26	The General Assembly finds that:
27	(1) Affordability is critical in providing access to
28	prescription drugs for Arkansas residents;
29 30	(2) The state should take steps to:
31	(A) Make prescription drugs more affordable for qualified Arkansas residents; and
31 32	(B) Integrate the program as part of any statewide program
33	for the uninsured;
34	(3) The state should not:
35	(A) Discourage employers from offering or paying for
36	prescription drug benefits for their employees: or

1	(B) Replace employer-sponsored prescription drug benefit
2	plans that provide benefits comparable to those made available to qualified
3	Arkansas residents under this subchapter; and
4	(4) A statewide drug price reduction program will increase the
5	overall health of Arkansas residents, promoting healthy communities, and
6	protecting the public health and welfare.
7	
8	20-76-502. Definitions.
9	As used in this subchapter:
10	(1) "Average wholesale price" means the wholesale price charged
11	on a specific drug that is assigned by the drug manufacturer and is listed in
12	a nationally recognized drug pricing file;
13	(2) "Covered drugs" means drugs that are on the Arkansas Rx
14	Program preferred drug list;
15	(3) "Director" means the Director of the Department of Human
16	Services or his or her designee;
17	(4) "Labeler" means a person or entity that:
18	(A) Receives prescription drugs from a manufacturer or
19	wholesaler and repackages those drugs for later retail sale; and
20	(B) Has a labeler code from the federal Food and Drug
21	Administration under 21 C.F.R. § 207.20, as in effect January 1, 2005;
22	(5) "Participating retail pharmacy" means a participant in the
23	Arkansas Rx Program that is:
24	(A)(i) A retail pharmacy located in this state; or
25	(ii) Another business licensed to dispense prescription
26	drugs in this state.
27	(B) "Participating retail pharmacy" does not mean a mail-
28	order pharmacy;
29	(6) "Preferred drug list" means a list of:
30	(A) Drugs listed as preferred drugs by the Arkansas Medicaid
31	Evidence Based Preferred Drug Program for which a rebate is in effect under the
32	Arkansas RX program; and
33	(B) Drugs that are within pharmaceutical classifications
34	having no listed preferred drug under the Arkansas Medicaid Evidence Based
35	Preferred Drug Program for which a rebate is in effect under the Arkansas RX
36	program: and

1	(7) "Qualified resident" means a resident of the state who:
2	(A) Is not otherwise enrolled in or covered by any
3	prescription drug benefit or insurance plan, including Medicaid and Medicare
4	Part D;
5	(B) Is enrolled in the program; and
6	(C)(i) Is sixty-five (65) years of age or older; or
7	(ii) Has a family income equal to or less than three
8	hundred fifty percent (350%) of the federal poverty level;
9	
10	20-76-503. Program established.
11	(a) Subject to the available funding, the Arkansas Rx Program is
12	established to reduce prescription drug prices and to improve the quality of
13	health care for residents of the state.
14	(b)(1) Subject to the available funding, the Department of Human
15	Services shall administer the program.
16	(2) The department shall use manufacturer rebates and pharmacy
17	discounts to reduce prescription drug prices.
18	(c) The department shall promulgate rules to implement the provisions
19	of this chapter.
20	(d) The department shall seek any waivers of federal law, rule, or
21	regulation necessary to implement the provisions of this subchapter.
22	
23	20-76-504. Rebate agreement.
24	(a) Every drug manufacturer or labeler that sells prescription drugs
25	in this state through any publicly supported pharmaceutical assistance
26	program shall enter into a rebate agreement with the Department of Human
27	Services for participation in the Arkansas Rx Program.
28	(b) The rebate agreement shall require the manufacturer or labeler to
29	make rebate payments to the state each calendar quarter or according to a
30	schedule established by the department.
31	$\underline{(c)(1)}$ A penalty of ten percent (10%) of the total rebate amount shall
32	be assessed for any rebate not paid by the manufacturer or labeler in
33	accordance with subsection (b) of this section or pursuant to terms
34	established by the Director of the Department of Human Services.
35	(2) An additional penalty of five percent (5%) of the total
36	delinquent amount shall be assessed each quarter that delinquent rebates

1	remain unpaid to the state.
2	(d) The director of his or her designee may file suit in Pulaski
3	County Circuit Court to enforce rebate agreements and to collect delinquent
4	rebates and penalties.
5	
6	20-76-505. Rebate amount.
7	(a) The Director of the Department of Human Services shall negotiate
8	the amount of the rebate required from a manufacturer or labeler in
9	accordance with this section.
10	(b) The director shall take into consideration:
11	(1) The rebate calculated under the Medicaid rebate program
12	under 42 U.S.C. § 1396r-8;
13	(2) The average wholesale price of prescription drugs; and
14	(3) Any other available information on prescription drug prices
15	and price discounts.
16	(c) The director shall use his or her best efforts to obtain an
17	initial rebate amount equal to or greater than the rebate calculated under
18	the Medicaid rebate program under 42 U.S.C. § 1396r-8.
19	(d) To assist with the rebate program under this subchapter, the
20	director shall use his or her best efforts to obtain a rebate equal to or
21	greater than the amount of price reduction for prescription drugs provided to
22	the United States government.
23	
24	20-76-506. Discounted prices for qualified residents.
25	Each participating retail pharmacy shall sell covered drugs to
26	qualified residents at the ordinary and customary retail price less any
27	applicable rebate established under this subchapter.
28	
29	20-76-507. Operation of program.
30	(a) Participating retail pharmacies shall disclose to qualified
31	residents the amount of savings provided as a result of the Arkansas Rx
32	Program.
33	(b) The Department of Human Services may not impose transaction
34	charges under the Arkansas Rx Program on participating retail pharmacies that
35	submit claims or receive payments under the program.

(c) A participating retail pharmacy shall submit claims to the

1 department in order to determine the appropriate rebates. 2 (d) On a biweekly basis, the department shall reimburse a 3 participating retail pharmacy for the applicable rebate provided to qualified 4 residents under § 20-76-506. 5 (e) The department shall conduct ongoing quality assurance activities 6 as needed at the discretion of the director. 7 8 20-76-508. Action with regard to nonparticipating manufacturers and 9 labelers. 10 (a) The names of manufacturers and labelers are public information 11 without regard to whether they enter into rebate agreements under this 12 subchapter. (b) The Department of Human Services shall: 13 (1) Release the names of manufacturers and labelers to health 14 15 care providers and the public on a regular basis; and 16 (2) Publicize participation by manufacturers and labelers that 17 is of particular benefit to the public. 18 19 20-76-509. 3	The Department of Human Services shall report the enrollment and
4	financial status of the program to the Legislative Council by October 1 each
5	year.
6	
7	20-76-511. Obligations of department.
8	(a) The Department of Human Services shall:
9	(1) Establish simplified procedures for determining eligibility
10	and issuing Arkansas Rx Program enrollment cards to qualified residents; and
11	(2) Undertake outreach efforts to:
12	(A) Build public awareness of the program; and
13	(B) Maximize enrollment of qualified residents.
14	(b) The department may adjust the requirements and terms of the
15	program to accommodate any new federally funded prescription drug programs.
16	
17	20-76-512. Medical assistance programs.
18	(a) The Department of Human Services shall administer the Arkansas Rx
19	Program in a manner that is advantageous to the program and to the enrollees
20	in the program.
21	(b) In implementing this subchapter the department may:
22	(1) Coordinate other programs of the department with this
23	program; and
24	(2) Provide the benefits of this program to enrollees in other
25	programs of the department.
26	<u>20-76-513. Rules.</u>
27	The department may promulgate such reasonable rules as may be necessary
28	or beneficial to the Arkansas Rx Program.

30	20-76-513. Implementation.
31	The Department of Human Services shall begin offering Arkansas Rx
32	Program drug benefits under this subchapter on February 1, 2006 and shall
33	immediately make all best efforts to:
34	(1) Enroll eligible participants;
35	(2) Publicize and promote the Arkansas Rx Program;
36	(3) Negotiate relates with manufacturers.

1	(4) Enroll participating pharmacies; and
2	(5) Promulgate all rules necessary to administer the Arkansas Rx

5	20-27-514. Fee.
6	Participating residents shall pay a twenty-five dollars (\$25.00) fee annually
