20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
21

22 SECTION 1. Arkansas Code § 14-54-302 is amended to read as follows:  
23 14-54-302. Purchase, lease, and sale authorized.

24 (a) Municipal corporations are empowered and authorized to buy, sell,  
25 convey, lease, rent, or let any real estate or personal property ~~owned or~~  
26 ~~controlled by the municipal corporations. This power and authorization shall~~  
27 ~~extend and apply to all such real estate and personal property, including~~  
28 ~~that which is held by the municipal corporation for public or governmental~~  
29 ~~uses and purposes.~~

30 (b) Municipal corporations are also empowered and authorized to donate  
31 property, or any part thereof, to the federal government or any agency  
32 thereof, for any one (1) or more of the following purposes. Having the real  
33 estate, personal property, or both, activated, reactivated, improved, or  
34 enlarged by the donee, the municipal corporation may donate the fee simple  
35 title and absolute interest, without any reservations or restrictions, in and  
36 to all real estate, personal property, or both, or any part of the property,



1 to the federal government, if this property was previously conveyed, or  
2 otherwise transferred, by the federal government to the municipal  
3 corporation, without cost to the municipal corporation. All other donation  
4 instruments shall contain provisions by which the title to the property  
5 donated shall revert to the municipal corporation when the donated property  
6 is no longer used by the donee for the purposes for which it was donated.

7 (c) The execution of all contracts and conveyances and lease contracts  
8 shall be performed by the mayor and city clerk or recorder, when authorized  
9 by a resolution, in writing, approved by a majority vote of the city council  
10 present and participating.
