19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
20

21 SECTION 1. Arkansas Code § 17-26-309 is amended to read as follows:

22 17-26-309. Examination for cosmeticians or cosmetologists.

23 Examinations for certificates of registration and license as  
24 cosmeticians or cosmetologists shall include both a written test and a  
25 practical test that include all phases of cosmetology as deemed necessary by  
26 the State Board of Cosmetology to protect the health, safety, and welfare of  
27 the public.

28 ~~(1) Practical demonstrations in shampooing the hair,~~  
29 ~~hairecutting, hairdressing, permanent waving, wet hairdressing, water waving,~~  
30 ~~hair coloring, manicuring, and facial and scalp massage with the hands; and~~

31 ~~(2) Written and oral tests in antiseptics, sterilization,~~  
32 ~~sanitation, and the use of mechanical apparatus and electricity as applicable~~  
33 ~~to the practice of the occupations of a cosmetician or cosmetologist.~~

35 SECTION 2. Arkansas Code § 17-26-310 is amended to read as follows:

36 17-26-310. Failure to appear for examination.



1 (a) Any applicant who without good cause fails to appear for  
2 examination within one (1) year after being notified by the State Board of  
3 Cosmetology of his or her eligibility ~~therefor~~ may be removed from the list  
4 of eligible applicants for examination. The applicant ~~shall forfeit his or~~  
5 ~~her examination fee and~~ may again become eligible only upon filing a new  
6 application and paying a new examination fee.

7 (b) However, any person whose failure to appear for examination is due  
8 to service in any branch of the armed forces of the United States, upon  
9 application made not later than one (1) year from the date of discharge or  
10 return to inactive military status and upon the filing of an affidavit  
11 showing the date of entrance into service and whether still in service or the  
12 date of discharge or return to inactive status, shall be restored to the  
13 eligible list and permitted to take the examination ~~without payment of~~  
14 ~~further examination fee.~~
