9 AN ACT TO ALLOW THE STATE REPRESENTATIVE OF A
10 SCHOOL DISTRICT OR PORTION OF A SCHOOL DISTRICT
11 TO PETITION FOR A CHANGE IN THE BOUNDARIES OF THE
12 SCHOOL DISTRICT AND THE ADJOINING SCHOOL
13 DISTRICT; AND FOR OTHER PURPOSES.

Subtitle

15 AN ACT TO ALLOW THE STATE REPRESENTATIVE
16 OF A SCHOOL DISTRICT OR PORTION OF A
17 SCHOOL DISTRICT TO PETITION FOR A CHANGE
18 IN THE BOUNDARIES OF THE SCHOOL DISTRICT
19 AND THE ADJOINING SCHOOL DISTRICT.

23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
24

25 SECTION 1. Arkansas Code Title 6, Chapter 13, Subchapter 12 is amended
26 to add an additional section to read as follows:

27 6-13-1211. Boundary change by the State Board of Education.

28 (a)(1) The State Board of Education shall consider a petition that
29 seeks an adjustment or change of boundary lines between adjoining school
30 districts and that is presented by all the state representatives and state
31 senators whose districts contain any area affected by the proposed adjustment
32 or change.

33 (2) The petition shall:

34 (A) Be signed by all the state representatives and state
35 senators whose districts contain any area affected by the proposed adjustment
36 or change;



1 (B) Include a description of the boundaries of the area to
2 be moved to a different school district; and

3 (C) Include a statement of the geographic features,
4 including, without limitation, terrain, roads, and distances to schools that
5 cause it to be in the best interest of the students of the area for the
6 boundaries to be adjusted.

7 (3) The petition shall be filed with the state board no earlier
8 than January 1 and no later than March 1 in any calendar year.

9 (b) Upon receipt of the petition, the state board shall:

10 (1) Cause public notice to be published in a local newspaper of
11 general circulation in each affected school district no less than once a week
12 for two (2) consecutive weeks; and

13 (2)(A) Provide a copy of the public notice to the boards of
14 directors of the affected school districts by registered mail or by certified
15 mail with return receipt requested.

16 (B) The notice to the boards of directors of the affected
17 school districts shall be made at least ten (10) days before a regularly
18 scheduled meeting of each board of directors.

19 (c) The petition shall be presented for hearing before the state board
20 at the first regularly scheduled meeting occurring after April 1 of the year
21 in which the petition was filed.

22 (d)(1) If the state board determines that due to geographic features
23 the proposed change in boundaries is in the best interest of the students of
24 the area, the state board may, by approval of a majority of the members of a
25 quorum present of the state board, issue an order changing or adjusting the
26 boundary lines between the adjoining districts.

27 (2) Before approving a boundary change, the state board shall
28 consider:

29 (A) Whether the change will result in identifiable
30 boundaries; and

31 (B) The financial consequences of the proposed boundary
32 change, including the impact of the proposed boundary change on all debt
33 service obligations of the affected districts.

34 (3) The state board shall not order any change in school
35 district boundaries which hampers, delays, or in any manner negatively
36 affects the desegregation efforts of the public school districts in the State

1 of Arkansas.

2 (4) The state board shall not order any change in school
3 district boundaries which negatively impacts the debt service obligations of
4 any affected school district.

5
6 (e) A change or adjustment in boundary lines approved under this
7 section shall be effective on July 1 of the year in which the petition was
8 filed.

9 (f)(1) Upon an order from the state board to change or adjust boundary
10 lines, the state board shall file the order with the county clerk in each
11 county in which every affected school district lies.

12 (2) The county clerk shall make a permanent record of the order.
13 After the county clerk enters the order, the boundaries established in the
14 order shall be the boundaries of the affected districts until changes are
15 made according to the provisions of law.

16 (g) Upon an order from the state board to change or adjust boundary
17 lines, the Department of Education shall make changes in the maps of the
18 school districts of the county to show the changes of boundaries.
