22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
23

24 SECTION 1. Arkansas Code § 8-6-901 is amended to read as follows:
25 8-6-901. Definitions.

26 As used in this subchapter, unless the context otherwise requires:

27 (1) "Commission" means the Arkansas Pollution Control and
28 Ecology Commission;

29 (2) "Department" means the Arkansas Department of Environmental
30 Quality;

31 (3) "Director" means the Director of the Arkansas Department of
32 Environmental Quality or the director's delegate or representative;

33 (4) "Illegal dumps control officer" means an individual employed
34 by a duly authorized solid waste management district within this state, a
35 county government within this state, or a pollution control inspector or
36 other representative of the department who is empowered to ensure compliance



1 with any state law prohibiting the illegal dumping of solid wastes;

2 (5) "License" means a certificate of competency issued by the
 3 director to solid waste management facility operators and illegal dumps
 4 control officers who have met the requirements of the licensing program;

5 (6) "Licensing committee" means the committee of solid waste
 6 management facility managers, operators, or technicians hereinafter
 7 established to assist and advise the commission and the department in the
 8 examining and licensing of operators of solid waste management facilities;

9 (7)(A) "Operator" means any person who performs operation of a
 10 solid waste management facility requiring individual judgment which may
 11 directly affect the proper operation of the solid waste management facility.

12 (B) "Operator" shall not be deemed to include an official
 13 solely exercising general administrative supervision;

14 (8) "Operator-in-training" means an employee of a solid waste
 15 management facility who has been issued an apprenticeship license by the
 16 director;

17 (9) "Provisional certificate" means a document issued to an
 18 operator by the director allowing an individual to operate at a facility
 19 while working to fulfill the licensing requirements;

20 (10)(A) "Recovered materials" means:

- 21 (i) Metal;
- 22 (ii) Paper;
- 23 (iii) Glass;
- 24 (iv) Plastic;
- 25 (v) Textiles;
- 26 (vi) Yard trimmings not destined for composting; or
- 27 (vii) Rubber materials which are not waste tires or

28 waste tire residuals; that have known recycling potential, can be feasibly
 29 recycled, and have been diverted and source-separated or have been removed
 30 from the solid waste stream for sale, use, or reuse as raw materials, whether
 31 or not the materials require subsequent processing or separation from each
 32 other, but does not include materials destined for any use that constitutes
 33 disposal.

34 (B) For the purpose of this subchapter, recovered
 35 materials, as described in subdivision (10)(A) of this section, are not solid
 36 waste;

1 (11) "Sanitary landfill" means any place for which a permit for
 2 disposal of solid waste on land is required under the provisions of this
 3 chapter;

4 (12)(A) "Solid waste disposal facility" means any place at which
 5 solid waste is dumped, abandoned, or accepted or disposed of for final
 6 disposition by incineration, landfilling, composting, or other method.

7 (B) Wastewater treatment plants permitted under the
 8 National Pollutant Discharge Elimination System and units at hazardous waste
 9 management facilities permitted under the Arkansas Hazardous Waste Management
 10 Act, § 8-6-201 et seq., and this Code shall not be deemed to be disposal
 11 sites or facilities for the purpose of this subchapter; and

12 (13)(A) "Solid waste management facility" means all contiguous
 13 land and structures, other appurtenances, and improvements on the land used
 14 for storage, collection, transportation, processing, treatment, and/or
 15 disposal of solid waste.

16 (B)(i) For purposes of this subchapter, facilities engaged
 17 solely in the recycling of source-separated materials are excluded.

18 (ii) Also excluded are processes, operations, and/or
 19 facilities that are regulated pursuant to hazardous waste rules and
 20 regulations which are not regulated pursuant to solid waste rules and
 21 regulations.

22
 23 SECTION 2. Arkansas Code § 8-6-904(a) and (b), establishing the
 24 licensing committee of the Arkansas Pollution Control and Ecology Commission
 25 and the Arkansas Department of Environmental Quality, are amended to read as
 26 follows:

27 (a)(1) There is created and established a licensing committee to
 28 advise and assist the Arkansas Pollution Control and Ecology Commission and
 29 the Arkansas Department of Environmental Quality in the administration of the
 30 licensing program, ~~which shall be composed of ten (10) members.~~

31 (2) The committee shall be composed of ten (10) voting members
 32 as follows:

33 ~~(1)(A)~~ Three (3) members, to be appointed by the
 34 commission, shall be solid waste management facility operators licensed by
 35 the department;

36 ~~(2)(B)~~ One (1) member, to be appointed by the commission,

1 shall be an employee of a county operating a ~~sanitary landfill~~ solid waste
 2 management facility who holds the position of ~~landfill~~ solid waste management
 3 facility on-site operator or supervisor;

4 ~~(3)(C)~~ One (1) member, to be appointed by the commission,
 5 shall be an employee of a municipality operating a sanitary landfill who
 6 holds the position of landfill on-site operator or supervisor;

7 ~~(4)(D)~~ One (1) member, to be appointed by the commission,
 8 shall be a representative of one (1) of the duly constituted regional solid
 9 waste management boards;

10 ~~(5)(E)~~ One (1) member, to be appointed by the commission,
 11 shall be an on-site operator or supervisor of a waste tire processing
 12 facility;

13 ~~(6)(F)~~ One (1) member, to be appointed by the commission,
 14 shall be an on-site operator or supervisor of a nonsegregated materials
 15 recovery, transfer, or composting facility;

16 ~~(7)(G)~~ One (1) member, to be appointed by the commission
 17 ~~and to serve ex officio with no vote~~, shall be a faculty member of or other
 18 qualified person associated with an accredited college, university, or
 19 professional school in this state whose major field is related to
 20 environmental education; and

21 ~~(8)(H)~~ One (1) member, to be appointed by the Director of
 22 the Arkansas Department of Environmental Quality, shall be a qualified member
 23 of his staff who shall serve ex officio with no vote as executive secretary
 24 of the licensing committee.

25 (b)(1) ~~The committee members who do not serve ex officio shall serve~~
 26 ~~five-year terms and until their successors have been appointed.~~

27 ~~(2)~~ In the event of a vacancy, a new member shall be appointed
 28 by the commission to serve out the unexpired term.

29 ~~(3)(2)(A) No voting~~ As of the effective date of this subdivision
 30 (b)(2)(A), no nonstate agency member shall serve more than two (2)
 31 consecutive five-year terms three-year terms.

32 (B) Those members serving unexpired five-year terms may
 33 serve an additional one (1) consecutive three-year term.

 35 SECTION 3. Arkansas Code § 8-6-905 is amended to read as follows:

36 8-6-905. ~~Rules and regulations Administration Enforcement Duties~~

1 Power and duties.

2 (a) The Arkansas Pollution Control and Ecology Commission, with the
 3 advice and assistance of the licensing committee, is given and charged with
 4 the power and duty to adopt rules and regulations implementing and
 5 effectuating such powers and duties of the Arkansas Department of
 6 Environmental Quality and the licensing committee under this subchapter as
 7 may be necessary for the administration and enforcement thereof.

8 (b) The department is charged with the responsibility of administering
 9 and enforcing this subchapter, with the advice and assistance of the
 10 licensing committee, and is given and charged with the following powers and
 11 duties:

12 (1)(A) To conduct examinations for licensing, which shall be
 13 held at least annually and more frequently as the commission shall deem
 14 necessary.

15 (B) This duty may be delegated by the department to the
 16 administrator of any approved course;

17 (2) To issue licenses to qualified solid waste management
 18 facility operators and qualified illegal dumps control officers, to renew
 19 those licenses, to suspend or revoke the licenses for cause after due notice
 20 and opportunity for hearing, to issue one-year apprenticeship licenses to
 21 operators-in-training, and to issue provisional certificates; and

22 (3) To initiate enforcement actions and/or institute court
 23 proceedings to compel compliance with the provisions of this subchapter and
 24 rules and regulations issued pursuant thereto.

25 (c) The licensing committee shall:

26 (1) Conduct inquiries and establish findings necessary to advise
 27 the commission and the department on irregularities encountered in the
 28 management of the licensing program;

29 (2) Conduct inquiries and establish facts necessary to advise
 30 the commission and the department on the actions of licensees; and

31 (3) Recommend administrative sanctions, including, but not
 32 limited to, the suspension and revocation of licenses as necessary to promote
 33 the professional integrity of solid waste licensees.
