22 SECTION 1. Arkansas Code § 21-6-402 is amended to read as follows:
23 21-6-402. Circuit court clerks - Miscellaneous fees.

24 (a) Except as provided in subsection (b) of this section, The the fees
25 for clerks of circuit courts in this state shall be as follows:

- 26 (1) For drawing and issuing, sealing any summons, subpoena.....
- 27 \$.2.50
- 28 (2) For taking and entering a bond, civil or criminal60
- 29 (3) For every motion, rule, answer, interrogatories, or other
- 30 miscellaneous filings60
- 31 (4) For entering every order or decree 2.00
- 32 (5) For entering each judgment 3.00
- 33 (6) For swearing jury 2.00
- 34 (7) For trial before court 1.00
- 35 (8) For scire facias 15.00
- 36 (9) For writs or executions 10.00



- 1 (10) For certificate and seal 2.00
- 2 (11) For each page in making and preparing any transcript. 1.50
- 3 (12) For indexing each page10
- 4 (13) For certifying costs 1.00
- 5 (14) For issuing juror or witness certificates50

6 (b) The fees to be charged by the circuit court clerks of this state
 7 to the Department of Finance and Administration shall be as follows:

- 8 (1) For filing a certificate of indebtedness issued by the
 9 Department of Finance and Administration \$8.00
- 10 (2) For filing a release of a certificate of indebtedness . 6.00
- 11 (3) For an execution on a certificate of indebtedness filed by
 12 the Department of Finance and Administration 10.00
