26	SECTION 3. EMERGENCY CLAUSE. It is found and determined by the	
27	General Assembly of the State of Arkansas that the purchasers of new motor	
28	vehicles are being charged fees for the preparation of documents related to	
29	the sale of a new motor vehicle that exceed a reasonable amount for this	
30	service; that the Arkansas Motor Vehicle Commission has refused to set a	
31	reasonable documentary fee; and that this act is immediately necessary to	
32	protect consumers who purchase new cars from being charged excessive	
33	documentary fees. Therefore, an emergency is declared to exist and this act	
34	being immediately necessary for the preservation of the public peace, health,	
35	and safety shall become effective on:	
36	(1) The date of its approval by the Governor;	

1	(2) If the bill is helther approved not veloced by the governor,
2	the expiration of the period of time during which the Governor may veto the
3	bill; or
4	(3) If the bill is vetoed by the Governor and the veto is
5	overridden, the date the last house overrides the veto.
