19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code § 19-4-1402 is amended to read as follows:

22 (a) Executed counterparts of all contracts entered into by any state
23 agency with respect to proposed projects for new improvements or major
24 repairs or additions to existing buildings and facilities shall be filed with
25 the Arkansas State Building Services Authority prior to the issuance of any
26 vouchers making payments under ~~any such~~ the contract, unless the contract is
27 exempted from the jurisdiction of the Arkansas ~~State Building Services~~
28 Authority by any law or a regulation promulgated pursuant to the Arkansas
29 Administrative Procedure Act, § 25-15-201 et seq.

30 (b)(1) The Boards of Trustees of the University of Arkansas, Arkansas
31 State University, University of Central Arkansas, Henderson State University,
32 Arkansas Tech University, and Southern Arkansas University, respectively, are
33 exempt from the requirements of this section requiring the filing of ~~such~~ the
34 contracts with the Arkansas ~~State Building Services~~ Authority.

35 ~~(2)(A)(2)~~ (2) The governing boards of all other public institutions
36 of higher education shall be exempt from filing ~~such~~ the contracts with the



1 Arkansas State Building Services Authority;

2 (A) ~~upon~~ Upon approval of the Department of Higher
3 Education; and

4 (B) ~~Provided, that~~ If prior to granting ~~such~~ approval, the
5 department shall have reviewed and approved policies and procedures adopted
6 by the governing boards of the institutions with respect to bidding and
7 construction of capital improvement projects.

8 (3) Nothing in this section shall prevent ~~any of the foregoing~~
9 ~~institutions exempt from filing such contracts with Arkansas State Building~~
10 ~~Services~~ an institution exempt under this subsection (b) from entering into
11 an agreement with the Arkansas State Building ~~Services~~ Authority to file ~~such~~
12 ~~its~~ contracts with ~~it~~ the authority.

13 (c)(1) All contracts for new improvements or major repairs or
14 additions to existing buildings and facilities under this subchapter shall
15 include a project disclosure statement prepared by the agency, board,
16 commission, or institution of higher education.

17 (2) The disclosure statement shall provide the estimated
18 timeline, scope, and cost of the total project.

19 (3) The disclosure statement shall not be construed as
20 authorizing any:

21 (A) Additional work which is beyond the scope of the bid
22 documents; or

23 (B) Payment exceeding the contract amount.

24 (d) Nothing in this section shall prohibit any agency, board,
25 commission, or institution of higher education from executing contract
26 amendments.
