## For An Act To Be Entitled

10 AN ACT TO CREATE AN ADDITIONAL CIRCUIT JUDGESHIP  
11 IN THE SECOND JUDICIAL DISTRICT; TO PROVIDE FOR  
12 THE APPOINTMENT AND ELECTION OF THE CIRCUIT  
13 JUDGE; AND FOR OTHER PURPOSES.

## Subtitle

15 AN ACT TO CREATE AN ADDITIONAL CIRCUIT  
16 JUDGESHIP IN THE SECOND JUDICIAL  
17 DISTRICT AND TO PROVIDE FOR THE  
18 APPOINTMENT AND ELECTION OF THE CIRCUIT

23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

24  
25 SECTION 1. Arkansas Code § 16-13-1003, concerning judges of the Second  
26 Judicial District, is amended to add an additional subsection to read as  
27 follows:

28 (e)(1) There is created in the Second Judicial District an additional  
29 circuit judgeship that shall have jurisdiction in law, equity, probate, and  
30 juvenile matters.

31 (2) The Governor shall appoint a qualified person who is a  
32 resident of the district to temporarily fill the Second Judicial District  
33 circuit judgeship created by this subsection (e), and the appointed person  
34 shall serve until December 31, 2006, or until a successor has been elected  
35 and qualified.

36 (3)(A) The qualified electors of the district shall elect the



1 additional circuit judge created by this subsection (e) at the November 2006  
 2 general election to take office on January 1, 2007.

3 (B) The additional judge shall be elected from the  
 4 district, shall satisfy the same qualifications for holding office, and shall  
 5 receive the same salary, expenses, and other allowances as provided by law  
 6 for judges of the circuit courts.

7 (C) The judge shall serve for elected terms of six (6)  
 8 years.

9 (4) The counties which comprise the Second Judicial District  
 10 shall provide courtroom and office facilities and supplies for the judge of  
 11 the circuit judgeship created by this subsection (e), which shall be paid out  
 12 of the county treasuries in the same manner as other demands against the  
 13 counties and out of funds appropriated by the respective quorum courts of the  
 14 counties for these purposes.

15 (5) There shall be provided for the judge of the circuit  
 16 judgeship created by this subsection (e), a court reporter and a trial court  
 17 administrative assistant whose salaries shall be fixed and paid in the manner  
 18 provided by law for court reporters and trial court administrative assistants  
 19 of the circuit courts of this state.

20  
 21 SECTION 2. EMERGENCY CLAUSE. It is found and determined by the  
 22 General Assembly of the State of Arkansas that the Judicial Resources  
 23 Assessment Committee has reviewed the caseloads of the various judicial  
 24 districts; that the caseload of the Second Judicial District necessitates the  
 25 appointment of an additional circuit judge; and that this act is immediately  
 26 necessary to ensure the smooth, efficient, and timely administration of  
 27 justice in the counties affected. Therefore, an emergency is declared to  
 28 exist and this act being immediately necessary for the preservation of the  
 29 public peace, health, and safety shall become effective on:

30 (1) The date of its approval by the Governor;

31 (2) If the bill is neither approved nor vetoed by the Governor,  
 32 the expiration of the period of time during which the Governor may veto the  
 33 bill; or

34 (3) If the bill is vetoed by the Governor and the veto is  
 35 overridden, the date the last house overrides the veto.
