SECTION 1. Arkansas Code Title 20, Chapter 76 is amended	to add an

3	20-76-502. Definitions.
4	As used in this subchapter:
5	(1) "Average wholesale price" means the wholesale price charged
6	on a specific drug that is assigned by the drug manufacturer and is listed in
7	a nationally recognized drug pricing file;
8	(2) "Covered drugs" means drugs that are on the Arkansas
9	Affordable Rx Program preferred drug list;
10	(3) "Labeler" means a person or entity that:
11	(A) Receives prescription drugs from a manufacturer or
12	wholesaler and repackages those drugs for later retail sales; and
13	(B) Has a labeler code from the Food and Drug
14	Administration under 21 C.F.R. § 207.20, as in effect January 1, 2005;
15	(4)(A) "Participating retail pharmacy" means a participant in
16	the Arkansas Affordable Rx Program that is:
17	(i) A retail pharmacy located in this state; or
18	(ii) Another business licensed to dispense
19	prescription drugs in this state.
20	(B) "Participating retail pharmacy" may include a mail-
21	order pharmacy; and
22	(5) "Qualified resident" means a resident of the state who:
23	(A) Is not otherwise enrolled in or covered by any
24	prescription drug benefit or insurance plan, including Medicaid and Medicare
25	Part D;
26	(B) Is enrolled in the program; and
27	(C)(i) Is sixty-five (65) years of age or older; or
28	(ii) Has a family income equal to or less than three
29	hundred fifty percent (350%) of the federal poverty level;
30	
31	20-76-503. Program established.
32	(a) The Arkansas Affordable Rx Program is established to reduce
33	prescription drug prices to eligible Arkansans and to improve the quality of
34	health care for residents of the state.
35	(b) The Department of Human Services shall administer the program.
36	(c) The department shall seek any waivers of federal law, rule, or

1	regulation necessary to implement the provisions of this subchapter.
2	(d) The program shall not be implemented unless sufficient funding is
3	available.
4	
5	20-76-504. Development of program.
6	(a) In implementing the Arkansas Affordable Rx Program, the Director
7	of the Department of Human Services shall utilize risk management and cost
8	containment principles to obtain the lowest possible prescription drug costs
9	to qualified residents and the program.
10	(b) The director may in consultation with the Drug Utilization and
11	Evaluation Subcommittee of the State and Public School Life and Health
12	Insurance Board:
13	(1) Contract to create a list of covered drugs and negotiate
14	pharmaceutical prices with manufacturers and labelers for the benefit of
15	participating members and pharmacies;
16	(2) Develop reasonable participating retail pharmacy
17	reimbursement rates based upon average wholesale prices or other available
18	information and including payment of a dispensing fee;
19	(3) Either independently or in combination with a state
20	preferred drug list implement cost-saving measures for pharmaceutical
21	services, including, but not limited to, tiered co-payments, reference
22	pricing, prior authorization, step therapy requirements, exclusion from
23	coverage of drugs or classes of drugs, mandating the use of generic drugs,
24	and mandating the use of therapeutic equivalent drugs; and
25	(4) Enter into agreements with a pharmacy benefits manager,
26	pharmacy benefits consultant, or other private entities to design, implement
27	manage, or audit the program.
28	
29	20-76-505. Operation of program.
30	(a) Participating retail pharmacies shall disclose to qualified
31	residents the amount of savings provided as a result of the Arkansas
32	Affordable Rx Program.
33	(b) The Department of Human Services may not impose transaction
34	charges under the Arkansas Affordable Rx Program on participating retail
35	pharmacies that submit claims or receive reimbursements under the program.
36	(c) A participating retail pharmacy shall submit claims for

1	rembursement to the department of an entity contracting with the department
2	to provide pharmacy benefits management.
3	(d) On a biweekly basis, the department shall pay a participating
4	retail pharmacy applicable reimbursement rates for prescription drugs
5	dispensed to qualified residents and a dispensing fee established by the
6	department.
7	(e) The department shall conduct ongoing quality assurance activities
8	as needed at the discretion of the director of the department.
9	
10	20-76-506. Annual summary report.
11	The Department of Human Services shall report the enrollment and
12	financial status of the program to the Legislative Council by October 1 each
13	year.
14	
15	20-76-507. Obligations of department.
16	(a) The Department of Human Services shall:
17	(1) Establish simplified procedures for determining eligibility
18	and issuing Arkansas Affordable Rx Program enrollment cards to qualified
19	residents; and
20	(2) Undertake outreach efforts to:
21	(A) Build public awareness of the program; and
22	(B) Maximize enrollment of qualified residents.
23	(b) The department may adjust the requirements and terms of the
24	program to accommodate any new federally funded prescription drug programs.
25	
26	20-76-508. Medical assistance programs.
27	(a) The Department of Human Services shall administer the Arkansas
28	Affordable Rx Program in a manner that is advantageous to the program and to
29	the enrollees in the program.
30	(b) In implementing this subchapter the department may:
31	(1) Coordinate other programs of the department with this
32	program; and
33	(2) Provide the benefits of this program to enrollees in other
34	programs of the department.
35	
36	20-76-509 Implementation

1	Subject to available funding and federal law, the Department of Human
2	Services shall begin offering Arkansas Affordable Rx Program drug benefits
3	under this subchapter on February 1, 2006 and shall immediately make all best
4	efforts to:
5	(1) Enroll eligible participants;
6	(2) Publicize and promote the Arkansas Affordable Rx Program;
7	(3) Enroll participating retail pharmacies; and
8	(4) Promulgate all rules necessary to administer the Arkansas
9	Affordable Rx Program.
10	
11	20-27-510. Fee.
12	Participating residents shall pay an annual fee of twenty-five dollars
13	(\$25.00) to participate in the Arkansas Affordable Rx Program.
