## For An Act To Be Entitled

10 AN ACT TO AUTHORIZE THE ARKANSAS STATE GOLF  
11 ASSOCIATION LICENSE PLATE; AND FOR OTHER  
12 PURPOSES.

### Subtitle

15 TO AUTHORIZE THE ARKANSAS STATE GOLF  
16 ASSOCIATION LICENSE PLATE.  
17

18  
19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
20

21 SECTION 1. Arkansas Code Title 27, Chapter 15 is amended to add an  
22 additional subchapter to read as follows:

23 27-15-4901. Arkansas State Golf Association license plate authorized.  
24 The Director of the Department of Finance and Administration shall  
25 provide for and issue Arkansas State Golf Association special license plates  
26 in the manner and subject to the conditions under this subchapter.  
27

28 27-15-4902. Design – Numbered plates.

29 (a)(1) The Arkansas State Golf Association special license plates  
30 shall be designed by the Arkansas State Golf Association.

31 (2) The design shall be submitted to the Director of the  
32 Department of Finance and Administration for design approval under rules of  
33 the director.

34 (3) The association may periodically submit a newly designed  
35 license plate for approval and issuance by the director with not more than  
36 one (1) new license plate design issued per calendar year.



1           (b)(1) Upon approval of the design by the director, the association  
 2 shall remit to the department a fee in the amount of six thousand dollars  
 3 (\$6,000) to cover the cost of the initial order of each newly designed  
 4 license plate.

5           (2) This fee shall be deposited into the State Central Services  
 6 Fund for the benefit of the Revenue Division of the Department of Finance and  
 7 Administration and shall be credited as supplemental and in addition to all  
 8 other funds as may be deposited for the benefit of the division.

9           (3) The fee shall not be considered or credited to the division  
 10 as direct revenues.

11           (c) The director shall promulgate reasonable rules and regulations and  
 12 prescribe any forms as the director determines to be necessary to carry out  
 13 the intent and purposes of this subchapter.

14  
 15           27-15-4903. Application for special Arkansas State Golf Association  
 16 license plate – Fee – Disposition of fee.

17           (a) Any motor vehicle owner may apply for and renew annually an  
 18 Arkansas State Golf Association special license plate.

19           (b)(1) Upon payment of the fee required by law for registration of the  
 20 motor vehicle, payment of twenty-five dollars (\$25.00) to cover the design-  
 21 use contribution, and payment of an additional handling and administrative  
 22 fee of ten dollars (\$10.00) for the special license plate, the Department of  
 23 Finance and Administration shall issue to the vehicle owner a special license  
 24 plate that bears the approved design.

25           (2)(A) The handling and administrative fee of ten dollars  
 26 (\$10.00) shall be deposited into the State Central Services Fund for the  
 27 benefit of the Revenue Division of the Department of Finance and  
 28 Administration and shall be credited to the division as supplemental and in  
 29 addition to all other funds as may be deposited for the benefit of the  
 30 division.

31           (B) The handling and administrative fee shall not be  
 32 considered or credited to the division as direct revenue.

33           (3) The design-use contribution of twenty-five dollars (\$25.00)  
 34 shall be remitted monthly to the association to be used for association  
 35 purposes.

1           27-15-4904. Renewal.

2           (a)(1) Arkansas State Golf Association special license plates issued  
3 under this subchapter may be renewed annually under the procedures set out in  
4 § 27-15-4903 either in person, by mail, or by facsimile under §§ 27-14-1012  
5 and 27-14-1013.

6           (2) Registration may continue from year to year as long as the  
7 license is renewed each year within the time and manner required by law.

8           (b)(1) A motor vehicle owner who was previously issued a plate with a  
9 design authorized by this subchapter and who does not pay a design-use  
10 contribution of twenty-five dollars (\$25.00) at a subsequent time of  
11 registration shall be issued a new plate, as otherwise provided by law, that  
12 does not bear the design.

13           (2) Upon expiration, the special license plate may be replaced  
14 with a conventional license plate, a personalized license plate, or a new  
15 special license plate.

16  
17           27-15-4905. Transfer to another vehicle.

18           Arkansas State Golf Association special license plates issued under  
19 this subchapter may be transferred from one (1) vehicle to another under  
20 § 27-14-914.

21  
22           27-15-4906. Compliance with other laws.

23           The Arkansas State Golf Association special license plates shall comply  
24 with all other state motor vehicle laws relating to registration and  
25 licensing of motor vehicles, including the minimum number of license plate  
26 applications required under § 27-15-4004, except as specifically provided  
27 otherwise in this subchapter.
