22	Council shall serve two-year terms and may be reappointed.
23	(c)(1) The House of Representatives and Senate cochairs of the
24	Legislative Council shall call the first meeting of the Community Services
25	Oversight and Planning Council within sixty (60) days of the effective date
26	of this subchapter.
27	(2) The House of Representatives and Senate cochairs of the
28	Legislative Council shall appoint a chair and vicechair from among the
29	members of the Community Services Oversight and Planning Council.
30	(d) The Community Services Oversight and Planning Council shall:
31	(1) Set the date, place, and time of meetings as necessary to

8	(a)(1) The Community Services Oversight and Planning Council shall
9	gather information and data regarding the community-based service needs of
10	citizens with developmental disabilities, behavioral health service needs,
11	aging services needs and youth services needs that are to be delivered by
12	community-based programs operated by licensed providers through contractual
13	relationships with the State of Arkansas.
14	(2) The Department of Human Services and service providers
15	operating under contract with the State of Arkansas shall provide to the
16	Community Services Oversight and Planning Council on request information
17	regarding service needs and funding to meet the needs of individual through
18	community-based options.
19	(3) This information and data shall be the basis for
20	recommendations for community-based service budget appropriations, special
21	language, and funding for the community-based programs.
22	(b) The Community Services Oversight and Planning Council shall report
23	at least quarterly to the Legislative Council and the Joint Budget Committee
24	(c) In deliberations concerning the department's proposed budget, the
25	Legislative Council or the Joint Budget Committee shall take into
26	consideration the recommendations of the Community Services Oversight and
27	Planning Council.
