17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
18

19 SECTION 1. Arkansas Code Title 20, Chapter 76 is amended add a new
20 subchapter to read as follows:

21 20-76-501. Community Services Oversight and Planning Council --
22 Created -- Duty.

23 (a) There is created the Community Services Oversight and Planning
24 Council.


25 (b) The council shall serve in an advisory capacity to the Legislative
26 Council and to the Joint Budget Committee.
27

28 20-76-502. Community Services Oversight and Planning Council --
29 Membership.

30 (a) The Community Services Oversight and Planning Council shall be
31 composed of the following eleven (11) members appointed by the Legislative
32 Council as follows:

33 (1) Three (3) members of the Senate recommended by the President
34 Pro-Tempore of the Senate;

35 (2) Three (3) members of the House of Representatives
36 recommended by the Speaker of the House of Representatives; and



1 (3) Five (5) members to be appointed by the House of
2 Representatives and Senate cochairs of the Legislative Council as follows:

3 (A) Two (2) providers of community-based developmental
4 disability services licensed by the Division of Developmental Disability
5 Services of the Department of Human Services appointed as follows:

6 (i) One (1) member to represent the Developmental
7 Disabilities Provider Association from a list provided by the association;
8 and

9 (ii) One (1) member to represent the Community
10 Developmental Disabilities Provider Network from a list provided by the
11 network;

12 (B) One (1) member who is a provider of community-based
13 services for individuals with behavioral-health needs from a list provided by
14 the Arkansas Mental Health Council of Arkansas;

15 (C) One (1) member who is a provider of community-based
16 services for youth from a list provided by the Arkansas Youth Services
17 Providers Association; and

18 (D) One (1) member who is a provider of community-based
19 services to the aging from a list provided by the Arkansas Association of
20 Area Agencies on Aging.

21 (b) The members of the Community Services Oversight and Planning
22 Council shall serve two-year terms and may be reappointed.

23 (c)(1) The House of Representatives and Senate cochairs of the
24 Legislative Council shall call the first meeting of the Community Services
25 Oversight and Planning Council within sixty (60) days of the effective date
26 of this subchapter.

27 (2) The House of Representatives and Senate cochairs of the
28 Legislative Council shall appoint a chair and vicechair from among the
29 members of the Community Services Oversight and Planning Council.

30 (d) The Community Services Oversight and Planning Council shall:

31 (1) Set the date, place, and time of meetings as necessary to
32 perform its duties; and

33 (2)(A) Provide information regarding scheduled meetings to the
34 Bureau of Legislative Research.

35 (B) The bureau shall publish the information on the
36 bureau's website.
