9 AN ACT TO REQUIRE THE STATE BOARD OF EDUCATION TO
10 PRESCRIBE UNIFORM COLLEGE LEVEL PREPARATORY AND
11 GRADE POINT AVERAGE REQUIREMENTS FOR ALL PERSONS
12 APPLYING FOR INITIAL TEACHER LICENSURE OR
13 RELICENSURE AFTER JULY 1, 2006; TO REPEAL THE
14 PROFESSIONAL EDUCATION, DEVELOPMENT, LICENSURE,
15 AND ASSESSMENT BOARD; TO CREATE THE PROFESSIONAL
16 LICENSURE STANDARDS BOARD; AND FOR OTHER
17 PURPOSES.


28 SECTION 1. Arkansas Code § 6-17-402 is amended to read as follows:
29 6-17-402. Rules and regulations.

30 (a) For purposes of this section:

31 (1) "Certified teaching license" includes that license of a
32 licensed classroom teacher, administrator, counselor, or librarian; and

33 (2) Levels of licensure" means the grade levels listed on a
34 teaching license of persons who are required to teach students in those grade
35 levels.

36 ~~(a)-(1)~~(b)(1) The State Board of Education shall promulgate rules and



1 regulations for the issuance, licensure, relicensure, and continuance of
2 licensure of teachers in the public schools of this state.

3 (2) The State Board of Education shall prescribe uniform college
4 level preparatory and grade point average requirements for all teachers
5 applying for initial licensure or relicensure after July 1, 2006, that are
6 consistent with the recommendations of the Professional Licensure Standards
7 Board prescribing uniform college level preparatory and grade point average
8 requirements for all teachers applying for initial licensure or relicensure
9 after July 1, 2006, including uniform and specific requirements for:

10 (A) Course of study;

11 (B) College level teacher education classes;

12 (C) Subject-matter specific course work certification or
13 licensure in a particular subject area rather than grade level certification;
14 and

15 (D) In-class teaching internships or practice teaching
16 hours.

17 ~~(2)~~(3)(A) In addition to the requirements under subdivision
18 (a)(2) of this section and other requirements, any person applying for
19 initial licensure as a teacher in the public schools or a licensed teacher
20 applying for a license in an additional area shall take and complete a test
21 recognized by the National Council for Accreditation of Teacher Education and
22 approved by the ~~board~~ State Board of Education, and submit the scores to the
23 Department of Education.

24 ~~(b)~~(B) No applicant for initial licensure or licensure in
25 an additional area shall receive a license unless the applicant scores at or
26 above the minimum level set by the ~~board~~ State Board of Education and obtains
27 the minimum grade point average set by the State Board of Education for any
28 college level course work requirements established by the State Board of
29 Education.

30 ~~(e)~~(C) All colleges and universities in this state shall
31 report the results of the examinations to the department upon request.

32 ~~(d)~~(c)(1) The ~~board~~ State Board of Education shall not delegate to any
33 college or university any of the ~~board's~~ State Board of Education powers or
34 duties pertaining to the issuance, licensure, relicensure, and continuance of
35 licensure of teachers in public schools in this state.

36 (2) The State Board of Education shall not delegate to any

1 college or university any of the State Board of Education's powers or duties
 2 pertaining to the uniform and specific requirements for:

3 (A) Course of study;

4 (B) College level teacher education classes;

5 (C) Subject-matter specific course work certification or
 6 licensure in a particular subject area rather than grade-level certification;
 7 and

8 (D) In-class teaching internships or practice teaching
 9 hours.

10 ~~(e)~~(d)(1) The ~~board~~ State Board of Education shall waive the
 11 examination requirements and the uniform college level preparatory and grade
 12 point average requirements under subsection (a) of this section for
 13 individuals applying for licensure in Arkansas who have a valid out-of-state
 14 teaching license and three (3) years' documented teaching experience as
 15 required by the rules and regulations promulgated by the ~~board~~ State Board of
 16 Education.

17 (2) The State Board of Education shall waive the uniform college
 18 level preparatory and grade point average requirement under subsection (a) of
 19 this section, for students enrolled as a junior or senior in a teacher
 20 education program prior to July 1, 2006.

21 ~~(f) For purposes of this section, "certified teaching license"~~
 22 ~~includes that license of a licensed classroom teacher, administrator,~~
 23 ~~counselor, or librarian.~~

24 (e)(1) By July 1, 2005, the levels of licensure for Arkansas shall be
 25 for:

26 (A) Grades prekindergarten through six (PreK-6);

27 (B) Grades seven through twelve (7-12);

28 (C) Grades four through eight (4-8); and

29 (D) Specialty content areas prekindergarten through twelve
 30 (PreK-12).

31 (2)(A) Institutions of higher education that have approved
 32 programs of study for grades prekindergarten through four (preK-4) in place
 33 shall be approved by the Department of Higher Education to offer a grades
 34 prekindergarten through six (preK-6) licensure program by adding appropriate
 35 middle-level course work as outlined by the Department of Education.

36 (B) Institutions of higher education currently offering

1 prekindergarten through grade four (preK-4) early childhood licensure
2 programs approved by the Department of Education shall not be required to
3 resubmit these programs for approval when the licensure levels change from
4 prekindergarten through grade four (preK-4) to prekindergarten through grade
5 six (preK-6).

6 (f) The uniform college level preparatory and grade point
7 average requirements adopted by the State Board of Education as provided
8 under subdivision (a)(2) of this section shall not be required for any
9 teacher who has been issued a teacher certification or licensure prior to
10 July 1, 2006.

 28 to add an additional section to read as follows:

29 6-17-421. Professional Licensure Standards Board.

30 (a) There is established a board to be known as the "Professional
 31 Licensure Standards Board".

32 (b) The Professional Licensure Standards Board shall consist of
 33 fifteen (15) members as follows:

34 (1) Twelve (12) members appointed by the State Board of
 35 Education as follows:

36 (A) Three (3) public school teachers with an Arkansas

1 teaching license selected from a list of no fewer than six (6) different
2 teachers submitted by the Arkansas Education Association;

3 (B) One (1) person with an Arkansas teaching license
4 selected from a list of no fewer than three (3) different people submitted by
5 the Arkansas Association of Middle Level Educators;

6 (C) One (1) public school administrator with an Arkansas
7 teaching license selected from a list of no fewer than three (3) different
8 administrators submitted by the Arkansas Association of School
9 Administrators;

10 (D) One (1) public school administrator with an Arkansas
11 teaching license selected from a list of no fewer than three (3) different
12 administrators submitted by the Arkansas Association of School Personnel
13 Administrators;

14 (E) One (1) public school administrator with an Arkansas
15 teaching license selected from a list of no fewer than three (3) different
16 administrators submitted by the Arkansas Association of Secondary Principals;

17 (F) One (1) public school administrator with an Arkansas
18 teaching license selected from a list of no fewer than three (3) different
19 administrators submitted by the Arkansas Association of Elementary
20 Principals;

21 (G) Two (2) deans of a public institution of higher
22 education school of education, college of education, or department of a
23 education from a list of no fewer than five (5) different administrators
24 submitted by the Executive Council of the Arkansas Higher Education
25 Coordinating Board; and

26 (H) Two (2) representatives of an independent higher
27 education institution from a list of no fewer than five (5) different
28 representatives submitted by the Association of Colleges for Teacher
29 Education;

30 (2) The Coordinator for Professional Quality Enhancement
31 Division of the Department of Education in a non voting, ex officio capacity;

32 (3) The Coordinator for Professional Licensure Division of the
33 Department of Education in a non voting, ex officio capacity; and

34 (4) The Non-traditional Licensure Program Advisor of the
35 Department of Education in a non voting, ex officio capacity.

36 (c) Any list to be submitted under subsection (b) of this section

1 shall be submitted to the secretary of the State Board of Education by June
2 30, 2005. If a list for the respective position is not submitted by the
3 deadline, the State Board of Education may appoint any qualified person to
4 fill the position.

5 (d) The appointed Professional Licensure Standards Board professional
6 licensure Professional Licensure Standards Board members shall be residents
7 of the State of Arkansas at the time of appointment and throughout their
8 terms.

9 (1) The Director of the Department of Education shall call an
10 organizational meeting within twenty (20) calendar days after the State Board
11 of Education has made all necessary appointments.

12 (2) The Director of the Department of Education shall serve as
13 chair at the organizational meeting until the Professional Licensure
