## For An Act To Be Entitled

10 AN ACT TO ENCOURAGE *CERTIFIED SCHOOL PERSONNEL* TO  
11 SERVE THIS STATE AS MEMBERS OF THE GENERAL  
12 ASSEMBLY; TO REMOVE CONTRACTUAL ROADBLOCKS TO  
13 *SERVICE OF CERTIFIED SCHOOL PERSONNEL* IN THE  
14 GENERAL ASSEMBLY; AND FOR OTHER PURPOSES.

## Subtitle

16 AN ACT TO ENCOURAGE *CERTIFIED SCHOOL*  
17 *PERSONNEL* TO SERVE THIS STATE AS MEMBERS  
18 OF THE GENERAL ASSEMBLY; TO REMOVE

25 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

27 SECTION 1. Arkansas Code Title 6, Chapter 17, Subchapter 1 is amended  
28 to add and additional subchapter to read as follows:

29 6-17-118. Leave of absence for certified school personnel elected to  
30 the General Assembly.

31 (a) Certified school personnel who are elected to the General Assembly  
32 have the right during any regular or extraordinary session of the General  
33 Assembly to either:

34 (1) A leave of absence under § 21-4-101; or

35 (2) Paid leave on the condition that the certified school  
36 person:



1                   (A) Reimburses the local school district for the cost of a  
2 substitute; and

3                   (B) Agrees to continue all contractual duties except  
4 actual personal presence in the school environment.

5                   (b) The State Board of Education shall promulgate rules to implement  
6 the provisions of this section.
