30 SECTION 16. EMERGENCY CLAUSE. It is found and determined by the  
31 General Assembly of the State of Arkansas, that changes in law are needed for  
32 the institutions of higher education including the authorization of  
33 additional vehicles to maintain efficient operations of campuses. Therefore,  
34 an emergency is hereby declared to exist and this Act being necessary for the  
35 immediate preservation of the public peace, health and safety shall be in  
36 full force and effect from and after July 1, 2005.
