2	(a) The Office of Driver Services of the Revenue Division of the
3	Department of Finance and Administration shall implement the changes required
4	by this subchapter for all new driver's licenses issued or renewed on or
5	before January 31, 2006.
6	(b)(1) Except as provided under subdivision (b)(2) and subsection (d)
7	of this section, beginning four (4) years after the effective date of this
8	subchapter, a state agency may not accept for any purpose a driver's license
9	or identification card that was not issued under the requirements of this
10	subchapter.
11	(2) The limitation under subdivision (b)(1) of this section and
