23	SECTION 2. EMERGENCY CLAUSE. It is found and determined by the

25	of critical importance to preserve the efficient operations of the schools of
26	the State of Arkansas; that this act provides needed information regarding
27	consolidations; and that this is immediately necessary for the efficient
28	operations of schools. Therefore, an emergency is declared to exist and this
29	act being immediately necessary for the preservation of the public peace,
30	health, and safety shall become effective on:
31	(1) The date of its approval by the Governor;
32	(2) If the bill is neither approved nor vetoed by the Governor,
33	the expiration of the period of time during which the Governor may veto the
34	<pre>bill; or</pre>
35	(3) If the bill is vetoed by the Governor and the veto is
36	overridden the date the last house overrides the veto
