19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
20

21 SECTION 1. Arkansas Code § 8-4-104(b), concerning the membership of
22 the Arkansas Pollution Control and Ecology Commission, is amended to read as
23 follows:

24 (b) The commission shall be composed of thirteen (13) members:

25 (1)(A) The Governor, by and with the advice and consent of the
26 Senate, shall appoint seven (7) members.

27 (B) Each congressional district shall be represented on
28 the commission by at least one (1) member and no district shall have more
29 than two (2) members of the seven (7) appointees.

30 (C) The Governor will not appoint a member to represent
31 any specific or special interest group, organization, or philosophy. However,
32 in making appointments to the commission, the Governor shall appoint
33 individuals who have knowledge or expertise in matters within the
34 jurisdiction of the commission, including government, business or industry,
35 agriculture and livestock, forestry, health, ecology, recreation and tourism,
36 and geology.



1 (D) Each member appointed by the Governor shall be
2 appointed for a term of four (4) years; and

3 (2)~~(A)~~ The other six (6) members of the commission shall be ~~the~~
4 Directors;

5 (A) The Director of the Department of Health or his or her
6 designee; and

7 (B)(i) The Directors of the Arkansas State Game and Fish
8 Commission, the Arkansas Forestry Commission, the Arkansas Soil and Water
9 Conservation Commission, the Oil and Gas Commission, and the State Geology
10 Commission.

11 ~~(B) However, a director~~ (ii) The directors specified in
12 subdivision (b)(2)(B)(i) of this section may designate the agency's deputy
13 director or assistant director to serve in lieu of the director.
