5	(a) A person may possess a large carnivore only if:

9	(2) The person applies for and is granted a permit for personal
10	possession for each large carnivore in the person's possession not more than
11	ninety (90) days after the effective date of this subchapter.
12	(b)(1) A person under subsection (a) of this section shall annually
13	obtain a permit for personal possession.
14	(2) After the effective date of this subchapter, any additional
15	large carnivore shall not be brought into possession under the authority of a
16	permit for personal possession.
17	(c)(l) An applicant shall file an application to receive a permit for
18	personal possession with the county sheriff's department of the county where
19	the large carnivore is kept on forms provided by the sheriff's department.
20	(2) The application shall include:
21	(A) The name, address, and telephone number of the

19	a veterinarian is to be kept on file by the permit holder.
20	(g) All fees levied and collected for permits of personal possession

23	personal possession, for any costs involved in controlling large carnivores
24	located within the county, and for any other animal control costs.

26	20-19-505. Caging requirements.
27	(a)(1) The possessor of a large carnivore is required to maintain the
28	large carnivore in a cage that meets the requirements recommended by the
29	American Zoo and Aquarium Association as in existence on January 1, 2055 for
30	each species of large carnivore.
31	(2) Failure to provide the caging required by this section shall
32	result in the cancellation of the permit for personal possession.
33	(b) Deviations from these caging requirements may be approved by the
34	county sheriff of the county where the animal is kept upon showing of good
35	cause.

1	20-19-506. Insurance - Signs - Notification.		
2	(a)(1) A possessor of a large carnivore shall maintain liability		
3	insurance coverage in an amount of not less than one hundred thousand dollars		
4	(\$100,000) for each occurrence for liability damages for destruction of or		
5	damage to property and for death or bodily injury to a person caused by the		
6	large carnivore.		
7	(2) The possessor of a large carnivore shall provide a copy of		
8	the policy for liability insurance to the county sheriff's department on an		
9	annual basis to obtain or renew a permit.

19	The possessor of a large carnivore shall allow an official of the		
20	county sheriff's department, an animal control officer, or a law enforcement

22	premises to ensure compliance with this subchapter.

24	20-19-508. Public contact - Warnings of escape.		
25	(a) The possessor of a large carnivore shall not bring a large		
26	carnivore to any commercial or retail establishment unless the possessor is		
27	bringing the large carnivore to a veterinarian clinic.		
28	(b)(1) If a large carnivore escapes or is released, the possessor of		
29	the large carnivore shall immediately contact the Arkansas State Game and		
30	Fish Commission and law enforcement officials of the city or county where the		
31	possessor resides to report the escape or release.		
32	(2) The possessor is liable for all expenses associated with		
33	efforts to recapture the large carnivore.		
34			
35	20-19-509. Confiscation.		
36	(a) A large carnivore may be immediately confiscated by a county		

1	sheriff's department if:
2	(1) The possessor does not have a permit for personal
3	possession;
4	(2) The possessor does not have the liability insurance coverage
5	required under this subchapter;
6	(3) Conditions under which the large carnivore is kept are
7	directly or indirectly dangerous to human health and safety; or
8	(4) The caging requirements of § 20-19-505 are not met.
9	(b)(1) If a large carnivore is confiscated, the possessor shall be
10	liable for the costs of placement and care for the large carnivore from the
11	time of confiscation until the time the large carnivore has been relocated to
12	an alternative facility.
13	(2) The county sheriff's department shall seek to place the
14	confiscated large carnivore with a wildlife sanctuary, humane society, or an
15	institution accredited by the American Zoo and Aquarium Association.

17	<u>20-19-510. Penalties.</u>
18	<u>A person who is in violation of the prohibitions of § 20-19-502 is</u>
19	guilty of a Class A misdemeanor.

21	20-19-511. Rules and regulations.
22	The county sheriff's department of each county may collect the fees for
23	the permits for personal possession required under this subchapter and the
24	Arkansas Game and Fish Commission may adopt rules and regulations to
25	implement and enforce this act.
