20	BE IT ENACTED BY THE G	GENERAL ASSEMBLY OF THE STATE OF ARK	ANSAS:

22	SECTION 1. Legi	islative intent.	
23	(a) Since the A	Arkansas Soil and Water Conservation	Commission was
24	created by Act 1963, No. 14 the responsibilities of the commission have grown		
25	to include water planr	ning, groundwater protection, floodp	lain management,
26	nonpoint source pollut	tion management, wetlands restoratio	on, and financing of
27	drinking water and sew	wer infrastructure as well as the fi	nancing of water
28	treatment and collection facilities.		
29	(b) The commission would more aptly be characterized by a name that		
30	describes the commission's mission to protect natural resources for the		
31	health, safety, and ed	conomic benefit of the state.	
32			
33	SECTION 2. Arka	ansas Soil and Water Conservation Co	mmission renamed
34	"Arkansas Natural Resources Commission".		
35	(a)(1) The "Arkansas Soil and Water Conservation Commission" as it is		
36	referred to or empowered throughout the Arkansas Code, is renamed.		

1	(2) In its place, the "Arkansas Natural Resources Commission" is		
2	established, succeeding to the general powers and responsibilities previousl		
3	assigned to the Arkansas Soil and Water Conservation Commission.		
4	(3) The Executive Director of the Arkansas Soil and Water		
5	Conservation Commission is directed to identify and revise all interagency		
6	agreements, financial instruments, funds, and other necessary legal documents		
7	in order to effect this change.		
8	(b) Nothing in this act shall be construed as impairing the powers and		
9	authorities of the Arkansas Soil and Water Conservation Commission before the		
10	effective date of the name change.		
11			
12	SECTION 3. Arkansas Code § 15-20-201 is amended to read as follows:		
13	15-20-201. Creation.		
14	There is created and established at the seat of government of this		
15	state a commission to be known as the "Arkansas Soil and Water Conservation		
16	Commission" "Arkansas Natural Resources Commission", hereinafter also		
17	referred to as the "commission".		
18			
19	SECTION 4. (a) This act shall not be construed as impairing the		
20	continued effectiveness of any regulations or orders promulgated or issued by		
21	the Arkansas Soil and Water Conservation Commission before the effective date		
22	of this act.		
23	(b) This act shall not be construed as extinguishing or otherwise		
24	affecting the unexpired terms of any current members of the Arkansas Soil and		
25	Water Conservation Commission.		
26			
27	SECTION 5. The Arkansas Code Revision Commission shall replace the		
28	name "Arkansas Soil and Water Conservation Commission" in all appropriate		
29	sections of the Arkansas Code with the name "Arkansas Natural Resources		
30	Commission".
