- (d)(c) Upon selling or otherwise relinquishing ownership of an historic or special interest vehicle, a collector may retain possession of the vehicle plate and transfer its registration to another vehicle of the same category in his or her possession, upon payment of one-half (1/2) the fee prescribed in subsection (a) of this section.
- $\frac{(e)}{(d)}(1)$ A vehicle manufactured as a reproduction or facsimile of an historic or special interest vehicle shall not be eligible for registration under this section unless it has been in existence for twenty-five (25) years or more.
- 16 (2) The age shall be calculated from the date the vehicle was 17 originally assembled as a facsimile.

- (b)(1) Upon notification of a violation of this section, the Beginning on January 1, 2006, the office shall require the owner of any antique motor
