19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
20

21 SECTION 1. Arkansas Code § 5-39-211(a), concerning unlawful mining and
22 entries into cemeteries, is amended to read as follows:

23 (a) It shall be unlawful for any corporation, company, or individual
24 to:

25 (1)(A) Mine, extract, or remove coal from under, beneath, or
26 within the buffer zone for a cemetery, graveyard, or burying place in this
27 state as specified in rules promulgated by the Arkansas Pollution Control and
28 Ecology Commission under the Arkansas Surface Coal Mining and Reclamation Act
29 of 1979, § 15-58-101 et seq.; or

30 (B) Mine, extract, or remove any other mineral ~~or~~
31 substance from under, ~~or~~ beneath, or within twenty-five feet (25') of the
32 boundary of any cemetery, graveyard, or burying place in this state;

33 (2)(A) Make, place, or drive any slope, pit, or entry of any
34 kind into, under, through, or across any cemetery, graveyard, or other
35 burying place in this state.

SECTION 2. Arkansas Code § 5-39-212 is amended to read as follows:

5-39-212. Cemeteries - Access - Debris - Disturbance.

(a)(1) It shall be unlawful for any person, firm, corporation, partnership, or association to:

(2) ~~Construct~~ construct any fence on any property in such manner as to enclose any cemetery, graveyard, or burying place unless ~~suitable~~ reasonable access by automobile to the cemetery is provided by gate or otherwise.

(B) The word "cemetery", as used in this subsection, is not intended to apply to any private family burial plot ~~which~~ that:

(i) ~~contains~~ Contains fewer than six (6) commercial grave markers;

(ii) ~~and has~~ Has not been used for burial purposes for at least twenty-five (25) years; and

(iii) ~~which has~~ Has not had an access road to the burial plot for at least thirty (30) years.

(3) Nothing in this section prohibits the placement of a fence around any cemetery for the purpose of defining boundaries or protection of grave sites, if all fences and gates are sufficiently maintained.

(b) Any person, firm, corporation, partnership, or association violating any of the provisions of this section shall be guilty of a misdemeanor and upon conviction shall be fined in any sum not less than ten dollars (\$10.00) nor more than one hundred dollars (\$100), and every day that the violation shall exist shall be a separate offense.

SECTION 3. Arkansas Code § 5-39-401 is amended to read as follows:

5-39-401. Destruction or removal.

It is unlawful for any person, corporation, company, or other entity to destroy or carry away any cemetery marker or grave marker.

SECTION 4. Arkansas Code § 5-71-215(a), concerning defacing of objects of public respect, is amended to read as follows:

(a) A person commits the offense of defacing objects of public respect if he or she purposely:

(1) Defaces, mars, or otherwise damages any public monument;

(2) Defaces, mars, or otherwise damages a work of art on display

1 in any public place; ~~or~~

2 (3) Defaces, mars, desecrates, or otherwise damages any place of
3 worship, cemetery, or burial monument; ~~or~~

4 (4) Removes broken or unbroken, commercial or rock grave markers
5 for any reason except for cleaning or repair by a family member, caretaker,
6 or preservation organization.

8 SECTION 5. Arkansas Code § 13-6-408(c), concerning desecration of
9 burial grounds and burial furniture, is amended to read as follows:

10 (c) Exempted from this section is disturbance of human skeletal burial
11 remains or burial furniture by landowners or agricultural tenants as a
12 consequence of agricultural activity or any other activity unless the
13 landowner or agricultural tenant knowingly desecrates or knowingly allows
14 desecration of a cemetery or burial site.

15
16 SECTION 6. Arkansas Code § 20-17-902 is amended to read as follows:
17 20-17-902. Burial in registered cemetery required - Records.

18 (a) It shall be unlawful to bury a dead body outside of a registered
19 cemetery.

20 (b) No dead body may be buried within twenty-five feet (25') of a
21 cemetery boundary.

22 (b)(c) The sexton or person in charge of the cemetery shall keep a
23 correct record, on a form prescribed by the Department of Health, of each
24 body buried ~~therein~~ in the cemetery.
