2	plate under this section instead of a license plate that is currently issued

4	Revenue Division of the Department of Finance and Administration.
5	(c) An applicant who seeks to use an antique license plate under this
6	section shall remit the following fees:
7	(1) The fee required by law for the registration and licensing
8	of the motor vehicle; and
9	(2) A handling and administrative fee in the amount of ten
10	<u>dollars (\$10.00).</u>
11	(d) To renew an antique license plate under this section, the owner of
12	the motor vehicle shall remit the fee required by law for the registration
13	and licensing of the motor vehicle.
14	(e)(1) An applicant who seeks to use an antique license plate other
15	than the special license plate issued by the Office of Motor Vehicle under
16	Arkansas Code § 27-15-2202 shall be required to submit the license plate to
17	the Office of Motor Vehicle for inspection to determine whether the antique
18	license plate may be used.
19	(2) If the Office of Motor Vehicle determines that the antique
20	license plate is unacceptable, the applicant shall not be allowed to use the
21	antique license plate.
22	(3) The reasons for which the Office of Motor Vehicle may
23	prohibit the use of an antique license plate include, but shall not be
24	<u>limited</u> to:
25	(A) The antique license plate does not meet reasonable

34	SECTION 2. Alternative license plates for antique motorcycles.
35	(a) As used in this section, "antique license plate" means a license
36	plate that:

1	(1) Is approved for issuance under subsection (e) of this
2	section for an antique motorcycle as defined under Arkansas Code § 27-15-
3	2301(a) that is over twenty-five (25) years of age instead of the special
4	license plate issued under Arkansas Code § 27-15-2304; and
5	(2) Was issued by and approved for use in the State of Arkansas
6	in the same year as the model year of the motorcycle that is being licensed.
7	(b) If a person is eligible for a special license plate for an antique
8	motorcycle, the person may choose to use an antique license plate under this
9	section instead of a license plate that is currently issued under Arkansas
10	Code § 27-15-2304 by the Office of Motor Vehicle of the Revenue Division of
11	the Department of Finance and Administration.
12	(c) An applicant who seeks to use an antique license plate under this
13	section shall remit the following fees:
14	(1) The fee required by law for the registration and licensing
15	of the antique motorcycle; and
16	(2) A handling and administrative fee in the amount of ten
17	dollars (\$10.00).
18	(d) To renew an antique license plate under this section, the owner of
19	the antique motorcycle shall remit the fee required by law for the
20	registration and licensing of the motorcycle.
21	(e)(1) An applicant who seeks to use an antique license plate other
22	than the special license plate issued by the Office of Motor Vehicle under
23	Arkansas Code § 27-15-2304 shall be required to submit the license plate to
24	the Office of Motor Vehicle for inspection to determine whether the antique
25	license plate may be used.
26	(2) If the Office of Motor Vehicle determines that the antique
27	license plate is unacceptable, the applicant shall not be allowed to use the
28	antique license plate.
29	(3) The reasons for which the Office of Motor Vehicle may
30	prohibit the use of an antique license plate include, but shall not be
