31	(b) If a used motor vehicle dealer engages in a delivery prior to		
32	sale, then the used motor vehicle dealer shall:		
33	(1) Provide disclosure to the consumer in an agreement for		
34	delivery prior to sale as provided under this section; and		
35	(2) Not sell the motor vehicle that is presented by the consumer		
36	as a trade-in unless the consumer has been approved for financing and has
