18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20 SECTION 1. Emergency medical technicians.

21 (a) The Department of Finance and Administration shall create and
22 issue a special license plate for emergency medical technicians.

23 (b) The Department of Finance and Administration shall design the
24 special license plates issued under this section.

25 (c) Any person may apply for and annually renew a special license
26 plate issued under this section if he or she is currently licensed in the
27 State of Arkansas as:

28 (1) An emergency medical technician;

29 (2) An emergency medical technician paramedic; or

30 (3) An emergency medical technician intermediate.

31 (d) An applicant shall remit the following fees to obtain a special
32 license plate issued under this section for use on a motor vehicle:

33 (1) The fee required by law for the registration and licensing
34 of the motor vehicle;

35 (2) A handling and administrative fee in the amount of ten
36 dollars (\$10.00); and



1 (3) An additional fee of fifteen dollars (\$15.00) to be
2 deposited into the EMS Enhancement Revolving Fund.

3 (e)(1) The fee for the renewal of a special license plate under this
4 section are the fees required under subsection (d) of this section.

5 (2) The replacement fee for a special license plate issued under
6 this section is ten dollars (\$10.00).

7 (f) Upon the initial application for a special license plate issued
8 under this section, the emergency medical technician shall provide adequate
9 proof to the Department of Finance and Administration that he or she is
10 licensed in the State of Arkansas as one (1) of the following:

11 (1) An emergency medical technician;

12 (2) An emergency medical technician paramedic; or

13 (3) An emergency medical technician intermediate.

14 (g)(1) The fee remitted under subdivision (d)(2) of this section shall
15 be deposited into the State Central Services Fund for the benefit of the
16 Revenue Division of the Department of Finance and Administration.

17 (2) The fee shall be credited as supplemental and in addition to
18 all other funds as may be deposited for the benefit of the division.

19 (3) The fee shall not be considered or credited to the division
20 as direct revenue.

21 (h) The registration of a special license plate under this section
22 may:

23 (1) Continue from year to year as long as it is renewed each
24 year within the time and in the manner required by law; and

25 (2) Be renewed as provided under §§ 27-14-1012 and 27-14-1013.
