24 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
25

SECTION 1. Intent.

26
27 (a) The General Assembly finds that:

28 (1) The actions of state government have produced a substantial
29 increase in the number of agencies, departments, boards, commissions,
30 institutions, and programs of this state, growth of pre-existing programs,
31 and the proliferation of rules;

32 (2) The growth of state government has developed without
33 sufficient legislative oversight, regulatory accountability, or a system of
34 checks and balances; and

35 (3) By establishing a system for the termination, study, review,
36 continuation, or re-establishment of such agencies, it will be in a better



1 position to evaluate the need for the continued existence of existing and
2 future agencies, departments, boards, commissions, institutions, and programs
3 of the state government.

4 (b) The intent of this act is to establish an orderly schedule for the
5 abolishment of all existing state agencies during a twelve-year period, but
6 to make provision for review by the Government Efficiency and Accountability
7 Review Committee to enable the General Assembly to have the benefit of
8 recommendations for the continuation of those state agencies which are deemed
9 to be essential for the necessary and efficient operation of government prior
10 to the abolishment.

12 SECTION 2. (a) The following state agencies, and all departments,

14 committees, and councils of the state agencies, shall be abolished on June
15 30, 2007, unless continued by action of the General Assembly or transferred
