27	school district intends to apply for state financial participation during
28	fiscal year 2006-2007, the division shall notify the school district of the
29	division's decision on the application and, if applicable, the estimated
30	amount of state financial participation in the new construction project no
31	later than May 1, 2006.
32	(B) Beginning in 2007, the division shall notify the
33	school district of the division's decision on the application and, if

	applicable, the estimated amount of state financial participation in the new
35	applicable, the estimated amount of state financial participation in the new construction project no later than May 1 of each odd-numbered year.

1	application for state financial participation in a new construction shall
2	include an explanation of the evaluative factors underlying the decision of
3	the division to provide or not provide state financial participation in
4	support of the new construction project.
5	(e)(l) If the division determines that the new construction project is
6	eligible for state financial participation, the division and the school
7	district shall enter into an agreement specifying the terms of the state's
8	financial participation and the conditions that must be satisfied by the
9	school district.
10	(2) At a minimum, the agreement shall:
11	(A) Identify the estimated amount of local financial
12	participation and state financial participation in the new construction
13	project;
14	(B) Define the method of and schedule for transferring
15	state financial participation funds to the school district;
16	(C) Identify whether the new construction project includes
17	any improvements that are classified as maintenance, repair, and renovation,
18	and how the project costs will be allocated between new construction
19	activities and maintenance, repair, and renovation activities;
20	(D) Provide that changes to the plans for the new
21	construction project shall be made in consultation with the division;
22	(E) Provide that the division or any person acting on
23	behalf of the division may conduct on-site inspections of the new
24	construction project as frequently as the division deems necessary to assure
25	the prudent and resourceful expenditure of state funds with regard to public
26	school academic facilities;
27	(F) Determine how risk will be allocated between the
28	school district and the state if the new construction project is not
29	<pre>completed;</pre>
30	(G) Describe how changes in the school district's wealth
31	index over the course of the new construction project will be treated; and
32	(H) Specify that the agreement is void and the state will
33	have no further obligation to provide state funds to the school district for
34	the new construction project that is the subject of the agreement if the
35	school district does not raise local resources and apply local resources
36	toward the new construction project as provided under the agreement.

1	(f)(1) If a school district qualifies for state financial
2	participation under this section, the division shall certify the amount of
3	state financial participation to the Commission on Public School Academic
4	Facilities and Transportation for oversight purposes. The commission shall
5	certify the amount to the Department of Education for payment.
6	(2) For tracking purposes, the school district shall account for
7	the funds received as state financial participation under this section as
8	restricted funds and shall account for the funds in accordance with
9	provisions of law, including, without limitation, the Arkansas Educational
10	Financial Accounting and Reporting Act of 2005, § 6-20-2201 et seq. and rules
11	established by the State Board of Education and the commission.
12	
13	6-20-2509. Academic Facilities Catastrophic Program.
14	(a) There is established the Academic Facilities Catastrophic Program
15	under which the Division of Public School Academic Facilities and
16	Transportation shall award state financial participation to a school district
17	based on a school district's academic facilities wealth index for eligible
18	catastrophic repair and new construction projects for the purpose of
19	supplementing insurance or other public or private emergency assistance
20	received by or payable to the school district.
21	(b) A school district may apply for state financial participation in a
22	catastrophic project if an academic facility in the district is damaged due
23	to an act of God or violence that could not have been prevented by reasonable
24	maintenance, repair, or renovation of the building.
25	(c) As part of its application for state financial participation in a
26	catastrophic project, the school district shall provide the division with
27	evidence of:
28	(1) The estimated cost of the project;
29	(2) The availability of insurance and any other public or
30	private emergency assistance to pay for the project; and
31	(3) How the catastrophic project supports the prudent and
32	resourceful expenditure of state funds and improves the school district's
33	ability to deliver an adequate and equitable education to public school
34	students in the district.
35	(d)(1) The division shall evaluate a school district's application for
36	catastrophic assistance and may conduct an on-site inspection prior to making

1	a decision on the application as it deems necessary.
2	(2) The division shall notify the school district of the
3	division's decision on the application and, if applicable, the amount of
4	state financial participation. The division shall base its decision, on
5	several factors, including, without limitation:
6	(A) Compliance with appropriate academic facility
7	standards, including, without limitation, appropriate space utilization;
8	(B) The amount and availability of insurance or other
9	public or private emergency assistance;
10	(C) The academic facilities wealth index of the school
11	district; and
12	(D) The prudent and resourceful expenditure of state funds
13	with regard to public school academic facilities.
14	(e)(l) If a school district qualifies for state financial
15	participation under this section, the division shall certify the amount of
16	state financial participation to the Commission on Public School Academic
17	Facilities and Transportation for oversight purposes. The commission shall
18	certify the amount to the Department of Education for payment.
19	(2) For tracking purposes, the school district shall account for
20	the funds received as state financial participation under this section as
21	restricted funds and shall account for the funds in accordance with
22	provisions of law, including without limitation, the Arkansas Educational
23	Financial Accounting and Reporting Act of 2005, § 6-20-2201 et seq. and rules
24	established by the State Board of Education and the commission.
25	(f) Every effort shall be made to conform a catastrophic project to
26	current academic facilities standards, including appropriate space
27	utilization requirements, unless in the judgment of the division it is
28	impractical to conform the catastrophic project to current standards.
29	(g) A school district shall use state financial participation in a
30	catastrophic program to pay the cost of only the portion of a catastrophic
31	project that is not covered by insurance or other public or private emergency
32	assistance received by or payable to the school district.
33	
34	6-20-2510. Project cost guidelines.
35	(a)(l) The Division of Public School Academic Facilities and
	(a)(1) The DIVISION OF FUDILE SCHOOL Academic Facilities and

1	determining the basic project cost per student for various types of new
2	construction projects, including, without limitation:
3	(A) New academic facilities;
4	(B) Additions to existing academic facilities; and
5	(C) Major improvements to academic facilities that bring
6	the state of condition or efficiency of the academic facility to a state of
7	condition or efficiency better than the facility's original condition of
8	completeness or efficiency.
9	(2) In establishing the formulas, the division shall take into
10	consideration:
11	(A) The academic programs offered;
12	(B) Current enrollment levels;

15	(E) Type of public school; and
16	(F) Nationally recognized design and construction
17	standards for cost per square foot.
18	(3) The division shall establish a process for determining the
19	cost of local enhancements and shall include a mechanism in the formulas for
20	determining basic project cost that excludes the cost of local enhancements
21	from the adjusted project cost.
22	(b) When a school district applies for state financial participation,
23	the division shall use the appropriate formula to compute an adjusted project
24	cost. The division shall determine the estimated amount of the state's share
25	of financial participation based on the adjusted project cost and the school
26	district's wealth index as determined under § 6-20-2502.
27	
28	6-20-2511. Incentives for collaboration.
29	(a) It is the intent of the General Assembly to encourage school
30	districts to explore and consider arrangements with other districts that have
31	the potential to:
32	(1) Improve academic facilities and equipment available to the
33	public school students in the districts;
34	(2) Result in improved transportation arrangements for public
35	school students in the state;
36	(3) Have the potential to create any type of efficiency for

1	school districts or enhanced learning opportunities for public school
2	students in the state; and
3	(4) Facilitate the highest and best use of state funds in
4	support of public school academic facilities.
5	(b) If school districts voluntarily consolidate or if one (1) school
6	district annexes another school district, then the division shall use the
7	lowest wealth index of the participating school districts to determine the

16	6-20-2512. High-growth school districts.
17	(a) The Division of Public School Academic Facilities and
18	Transportation shall develop a program to provide state financial
19	participation in the form of emergency loans to eligible high-growth school
20	districts for assistance with excess debt service requirements. The amount
21	of an emergency loan shall be based on:
22	(1) Growth trends in the district;
23	(2) The application of space utilization standards in the
24	district;
25	(3) The academic facilities wealth index of the school district;
26	and
27	(4) The prudent and resourceful expenditure of state funds with
28	regard to public school academic facilities.
29	(b) The division shall report to the General Assembly by January 15,
30	2007 on the development of the program and obtain formal legislative approval
31	and funding before implementing the program.
32	
33	6-20-2513. Regulatory authority.
34	The Commission on Public School Academic Facilities and Transportation
35	shall promulgate rules necessary to administer this subchapter, which shall
36	promote the intent and purposes of this subchapter and assure the prudent and

1	resourceful expenditure of state funds with regard to public school academic
2	facilities throughout the state.
3	
4	<u>6-20-2514. Appeals.</u>
5	(a) A school district may appeal any determination of the Division of
6	Public School Academic Facilities and Transportation under this subchapter to
7	the Commission on Public School Academic Facilities and Transportation in
8	accordance with procedures developed by the commission.
9	(b) All decisions of the commission resulting from a school district's
10	appeal of a division determination under this subchapter shall be final and

15	SECTION 2. Effective July 1, 2005, Arkansas Code Title 6, Chapter 20,

17	6-20-2401. Title.
18	This subchapter shall be known and may be cited as the "Supplemental
19	School District Funding Act of 2003".
20	
21	6-20-2402. Purpose.
22	(a) The General Assembly finds that:
23	(1) The debt service funding supplement and general
24	facilities funding have been an integral part of school financing for a
25	number of school districts;
26	(2) Elimination of these sources of funds could adversely
27	affect the ability of those districts to continue to operate in a fiscally
28	prudent manner; and
29	(3) School districts that voluntarily raise school district
30	millage beyond the twenty-five (25) mills required by Arkansas Constitution,
31	Amendment 74, should receive incentive funding to encourage local financial
32	support of schools.
33	(b) The purpose of this subchapter is to allow eligible school
34	districts to elect to either continue receiving the debt service funding
35	supplement and general facilities funding or to receive supplemental millage
36	incentive funding.

1	
2	6-20-2403. Definitions.
3	As used in this subchapter:
4	(1) "Average daily membership" means the total number of days
5	attended plus the total number of days absent by students in grades
6	kindergarten through twelve (K-12) during the first three (3) quarters of
7	each school year divided by the number of school days actually taught in the
8	district during that period of time rounded up to the nearest hundredth.
9	Students who may be counted for average daily membership are:
10	(A) Students who reside within the boundaries of the
11	school district and who are enrolled in a public school operated by the
12	district or a private school for special education students with their
13	attendance resulting from a written tuition agreement approved by the
14	Department of Education;
15	(B) Legally transferred students living outside the
16	district but attending a public school in the district; and
17	(C) Students who reside within the boundaries of the
18	school district and who are enrolled in the Arkansas National Guard Youth
19	Challenge Program, so long as the students are participants in the program;
20	(2) "Debt service funding supplement" means the state
21	financial aid provided to qualifying local school districts for the purpose
22	of reducing existing debt service burdens and increasing the amount of local
23	revenue available for maintenance and operations expenditures;
24	(3) "Eligible debt service millage required" means the debt
25	service millage required for bonds issued before May 30, 2004, that is
26	computed by dividing the scheduled debt payment by the total property
27	assessment in the school district and then adding the result to the millage
28	for mandatory callable bonds;
29	(4) "General facilities funding" means the state financial
30	aid provided to each school district from line item funds made available for
31	that purpose;
32	(5) "Local revenue" means in each school year ninety-eight
33	percent (98%) of the amount of revenue available, whether or not collected,
34	in a local school district solely from the levy of the uniform rate of tax
35	plus seventy-five percent (75%) of the average miscellaneous funds collected
36	in the previous five (5) years or the previous year, whichever is less;

1	(6) "Mandatory callable bonds" means a bond issue in which
2	all net proceeds from debt service millage used to secure the issuance of
3	that bond must be applied to payment of the issue and cannot be used for any
4	other purpose;
5	(7) "Miscellaneous funds" mean those funds received by a
6	local school district from federal forest reserves, federal grazing rights,
7	federal mineral rights, federal impact aid, federal flood control, wildlife
8	refuge funds, severance taxes, funds received by the district in lieu of
9	taxes, and local sales and use taxes dedicated to education pursuant to §§
10	<del>26-74-201 et seq., 26-74-301 et seq., 26-75-301 et seq., and 14-164-301 et</del>
11	<del>seq.;</del>
12	(8) "Qualified school district" means a school district that:
13	(A) Issued bonds to finance school district projects
14	before May 30, 2004, and for which outstanding bonds exist as of May 30,
15	<del>2004;</del>
16	(B) Was approved by the Department of Education to
17	issue bonds on or before December 31, 2003; and
18	(C) Received debt service funding supplements
19	pursuant to <mark>\$\$ 6-20-303 and 6-20-308 during school year 2003-2004 in</mark>
20	accordance with regulations promulgated by the Department of Education;
21	(9) "Scheduled debt payment" means the scheduled debt payment
22	on bonded debt issued on or before May 30, 2004, for the following calendar
23	year, not including mandatory callable bonds on file with the Department of
24	Education as of May 30 of the previous year. The scheduled debt payment shall
25	be adjusted by the Department of Education as follows:
26	$(\Lambda)$ In the case of a nonvoted refunding bond issue,
27	the payment schedule of the issue being refunded will be compared to the
28	payment schedule of the refunding issue. The schedule with the higher annual
29	debt payment will be used for the purposes of calculating eligible debt
30	service mills required if the district has provided to the Department of
31	Education a signed certificate concerning the use of the debt service savings
32	in conformity with § 6-20-2404;
33	(B) If a voted refunding issue is combined with
34	additional debt or extends the term of the original debt, the new payment
35	schedule will be used for the purpose of calculating eligible debt service
36	mills required; and

1	(C) A payment that a school district makes to a third
2	party for the eventual purpose of retiring indebtedness is deposited into an
3	escrow account pending payment to bond holders and is included as a scheduled
4	debt payment if the school district is unable to recover the deposited funds;
5	(10) "School district assessment per student" means the total
6	assessed valuation of property within a school district divided by the school
7	district's average daily membership;
8	(11) "State assessment per student" means the total assessed
9	valuation of property within the state divided by the statewide average daily
10	membership;
11	(12) "State wealth index" means the result of one (1) minus
12	the ratio of local revenue for a school year divided by the amount of state
13	funds allocated to the school district from the Public School Fund for
14	unrestricted general support of the school district;
15	(13) "Statewide average daily membership" means the total
16	number of days attended plus the total number of days absent by all students
17	in grades kindergarten through twelve (K-12) in all school districts during
18	the first three (3) quarters of each school year divided by the total state
19	average daily membership and rounded up to the nearest hundredth. Students
20	who may be counted for average daily membership are:
21	(A) Students who reside in Arkansas and who are
22	enrolled in a public school operated by a school district or a private school
23	for special education students, with their attendance resulting from a
24	written tuition agreement approved by the Department of Education; and
25	(B) Students who reside in Arkansas and who are
26	enrolled in the Arkansas National Guard Youth Challenge Program, so long as
27	the students are participants in the program;
28	(14) "Supplemental millage incentive funding" means state
29	funding paid to school districts who levy ad valorem taxes in excess of the
30	twenty-five (25) mills required by Arkansas Constitution, Amendment 74; and
31	(15) "Supplemental millage incentive funding base" means the
32	state assessment per student less the school district assessment per student
33	multiplied by one one-thousandth (.001).
34	
35	6-20-2404. Debt service funding supplement.
36	(a)(1) Beginning with school year 2004-2005, the state shall provide

1	to qualified school districts from available line item funds a debt service
2	funding supplement for the purpose of reducing bonded indebtedness if the
3	qualified school district elects to receive the funds in accordance with § 6-
4	<del>20-2407.</del>
5	(2)(A) A school district's debt service funding supplement is
6	calculated by multiplying the district's eligible debt service millage
7	required times an amount established annually by the State Board of
8	Education, but no less than twelve dollars (\$12.00) per average daily
9	membership times the state wealth index.
10	(B) The debt service funding supplement shall be
11	distributed quarterly.
12	(b) A school district qualifying for a debt service funding
13	supplement under this section shall not lose any debt service funding
14	supplements as a result of debt service savings produced by refunding
15	outstanding bonds if:
16	(1) The yearly savings produced by the refunding is deposited
17	into a refunding savings building fund and is used by the district for the
18	building and equipping of school buildings, for major adaptations to a
19	facility, or for purchasing facility sites; and
20	(2) Before the date that the refunding bonds are sold at
21	public sale, the district submits a certificate to the Director of the
22	Department of Education certifying that the yearly debt service savings will
23	be used for the purposes described in this subsection.
24	(c) If the Department of Education determines that an overpayment has
25	been made to a local school district in any appropriation authorized by this
26	subchapter, the department shall withhold the overpayment from state funding
27	and shall transfer the amount withheld for the overpayment to the line item
28	appropriation from which the overpayment was initially made.
29	
30	6-20-2405. General facilities funding.
31	(a)(1) Beginning with school year 2004-2005, the state shall provide
32	from available line item funds general facilities funding to school districts
33	that elect to receive the funds in accordance with § 6-20-2407.
34	(2) A school district's general facilities funding for a
35	school year is calculated by multiplying the school district's average daily
36	membership for the previous school year by the state wealth index times a

1	rate established annually by the State Board of Education.
2	(3) General facilities funding payments shall be distributed
3	quarterly.
4	(b)(1) General facilities funding shall be used only for:
5	(A) The purchase of school buses, furniture,
6	equipment, and computer software; and
7	(B) The renovation or repair of existing facilities.
8	(2) Unused funds may be carried forward and shall be used
9	exclusively for the purposes stated in subdivision (b)(1) of this section.
10	
11	6-20-2406. Supplemental millage incentive funding.
12	(a) Beginning with school year 2004-2005, the state shall provide
13	from available line item funds supplemental state funds to qualified school
14	districts that increase total school district millage in excess of the
15	twenty-five (25) mills in accordance with Arkansas Constitution, Amendment
16	74, and that elect to receive the funds in lieu of funds available under §§
17	6-20-2404 and 6-20-2405.
18	(b) For each school year beginning with school year 2004-2005, the
19	Department of Education shall determine by July 31 immediately preceding the
20	school year:
21	(1) The total millage rate of ad valorem tax levied in each
22	school district as of December 31 immediately preceding the school year; and
23	(2) The number of mills, if any, by which the total millage
24	rate exceeds the twenty-five (25) mills required by Arkansas Constitution,
25	Amendment 74.
26	(c)(l) A school district's supplemental millage incentive funding
27	shall be equal to the result of multiplying the lesser of the number ten (10)
28	or the result of subdivision (b)(2) of this section by the school district's
29	supplemental millage incentive funding base multiplied by the school
30	district's average daily membership times a funding factor to be determined
31	by the department.
32	(2) The supplemental millage incentive funding base shall be
33	computed based upon property values as of December 31 immediately preceding
34	the school year and the average daily membership for the previous school
35	<del>year.</del>
36	(3) If a school district is eligible to receive supplemental

1	millage incentive funding and is also eligible to receive a debt service
2	funding supplement or general facilities funding, or both, then the school
3	district shall make its funding election in accordance with § 6-20-2407.
4	(4) A school district shall not receive supplemental millage
5	incentive funding along with a debt service funding supplement or general
6	facilities funding, or both.
7	(d) Supplemental millage incentive funding shall be distributed
8	quarterly.
9	
10	6-20-2407. Funding election.
11	(a) By July 31 immediately preceding the school year, a school
12	district that is eligible for supplemental millage incentive funding shall
13	provide the Department of Education with a written election indicating
14	whether for the school year the school district:
15	(1) Elects to receive only supplemental millage incentive
16	funding in lieu of a debt service funding supplement or general facilities
17	funding, or both; or
18	(2) Elects to receive a debt service funding supplement or
19	general facilities funding, or both, in lieu of supplemental millage
20	incentive funding.
21	(b) The election of a school district under this section shall be
22	effective for one (1) school year.
23	(c) The department shall provide necessary data to each school
24	district prior to July 15 to enable each school district to make its funding
25	election.
26	
27	SECTION 3. EMERGENCY CLAUSE. It is found and determined by the
28	General Assembly of the State of Arkansas that the Arkansas Supreme Court has
29	determined that current public school academic facilities in Arkansas are
30	inadequate and inequitable; that the General Assembly established the Joint
31	Committee on Educational Facilities to inventory the current condition of
32	public school academic facilities and recommend methods for bringing public
33	school academic facilities into conformity with the court's constitutional
34	expectations; that the programs established in this act are derived from
35	recommendations of the joint committee and are part of a comprehensive
36	program for overseeing the provision of constitutionally appropriate public

1	school academic facilities across the state; that this program must be
2	implemented immediately for the good of public school students in Arkansas.
3	Therefore, an emergency is declared to exist and this act being immediately
4	necessary for the preservation of the public peace, health, and safety,
5	Section 2 of this act shall be effective on July 1, 2005, and Section 1 of
6	this act shall become effective on:
7	(1) The date of its approval by the Governor;
8	(2) If the bill is neither approved nor vetoed by the Governor,
9	the expiration of the period of time during which the Governor may veto the
10	<u>bill; or</u>
11	(3) If the bill is vetoed by the Governor and the veto is
12	overridden, the date the last house overrides the veto.
