27	WHEREAS, the federal Satellite Home Viewer Improvement Act of 1999
28	permits satellite companies to provide local broadcast television signals to
29	subscribers residing in a designated market area; and
30	
31	WHEREAS, satellite companies that provide local television service are
32	required to provide their subscribers with all the local broadcast television
33	signals assigned to their designated market area as defined by Nielsen Media
34	Research; and
35	
36	WHEREAS, many Arkansans who reside in areas that border another state

1	are subscribers to satellite services that do not provide access to Arkansas
2	broadcasts because designated market areas do not conform to state boundary
3	lines; and
4	
5	WHEREAS, existing federal law prohibits satellite companies from
6	broadcasting local network channels from outside a subscriber's designated
7	market area; and
8	
9	WHEREAS, Arkansas subscribers in border areas that are assigned to
10	designated market areas that provide out-of-state local broadcasts would
11	benefit much more from Arkansas news and reports and programming concerning
12	Arkansas governmental and cultural activities and events,
13	
14	NOW THEREFORE,
15	BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE EIGHTY-FIFTH GENERAL
16	ASSEMBLY OF THE STATE OF ARKANSAS, THE SENATE CONCURRING THEREIN:
17	
18	That the House of Representatives of the Eighty-fifth General Assembly
19	of the State of Arkansas requests that all members of the Arkansas
20	congressional delegation support legislation that will enable all Arkansans
21	subscribing to a satellite service to have access to local broadcasts from
22	Arkansas television stations.

24	BE IT FURTHER RESOLVED that, after its adoption, copies of this
25	resolution shall be sent to the members of Arkansas' congressional delegation
26	by the Chief Clerk of the House of Representatives.
