3	BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE EIGHTY-FIFTH GENERAL
4	ASSEMBLY OF THE STATE OF ARKANSAS, THE SENATE CONCURRING THEREIN:
5	
6	(a) That the Regular Session of the Eighty-fifth General Assembly of
7	the State of Arkansas is extended until 12:00 noon, May 13, 2005;
8	(b) That the Regular Session of the Eighty-fifth General Assembly of
9	the State of Arkansas shall enter into recess simultaneously at the close of
10	business in each chamber on April 15, 2005, or at such earlier time as may be
11	agreed upon by the House of Representatives and the Senate;
12	(c) That the Speaker of the House of Representatives and the President
13	Pro Tempore of the Senate may, by joint proclamation:
14	(1) Reconvene the General Assembly at any time before 12:00
15	noon, May 13, 2005, for the purpose of:
16	(A) Considering vetoes;
17	(B) Correcting errors and oversights;
18	(C) Completing its work on proposed constitutional
19	amendments; and
20	(D) Considering the need for further extension of the
21	Regular Session of the Eighty-fifth General Assembly; or
22	(2) Adjourn the Regular Session of the Eighty-fifth General
23	Assembly at any time before that date if they determine it is not necessary
24	to reconvene; and
25	(d) That if the General Assembly is not reconvened or adjourned before
26	12:00 noon, May 13, 2005, the Regular Session of the Eighty-fifth General
27	Assembly is adjourned sine die on that date.
