8 **HOUSE CONCURRENT RESOLUTION**  
9 TO CONDEMN THE USE OF RACIAL EPITHETS AT SCHOOL  
10 SPORTING EVENTS.

12 **Subtitle**  
13 TO CONDEMN THE USE OF RACIAL EPITHETS AT  
14 SCHOOL SPORTING EVENTS.

16

17 WHEREAS, school activity programs are vital in teaching young people  
18 lifelong lessons; and  
19

20 WHEREAS, the purpose of interscholastic sports activities should be to  
21 promote citizenship and sportsmanship, instill a sense of pride in the  
22 community, teach teamwork and self-discipline, and facilitate the physical  
23 and emotional development of our youth; and  
24

25 WHEREAS, competitive sports tend to create natural rivalries among  
26 teams, and such rivalries should be used to cultivate healthy emotional  
27 development and respect for the abilities and diversity of everyone; and  
28

29 WHEREAS, to allow or ignore the use of racial epithets before, during,  
30 or after interscholastic sports activities would be a failed opportunity and  
31 counterproductive to the Arkansas Activities Association's mission of  
32 "Building Citizenship Through Activities Participation"; and

34 WHEREAS, the Arkansas Activities Association's rules require  
35 superintendents and principals of schools to be responsible for providing  
36 leadership by implementation of good sportsmanship policies in each school



1 for not only the students and coaches but also for fans; and

2  
3 WHEREAS, the Arkansas Activities Association requires each school to  
4 have policies requiring good sportsmanship and to be prepared to expel any  
5 person who engages in unsportsmanlike conduct. The Arkansas Activities  
6 Association details specific sanctions for not complying with good  
7 sportsmanship policies,

9 NOW THEREFORE,

10 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE EIGHTY-FIFTH GENERAL  
11 ASSEMBLY OF THE STATE OF ARKANSAS, THE SENATE CONCURRING THEREIN:

12  
13 THAT the Eighty-Fifth General Assembly of the State of Arkansas  
14 encourages administrators, coaches, participants, and fans to report to the  
15 school district and the Arkansas Activities Association any use of racial  
16 epithets during school sporting events.

17  
18 THAT for participants, coaches, administrators, or fans of either the  
19 offending team or the offended team to ignore such conduct is not conducive  
20 to teaching our youth the importance of respect for the abilities and  
21 diversity of everyone.

23 BE IT FURTHER RESOLVED THAT upon adoption of this resolution, the Clerk  
24 of the House of Representatives shall mail a copy of this resolution to the  
25 following organizations, and the General Assembly hereby requests that each  
26 organization provide a copy of this resolution to each of its members:
