36	SECTION 1. (a) The General Assembly has the sole power and

1	responsibility to determine the adequacy, suitability, and efficiency of the
2	public schools of the State of Arkansas.
3	(b) The Judicial Department of this state has no jurisdiction to
4	entertain or grant relief for claims arising under the Constitution of the
5	State of Arkansas, the United States Constitution, or the laws of the United
6	$\underline{\text{States}}$ concerning acts of the General Assembly that appropriate public funds
7	for public school purposes.
