20	WHEREAS, Mr. E.J. Ball of Fayetteville, Arkansas, died on Tuesday,
21	January 27, 2004, at the age of eighty-seven (87) years; and
22 23	WHEREAS, Mr. Ball was born on January 21, 1917, in Monette, Arkansas,
23 24	to Benjamin Franklin and Vera Lamb Ball; and
24	to benjamin Frankiin and Vera Lamb Dail, and
26	WHEREAS, Mr. Ball entered the United States Navy and became a Naval
27	aviator in 1943, serving at the Naval Air Station in Tillamook, Oregon, and
28	at the Naval Station in Great Lakes, Illinois, and retired from the Navy as a
29	lieutenant junior grade; and
30	
31	WHEREAS, Mr. Ball attended the University of Arkansas at Fayetteville,
32	where he received a Bachelor's Degree in Accounting in 1949, an L.L.B. with
33	honors in 1950, and an M.B.A. in Business Administration in 1953; was active
34	in many academic honor societies, including Beta Gamma Sigma, Omicron Delta
35	Kappa, Phi Alpha Delta, and the Blue Key honorary men's leadership
36	fraternity; and was editor of the Law Review from 1950-1951; and

1 2 WHEREAS, Mr. Ball served as an assistant professor at the University of 3 Arkansas College of Business Administration and the School of Law for twenty-4 five (25) years; and 5 6 WHEREAS, Mr. Ball began his private law practice in Fayetteville, 7 Arkansas in 1950, where he practiced with law partner Ken Mourton for thirty-8 four (34) years, growing the law firm into one of the oldest and most 9 recognized in Northwest Arkansas; and 10 11 WHEREAS, Mr. Ball was the first counsel for the University of Arkansas 12 Men's Athletics Department; was best known for his representation of clients charged with federal tax crimes; was an early specialist on federal criminal 13 14 tax violations and went years before ever losing a case to the federal 15 government; and helped pioneer the law of variable annuities, like-kind 16 exchanges, estate planning, and charitable foundations; and 17 WHEREAS, Mr. Ball's contributions to the law were recognized by his 18 19 appointment as a Special Justice to the Arkansas Supreme Court, being named one of the Best Lawyers in America by Woodward/White, Inc. of New York, and 20 21 being chosen as Outstanding Lawyer in Arkansas; and 22 23 WHEREAS, Mr. Ball was involved in more than one hundred twenty-five 24 (125) reported appellate cases during his career; and 25 26 WHEREAS, Mr. Ball served as Chairman of the Fayetteville Chamber of 27 Commerce; was a longtime director of McIlroy Bank; served on the board of the 28 University of Arkansas Alumni Association; was on the Arkansas Western Gas 29 Company Board of Directors for twenty-one (21) years; created the nation's 30 first commercial variable annuity life insurance company with the late Harold 31 Dulan and Lewis Callison, where Mr. Ball served as corporate director, 32 secretary-treasurer, and general counsel; founded the Razorback Foundation, 33 which honored him with a distinguished service award in 1992; was a founding 34 member of the University of Arkansas National Development Council; founded 35 the Law School Foundation; created the Wylie H. David Professorship and the 36 Ethel Harper Phillips Scholarship Fund; and was founding Chairman of the

1 Chancellor's Society; and 2 WHEREAS, Mr. Ball and his wife, Gladys, have generously supported the 3 4 University of Arkansas Law School, including the Robert A. Leflar 5 Professorship and the E.J. Ball Professorship; were major contributors to the 6 J. William Fulbright Peace Fountain; and, in 2002, the Balls were inducted as 7 Towers of Old Main; and 8 9 WHEREAS, Mr. Ball was the honored recipient at the Arkansas Law Review 10 50th Anniversary in 1997; received the Alumni Citation of Merit; received a 11 gift in his name from the Razorback Foundation of a teaching lab in the 12 university library bearing his name; and, in 2003, the School of Law hosted a reception and dinner to recognize his lifelong leadership and contributions 13 14 to the University of Arkansas; and 15 16 WHEREAS, Mr. Ball was preceded in death by his parents, Benjamin 17 Franklin and Vera Lamb Ball; and 18 19 WHEREAS, Mr. Ball is survived by his wife of fifty-eight (58) years, Gladys; son and daughter-in-law, Kenneth Ben and Betsy Ball; daughter and 20 21 son-in-law, Kathy L. Ball and Barry D. Herzog; daughter and son-in-law, Karen 22 L. Ball and W. Tate Wolf; and three grandchildren, Benjamin Slade Adams, 23 Amanda Britt Adams, and Benjamin Henry Ball; and 24 25 WHEREAS, the House of Representatives of the Eighty-fifth General 26 Assembly wishes to publicly recognize Mr. Ball's many contributions to the 27 State of Arkansas and his local community, 28 29 NOW THEREFORE, 30 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE EIGHTY-FIFTH GENERAL 31 ASSEMBLY OF THE STATE OF ARKANSAS: 32 33 THAT the House of Representatives recognizes E.J. Ball's commitment, 34 hard work, dedication, and years of service to the State of Arkansas and his 35 local community and commends him for his leadership.
