(ii) Additionally, the commission shall have no jurisdiction over claims against the state for repayment of child support, except in cases where the underlying support order is set aside as void ab initio by the court and the child support paid was retained by the state as reimbursement for public assistance paid on behalf of a child. (iii) The commission shall have no jurisdiction over: (a) A claim by a member of the uniformed armed services against the department, the militia, or any subdivision thereof, if the claim arises out of the performance of the claimant's military duty; (b) Claims against the Department of Community Correction for acts committed by a person while that person is subject to conditions of parole or probation under Arkansas law; or (c) Claims against the Department of Correction for acts committed by inmates while on authorized release from the Department of Correction-; or (d) Claims against the Department of Human Services or its employees for any act committed by a minor, licensed to drive under § 27-16-702(a)(1)(D), in the custody of the department while operating a motor vehicle.
