21 SECTION 23. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
22 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. BUFFALO
23 GNAT CONTROL PROGRAM. The Appropriation authorized for the Buffalo Gnat
24 Control Program in Item (05) of Section 3 of this Act, shall be expended only
25 for the control of buffalo gnats in the Arkansas counties of Miller,
26 LaFayette, Little River and parts of Hempstead.

27 The provisions of this section shall be in effect only from July 1, ~~2003~~

30 SECTION 24. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
31 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXPENSE
32 REIMBURSEMENT. Funds appropriated in Item (07), (08) and (09) of Section 19
33 of this act shall be used to reimburse members of high school 4H clubs, high
34 school FFA clubs and Miss Arkansas Rodeo for expenses incurred while
35 representing the State of Arkansas at national conferences and events outside
36 the State. The State 4H Association and the State FFA Association shall

1 receive funds appropriated for expense reimbursement of student members but
2 shall be limited to \$20,000 each, or so much thereof that is available.
3 Reimbursement of expenses for Miss Arkansas Rodeo shall be limited to \$350
4 per year.

10 FORWARD. Any unexpended balance of appropriation provided in the Brucellosis

19 TRANSFER. The Executive Director of the Livestock and Poultry Commission,
20 with prior review of the Arkansas Legislative Council or the Joint Budget
21 Committee, the approval of the Chief Fiscal Officer of the State, and for the
22 reimbursing of documented expenditures designated by law to be made from the
23 transferred special revenue, may transfer funds among the Livestock and
24 Poultry Equine Infectious Anemia Control Fund, Livestock and Poultry
25 Commission Disease and Pest Control Fund, Livestock and Poultry Special
26 Revenue Fund, Livestock and Poultry Commission Swine Testing Fund, and the
27 Poultry and Egg Grading Fund or from these funds to the Livestock and Poultry
28 Fund Account. The purpose of these transfers shall only be for accurate
29 allocation of incurred costs between the funds. Requests for fund transfer
30 will at least include the total amount to be transferred, to and from which
31 funds, the nature, purpose, and time period of the expenditures being
32 reimbursed, and any other information requested by the Legislative Council or
33 the Joint Budget Committee.

1 SECTION 27. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
2 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUND
3 BALANCES - LIVESTOCK AND POULTRY COMMISSION DISEASE AND PEST CONTROL FUND.

4 (A) For all appropriations as provided in this Act, the agency disbursing
5 officer shall monitor the level of fund balances in relation to expenditures
6 on a monthly basis. If any proposed expenditures would cause the Livestock
7 and Poultry Commission Disease and Pest Control Fund to decline below four
8 hundred fifty thousand dollars (\$450,000) ~~two hundred forty three thousand~~
9 ~~ninety six dollars (\$243,096)~~, the disbursing officer shall immediately
10 notify the executive head of the agency. Prior to any obligations being made
11 under these circumstances, the agency head shall file written documentation
12 with the Chief Fiscal Officer of the State requesting approval of the
13 expenditures. Such documentation shall provide sufficient financial data to
14 justify the expenditures and shall include the following:

- 15 1) a plan that clearly indicates the specific fiscal impact of such
16 expenditures on the fund balance.
- 17 2) information clearly indicating and explaining what programs would be cut
18 or any other measures to be taken by the agency to restore the fund balance.
- 19 3) the extent to which any of the planned expenditures are for one-time costs
20 or one-time purchase of capitalized items.
- 21 4) a statement certifying that the expenditure of fund balances will not
22 jeopardize the financial health of the agency, nor result in a permanent
23 depletion of the fund balance.

24 (B) The Chief Fiscal Officer of the State shall review the request and
25 approve or disapprove all or any part of the request, after having sought
26 prior review by the Legislative Council.

27 The provisions of this section shall be in effect only from July 1, 2003
28 2005 through June 30, ~~2005~~ 2007.

29
30 SECTION 28. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
31 by this act shall be limited to the appropriation for such agency and funds
32 made available by law for the support of such appropriations; and the
33 restrictions of the State Procurement Law, the General Accounting and
34 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
35 Procedures and Restrictions Act, or their successors, and other fiscal
36 control laws of this State, where applicable, and regulations promulgated by

1 the Department of Finance and Administration, as authorized by law, shall be
2 strictly complied with in disbursement of said funds.

3
4 SECTION 29. LEGISLATIVE INTENT. It is the intent of the General Assembly
5 that any funds disbursed under the authority of the appropriations contained
6 in this act shall be in compliance with the stated reasons for which this act
7 was adopted, as evidenced by the Agency Requests, Executive Recommendations
8 and Legislative Recommendations contained in the budget manuals prepared by
9 the Department of Finance and Administration, letters, or summarized oral
10 testimony in the official minutes of the Arkansas Legislative Council or
11 Joint Budget Committee which relate to its passage and adoption.

12
13 SECTION 30. EMERGENCY CLAUSE. It is found and determined by the General
14 Assembly, that the Constitution of the State of Arkansas prohibits the
15 appropriation of funds for more than a two (2) year period; that the
16 effectiveness of this Act on July 1, 2005 is essential to the operation of
17 the agency for which the appropriations in this Act are provided, and that in
18 the event of an extension of the Regular Session, the delay in the effective
19 date of this Act beyond July 1, 2005 could work irreparable harm upon the
20 proper administration and provision of essential governmental programs.
21 Therefore, an emergency is hereby declared to exist and this Act being
22 necessary for the immediate preservation of the public peace, health and
23 safety shall be in full force and effect from and after July 1, 2005.
