21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23 SECTION 1. Arkansas Code § 3-5-701 is amended to read as follows:
24 3-5-701. Creation – Members.

25 (a)(1) There is created the Arkansas Wine Producers Council to be
26 composed of ~~seven (7)~~ ten (10) members.

27 (2) Four (4) members of the council shall be appointed by the
28 Governor and confirmed by the Senate from a list of two (2) names submitted
29 by the Arkansas Wine Producers Association for each of the four (4) positions
30 to be filled.

31 (3) ~~One (1) member shall be appointed by the Governor and~~
32 ~~confirmed by the Senate from a list of two (2) names submitted by the~~
33 ~~Arkansas State Horticulture Society.~~ Four (4) members of the council shall
34 be appointed by the Governor and confirmed by the Senate from a list of two
35 (2) names submitted by the Arkansas Association of Grape Growers for each of
36 the four (4) positions to be filled.



1 (4) One (1) member of the council shall be designated by the
2 Board of Trustees of the University of Arkansas and shall be a faculty member
3 or administrator who is knowledgeable in viniculture.

4 (5) One (1) member shall be designated by the State Parks,
5 Recreation, and Travel Commission, and the member shall be either a member or
6 employee of the commission.

7 (b) All successor members shall be appointed or designated for terms
8 of three (3) years.
