22	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE	OF ARKANSAS:

24	SECTION 1. Arkansas Code Title 6, Chapter 1	7, Subchapter ll is amended
25	to add an additional section to read as follows:	
26	6-17-1119. Authority to purchase health ins	urance for employees.
27	(a) Notwithstanding any provision of §§ 21-	5-401 through 21-5-417 to
28	the contrary, an Arkansas school district is autho	rized to solicit proposals
29	from any health insurer or health maintenance orga	nization to provide school
30	district employees and dependents of the employees with health insurance	
31	coverage or with health care benefits that are ind	ependent of the group
32	coverage offered by the State and Public School Life and Health Insurance	
33	Board.	
34	(b) If a school district enters into an agr	eement with a health
35	insurer or health maintenance organization, the school district is entitled	
36	to receive payments from the state for its employees and dependents of the	

	employees in an equivalent amount provided to other similar school districts	
2	as an offset to the cost of the premiums to the health insurer or health	
3	maintenance organization.	
4	(c) The school districts shall pay an amount no less than the health	
5	insurance contribution rate under § 6-17-1117 for each eligible employee	
6	electing to participate with the school district's health insurer or health	
7	maintenance organization under this section as if the employee was	
8	participating in the public school employee health insurance program.

10	SECTION 2. Arkansas Code § 21-5-406(e), concerning the State and	
11	Public School Life and Health Insurance program, is amended to read as	
12	follows:	
13	(e) The Arkansas State Police Employee Health Plan and any public	
14	school district purchasing health insurance for its employees under § 6-17-	
15	$\underline{1119}$ shall be exempt from any mandatory participation required by this	
16	section.
