3	regulations adopted by the Board of Trustees of the Arkansas Teacher

12	SECTION 2. EMERGENCY CLAUSE. It is found and determined by the		
13	General Assembly of the State of Arkansas that the Arkansas Teacher		
14	Retirement System has no mechanism to recoup overpayment in certain		
15	circumstances; that the absence of the ability leads to the potential loss of		
16	funds from the system; and that the most effective time to make changes to		
17	the retirement system is at the beginning of the state's fiscal year.		
18	Therefore, an emergency is declared to exist and this act being immediately		
19	necessary for the preservation of the public peace, health, and safety shall		
20	become effective on July 1, 2005.
