28	(a) As used in the	nis section, "Armed Forces Rese	erve" means one of the	
29	reserve components of the	ne United States Armed Forces.		
30	(b)(1) A member of	of the Arkansas Public Employee	es' Retirement System	
31	may purchase credited service in the system for a period not to exceed one			
32	(1) year for compensated service rendered by the member in the Arkansas			
33	National Guard or in the Armed Forces Reserve if the member:			
34	<u>(A) N</u>	<u> Makes an application to the Boa</u>	ard of Trustees of the	
35	Arkansas Public Employee	es' Retirement System;		
36	<u>(B) I</u>	Provides the board with satisfa	actory proof of that	

1	person's service in the Arkansas National Guard or Armed Forces Reserve; and		
2	(C)(i) For the year of service credit granted, pays to th		
3	system the employee and employer contributions based on the greater of:		
4	(a) The annual salary received by the member		
5	for the member's first full year of credited service that precedes the fiscal		
6	year in which the service is purchased; or		
7	(b) The average of the three (3) highest		
8	annual salaries earned at the time of purchase.		
9	(ii) The member must pay interest from the end of		
10	that year of credited service to the date of payment in full.		
11	(2) Payment for service under this section is to be based on the		
12	contribution rates in effect at the time of the purchase.		
13	(3) The payment is to be credited to the members' deposit		
14	account and is in addition to any regular member contributions.		
15	(c) A member shall receive one (1) year of purchased service credit		
16	for every five (5) years of compensated service in the Arkansas National		
17	Guard or in the Armed Forces Reserve.		
18	(d) The Arkansas National Guard or Armed Forces Reserve service shall		
19	not become credited service under this system until:		
20	(1) The member pays for all the Arkansas National Guard or Armed		
21	Forces Reserve service, or a portion of the service in one (1) year		
22	increments, at one (1) time in a single lump-sum payment; and		
23	(2) The member has established five (5) or more years of actual		
24	service in the system.		
25	(e) If a member ceases to be an active member before the Arkansas		
26	National Guard or Armed Forces Reserve service has been established as		
27	system-credited service, the member payments contributed under this section		
28	are refundable, together with regular interest.		
29	(f)(1) This section is supplemental to $\$24-2-502$ , and nothing in this		
30	section shall diminish the right of any member of the system to obtain		
31	credited service in the system for active duty military service within the		
32	limits permitted by § 24-2-502.		
33	(2) However, no member is entitled to receive more than one (1)		
34	year of credited service rendered by the member under this section.		
35	(3) No member is eligible to purchase service credit in more		
36	than one (1) state-supported retirement system for service time in the		

1	Arkansas National Guard or in the Armed Forces Reserve.	
2	(4) Service credit in the system for active duty military	
3	service under § 24-2-502 and for service in the Arkansas National Guard or	
4	Armed Forces Reserve shall not be given for the same period of time.	
5	(5) The service is not credited as service under any other	
6	retirement system, including federal systems, except social security.
