8 SECTION 8. LEGISLATIVE INTENT. It is the intent of the General Assembly 9 that any funds disbursed under the authority of the appropriations contained 10 in this act shall be in compliance with the stated reasons for which this act 11 was adopted, as evidenced by the Agency Requests, Executive Recommendations 12 and Legislative Recommendations contained in the budget manuals prepared by 13 the Department of Finance and Administration, letters, or summarized oral 14 testimony in the official minutes of the Arkansas Legislative Council or 15 Joint Budget Committee which relate to its passage and adoption.

17 SECTION 9. EMERGENCY CLAUSE.
